You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

SUNDAY, 2300 HOURS, R/O AND OFFICER PTAK #32 RESPONDED TO IN REPORT OF A
DOMESTIC BATTERY. UPON ARRIVAL R/O SPOKE WITH THE VICTIM, JUDITH BENITEZ, F/H
BENSENVILLE IL WHO RELATED AT THE ABOVE DATE AND TIME, SHE BECAME
INVOLVED IN A VERBAL ALTERCATION WITH HER LIVE IN BOYFRIEND TORALVA, JAVIER M/H
