Report Narrative: ON 01/03/2016 AT APPROXIMATELY 1115 HRS BENSENVILLE POLICE UNITS WERE DISPATCHED TO 1041 WAVELAND AVENUE FOR A POSSIBLE BURGLARY. UPON ARRIVAL BENSENVILLE POLICE UNITS OBSERVED THE FRONT DOOR WINDOW WAS SHATTERED AND THE OWNER, IDENTIFIED AS QUERCIA, ANGELO M/W [REDACTED], WAS STANDING IN FRONT. FURTHER INVESTIGATION REVEALED A BURGLARY HAD NOT OCCURRED (NO ENTRY MADE - OR ATTEMPT / R/O'S DID A WALK THROUGH) AND THE FRONT DOOR OF THE BUSINESS HAD BEEN POSSIBLY DAMAGED BY A PELLET FROM A PELLET GUN.

R/O SPOKE TO QUERCIA WHO STATED THE FOLLOWING IN SUMMARY:

QUERCIA STATED HE LEFT HIS BUSINESS ON 01/02/2016 AT APPROXIMATELY 2100 HRS (FRONT DOOR WAS NOT DAMAGED). QUERCIA STATED ON 01/03/2016 AT APPROXIMATELY 1115 HRS HE RETURNED TO HIS BUSINESS AND OBSERVED THE FRONT DOOR WAS SHATTERED. QUERCIA STATED HE FIRED AN EMPLOYEE (IDENTIFIED AS FIORE, JOSEPH M M/W [REDACTED]) APPROXIMATELY TWO WEEKS AGO FOR BEING UNDER THE INFLUENCE OF DRUGS. QUERCIA STATED HE OBSERVED FIORE USING WHAT HE SUSPECTED TO BE COCAINE AT HIS BUSINESS. QUERCIA STATED FIORE WAS HOSTILE WHEN HE WAS FIRED.

R/O, OFFICER MELONE #521, AND OFFICER REYNOLDS #534 WENT TO FIORE'S RESIDENCE ([REDACTED]) BENSENVILLE, IL 60106) TO SPEAK TO FIORE.

UPON ARRIVAL AT FIORE'S RESIDENCE R/O SPOKE TO FIORE'S MOTHER AND ADVISED HER R/O NEEDED TO SPEAK TO FIORE IN REFERENCE TO A DAMAGE TO PROPERTY THAT OCCURRED AT QUERCIA'S BUSINESS. WHEN SPEAKING TO HER SEVERAL OF FIORE'S FAMILY MEMBERS RETURNED. FIORE'S FAMILY MEMBERS CLAIMED FIORE WAS WITH THEM DURING THE DURATION OF THE TIME THE CRIME HAD OCCURRED. BENSENVILLE POLICE UNITS WERE UNABLE TO TALK TO FIORE WITHOUT BEING INTERRUPTED. FURTHERMORE, FIORE'S FATHER WAS HOSTILE TOWARD POLICE AND PREVENTED R/O FROM CONDUCTING A PROPER INVESTIGATION.

OFFICER REYNOLDS #534 ADVISED R/O THAT WHEN HE WAS ATTEMPTING TO QUESTION FIORE HE WAS DEFENSIVE AND WOULD NOT MAKE EYE CONTACT.

BECAUSE FIORE'S FAMILY WAS UNCOOPERATIVE AND CONSTANTLY INTERRUPTING BENSENVILLE POLICE UNITS LEFT FIORE'S RESIDENCE.

R/O SUBMITTED A PICTURE OF THE DAMAGED FRONT DOOR INTO EVIDENCE.

NOTHING FURTHER AT THIS TIME.
