- 2) Village of Bensenville Non Crime/Other Report No. BV16000216.1. (2 pgs.)


These are all of the documents that can be discovered responsive to your request.

COOK COUNTY DISPOSITION DOCUMENT FOR CASE 13D5511 AFFORDS CARL A PHONE CALL TO HIS DAUGHTER FROM 1830 HRS TO 1835 HRS ON MONDAY, WEDNESDAY, AND FRIDAY OF EACH WEEK. ON 010816 AT APPROXIMATELY 0800 HRS CARL RECEIVED A TEXT MESSAGE FROM EX WIFE KATHRYN D MITCHELL-MUELLER FW [REDACTED] STATING THEIR DAUGHTER WOULD NOT BE AVAILABLE TO TALK THIS EVENING AND THAT THE CALL COULD BE MADE UP ON SATURDAY 010916 AT 1830 HRS. CARL STATED HE WOULD CONSULT WITH THE ATTORNEY AND THAT HE WOULD NOT PHONE HIS DAUGHTER ON SATURDAY OUT OF FEAR OF BREAKING THE COURT ORDER.

RO SPOKE WITH KATHRYN VIA TX WHO AGAIN STATED THEIR DAUGHTER WOULD BE UNAVAILABLE FOR FRIDAY'S SCHEDULED CALL AND REMINDED RO SHE OFFERED FOR CARL TO MAKE IT UP. KATHRYN EXPLAINED SHE ALREADY SPOKE WITH ATTORNEY WHO ADVISED KATHRYN TO MAKE THE ARRANGEMENT BECAUSE "LIFE HAPPENS."

CARL WAS FURNISHED WITH THIS REPORT NUMBER AND STATED HE WOULD MAKE MENTION OF IT AT THEIR NEXT COURT DATE ON 012216.
