- 1) Village of Bensenville New Business Licenses Issued from 10/1/15 – 12/31/15. (1 pg.)


These are all of the documents that can be discovered responsive to your request.

You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.
