- 1) Village of Bensenville Non Crime/Other Report No. BV15008788.1. (3 pgs.)


These are all of the documents that can be discovered responsive to your request.

Report Narrative

AT APPROXIMATELY 2034 HOURS ON 08/17/15 R/O WAS DISPATCHED TO [REDACTED] FOR A REPORT OF DOMESTIC TROUBLE.

R/O ARRIVED ON SCENE AND OBSERVED A M/W SITTING IN IL REG [REDACTED]. THE M/W EXITED THE VEHICLE AND IDENTIFIED HIMSELF AS FEDOR, MICHAEL A M/W [REDACTED] AND STATED THE VEHICLE BELONGED TO HIS MOTHER. FEDOR STATED THAT CAREY, ELIZABETH A F/W [REDACTED] HIS EX-GIRLFRIEND TOLD HIM TO COME OVER TO DROP HER CLOTHES OFF. FEDOR STATED THAT HE GAVE CAREY HER CLOTHES BUT CAREY'S FRIEND, CIFONE, MICHAEL J M/W [REDACTED] CAME OUT CALLING HIM NAMES AND TOLD HIM TO LEAVE. FEDOR STATED THAT HE DID NOT LEAVE BECAUSE CIFONE SAID HE WAS GOING TO CALL THE POLICE SO FEDOR WANTED TO EXPLAIN TO THE POLICE WHAT WAS GOING ON.

OFC GUEST #511 SPOKE WITH CAREY WHO STATED THAT SHE DATED FEDOR FOR 4 MONTHS AND WAS LIVING WITH HIM BUT SHE WAS RECENTLY ARRESTED BECAUSE FEDOR HURT HIMSELF AND CALLED THE POLICE WHEN SHE TRIED TO MOVE OUT. CAREY STATED THAT SHE DID NOT TELL FEDOR TO BRING THE CLOTHES, BUT WHEN HE SHOWED UP SHE WENT TO GET THE CLOTHES AND RETURNED INTO THE HOME.

CIFONE STATED THAT HE WENT OUTSIDE AND TOLD FEDOR TO LEAVE HIS PROPERTY PRIOR TO POLICE ARRIVAL AND FEDOR REFUSED TO LEAVE.

FEDOR STARTED WALKING TOWARD THE CAR TO LEAVE AND HE STATED "I'M GOING TO KILL MYSELF"; AT WHICH TIME R/O, OFC GUEST #511 AND OFC DRISCOLL #518 TOLD FEDOR TO EXIT THE VEHICLE.

BENSENVILLE FIRE PROTECTION DISTRICT PARAMEDICS #17 RESPONDED AND TRANSPORTED FEDOR TO ELMHURST MEMORIAL HOSPITAL FOR A PSYCHOLOGICAL EVALUATION BECAUSE OF THE SUICIDAL STATEMENT THAT HE MADE.

OFC GUEST ARRANGED FOR IL REG [REDACTED] TO BE TAKEN AND PARKED IN THE BENSENVILLE POLICE DEPARTMENT LOT. THE KEYS TO THE VEHICLE WERE LEFT IN THE LOBBY OF THE POLICE DEPARTMENT.
