Report Narrative **On 01/25/2009 at approximately 0445 hours R/O was dispatched to [REDACTED] for a report of a domestic battery.**

**R/O arrived on scene and spoke to a female subject later identified as Julia G. Lopez M/H [REDACTED]. Lopez stated that she was at a night club with Rogelio A Valdez M/H [REDACTED] and Juan F. Quiroz M/H [REDACTED]. Lopez stated that when they arrived at [REDACTED] Valdez got angry at her for dancing with Quiroz at the club. Lopez stated that Valdez punched her in the mouth with a closed fist causing Lopez's lip to bleed. Lopez stated that Valdez had warrants for his arrest and left the scene in a white Cadillac. Lopez stated that Valdez was her boyfriend.**

**R/O spoke to Quiroz who stated that Valdez got jealous because Lopez danced with Quiroz. Quiroz stated that Valdez took his vehicle without permission but did not want to sign complaints. Quiroz stated that he did not witness Valdez punch Lopez.**

**Lopez stated that Valdez was probably going to Lopez's residence, [REDACTED] A/O Mandziara #512 arrived on scene and located the white Cadillac, Illinois registration [REDACTED]. Valdez was nowhere to be found.**

**R/O took a picture of Lopez's injury and submitted it into evidence. R/O also observed a bump on the back of Lopez's head. Lopez stated that she was also punched in the back of the head with a closed fist. Lopez refused medical attention.**

**On 01/27/2009 at approximately 0400 hours R/O contacted Victim's Advocacy and spoke to Anne. R/O advised Anne of the incident.**

**The R/O has nothing further at this time.**
