Report Narrative

On 12/29/2015 at approximately 1533 hours, R/O was dispatched to the Bensenville Police Department lobby for the report of a damage to vehicle.

Upon arrival, R/O spoke with Konieczna, Katarzyna F/W [REDACTED] who related that on 12/27/2015 she was driving on Irving Park Rd near the intersection with Church Road in her silver Honda Pilot bearing IL Reg [REDACTED]. It was dark out and she changed lanes and did not see someone was behind her. The vehicle behind her stopped. The driver is described as a male white 20-30 years old, approximately 6 feet tall with a bald head, possible blond hair. The m/w got out of the blue 2014 Mazda bearing IL Reg [REDACTED], came up to her window and began yelling at her. The m/w hit the driver's side mirror with his fist and caused some interior plastic to break but the mirror is functional. The m/w then left the scene. Konieczna did not immediately report the incident and decided to report it on 12/29/2015 because her husband found out the mirror would cost \$300.00 to replace.

The vehicle is registered to Szejda, Karol [REDACTED] but R/O is unable to locate a phone number. Konieczna does not want the subject arrested but would like the damage paid for.
