You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **On 01/27/16 at approximately 1600 hrs, I, Officer Driscoll #518 and Officer Linkowski #520, were dispatched to [REDACTED] where a 6 year old boy stuck another 6 year old child with his epi-pen while on the bus. The sticking of the epi-pen occurred at approximately 1550 hrs.**

**Upon arrival Bensenville Fire Department, RUN# 290, was already on scene speaking with the child who was stuck, Juv #1 (F.N.) who was escorted to the ambulance, able to walk on his own free will, to be transported to the Elmhurst Hospital.**

**I spoke with Juv #2(L.K.) and his mother, Caneisha T Weakliss f/b [REDACTED] L.K. confirmed that he stuck F.N. with the epi-pen but was unable to clearly articulate any additional information.**

**I spoke with the father of F.N. and advised them that his son was being transported to Elmhurst Memorial Hospital as a precaution.**

**Juilann M Greene f/w school district liason was on scene and spoke with both parents in regards to finding a better solution.**
