- 1) Village of Bensenville Crime Report No. BV16000909.1. (3 pgs.)


These are all of the documents that can be discovered responsive to your request.

Report Narrative **AT 0046 HOURS, 1/30/16, RO WAS SUMMONED TO THE BENSENVILLE POLICE DEPARTMENT FOR A DESK REPORT OF A MOTOR VEHICLE THEFT/ CONTAINER THEFT. RO ARRIVED AND SPOKE TO THE OWNER OF THE VEHICLE, NEMANJA JANJIC M/W [REDACTED], WHO STATED THE FOLLOWING.**

**AT APPROXIMATELY 0000 HOURS, 1/30/16, NEMANJA RETURNED TO THE PARKING LOT AT 143 BEELINE DR AND PARKED HIS TRACTOR IN A DESIGNATED SPOT AND NOTICED THAT ANOTHER ONE OF HIS TRACTORS WITH ATTACHED TRAILER WAS MISSING. NEMANJA CALLED HIS EMPLOYEE, DEJAN DULEJIC M/W [REDACTED], WHO WAS THE LAST DRIVER TO USE THE TRACTOR/TRAILER EARLIER IN THE DAY TO CONFIRM WHETHER THE VEHICLE WAS PARKED EARLIER IN THE DAY OR IF HE WAS STILL ON THE ROAD. DEJAN INFORMED NEMANJA THAT HE PARKED THE TRACTOR AROUND 1800 HOURS AND THAT IT SHOULD BE IN THE LOT. NEMANJA USED A PHONE APP CALLED FLEETMASTERS WHICH HAD A GPS LOCATOR ON THE TRACTOR. THE PHONE APP SHOWED THE TRACTOR WAS PARKED AT 143 BEELINE DR AT 1755 HOURS, 1/29/16 AND WAS MOVED AT 2141 HOURS THE SAME DAY. THE TRACTOR WAS THEN TAKEN TO AN OPEN LOT AT 850 W 45TH ST IN CHICAGO AND ARRIVED AT 2229 HOURS AND THE VEHICLE SAT IDLE FOR A PERIOD OF TIME. THE GPS TRACKING THEN SHOWED THE TRACTOR MOVED AGAIN AND WAS PARKED AT 4109 S UNION IN CHICAGO.**

**RO THEN SPOKE TO THE DRIVER OF THE TRACTOR, DEJAN, WHO INFORMED RO THAT HE RECEIVED A LOAD OF 43,000LBS OF RECYCLED COPPER FROM BEHR SPECIALTY METALS AT 208 QUAKER RD IN ROCKFORD IL. AFTER RETURNING TO 143 BEELINE, DEJAN, LEFT THE TRACTOR UNLOCKED AND LEFT THE KEYS TO THE VEHICLE UNDER THE HOOD AND INSIDE THE ENGINE COMPARTMENT. NEMANJA STATED THIS WAS STANDARD PRACTICE FOR WHEN A VEHICLE WAS SCHEDULED FOR MAINTENANCE. THE TRACTOR WAS THEN SCHEDULED TO TRAVEL TO INDIANA ON 1/31/16 TO DELIVER THE COPPER.**

**NEMANJA INFORMED RO THAT THERE IS VIDEO SURVEILLANCE FOR THE PARKING LOT BUT IS UNSURE WHETHER THE THEFT WOULD BE IN THE CAMERAS VIEW.**

**AT 0106 HOURS, THE TRACTOR AND TRAILER WERE BOTH PLACED INTO LEADS AS STOLEN AND RO CALLED CHICAGO PD FOR ASSISTANCE IN LOCATING THE TRACTOR AND TRAILER.**

**AT APPROX 0230 HOURS, DET. PTAK WENT TO 850 W 45TH ST AND FOUND THE TRAILER WHICH STILL CONTAINED THE LOAD OF COPPER. NEMANJA WAS NOTIFIED THAT THE TRACTOR AND TRAILER WERE BOTH LOCATED AND HE WENT TO DET. PTAK'S LOCATION ALONG WITH DEJAN TO RETRIEVE THE TRACTOR/TRAILER AND BRING THEM BACK TO BENSENVILLE. THE TRACTOR AND TRAILER WERE THEN TAKEN OUT OF LEADS AS STOLEN. ALL CONTENTS WAS INTACT.**
