Report Narrative

ON 07-28-2011 AT 1033 HRS. R/O WAS DISPATCHED TO THE METRA STATION AT 7 S. ADDISON ST. TO MEET WITH A METRA OFFICER WHO STATES HE HAS A BENSENVILLE RESIDENT THERE THAT WANTS TO REPORT A ROBBERY THAT OCCURRED IN BENSENVILLE. R/O MET W/ THE METRA OFFICER NEXT TO THE DEPOT WHO WAS TALKING WITH 2 MALE HISPANIC SUBJECTS.

R/O SEEING THAT THE VICTIM SPOKE ONLY SPANISH, REQUESTED A SPANISH SPEAKING BENSENVILLE OFFICER BUT WAS ADVISED THERE WERE NONE ON DUTY. R/O ASKED THE METRA OFFICER ALONZO #994 WHO SPOKE SPANISH, IF HE WOULD ASK THE VICTIM AND HIS SON TO MEET R/O AT THE BENSENVILLE POLICE STATION WHERE WE COULD SIT DOWN WITH R/O AND A TRANSLATOR (RECORDS CLERK CASILDO #543) TO GET FURTHER INFORMATION AND POSSIBLY OPEN AN INVESTIGATION.

VICTIM CRUZ-LOPEZ, MARTHO M/H [REDACTED], THROUGH TRANSLATION, STATED THE FOLLOWING IN SUMMARY: CRUZ STATED HE HAD RETURNED HOME ([REDACTED]) FROM WORK AT APPROX. 0050 HRS. ON 07-28-2011. HE ENTERED HIS APARTMENT BUILDING THROUGH THE MAIN (SOUTH) ENTRANCE AND OBSERVED 2 SUBJECTS 1-MALE AND 1 FEMALE SITTING ON THE STEPS OF THE STAIRCASE IN THE ENTRY WAY THAT LEADS UP TO HIS 2ND FLOOR APARTMENT. WHEN HE TRIED TO GET BY THE 2 SUBJECTS TO GO UPSTAIRS THEY ASKED HIM IF HE HAD A CIGARETTE OR SOMETHING TO THE EFFECT. WHEN CRUZ INDICATED "NO". CRUZ STATES THE SUBJECTS STOOD-UP AND THE FEMALE PUNCHED HIM IN THE BACK OF THE HEAD WITH A CLOSED FIST. THE MALE THEN BEGAN HITTING HIM AND KICKING HIM WITH HIS FEET. BOTH CONTINUED TO STRIKE CRUZ WHILE THE MALE OFFENDER DUG THROUGH HIS PANTS POCKETS AND EVENTUALLY PULLED \$150.00 (1-\$100 BILL & 1-\$50 BILL) OUT OF HIS RIGHT/FRONT PANTS POCKET. CRUZ STATED THE OFFENDERS ALSO TOOK HIS BLACK SINGLE STRAP BACKPACK WITH HIS COFFEE THERMOS INSIDE.

R/O OBSERVED A LARGE SWOLLEN INJURY/CUT (DRIED BLOOD) ON THE BACK OF HIS HEAD, AN ABRASION TO HIS RIGHT ELBOW AND HE COMPLAINED OF PAIN IN HIS RIGHT PALM/WRIST AREA. SEE PHOTOS.

CRUZ STATED AT THIS POINT HE BEGAN RUNNING. HE RAN OUT THE FRONT (SOUTH) ENTRANCE DOOR BUT FELL ON THE OUTSIDE CONCRETE STOOP, INJURING HIS RIGHT HAND & ELBOW. CRUZ STATED HE GOT UP AND CONTINUED TO RUN S/B TO THE "EDMAR" GROCERY STORE ACROSS THE STREET (ROOSEVELT AV.) TO GET AWAY FROM THE OFFENDERS. CRUZ DESCRIBED THE OFFENDERS AS FOLLOWED:

CRUZ ALSO STATED THAT THEY HAVE A FRIEND THAT THEY VISIT WHO LIVES ON THE 3RD FLOOR OF THE APARTMENT BUILDING, HE IS DESCRIBED AS A MALE HISPANIC AND APPROX. 13 OR 14 YEARS OLD. CRUZ IS UNCERTAIN OF THE APARTMENT #.

CRUZ DID NOT WISH PARAMEDICS TO RESPOND BUT R/O SUGGESTED HE MAY WANT TO SEEK MEDICAL ATTENTION FOR THE CUT/BUMP ON THE BACK OF HIS HEAD AND THE PAIN IN HIS RIGHT ARM.

Report Narrative ON 072811 AT APPROX 1030 HOURS., THIS R/I ASSISTED OFC. EICKLEMANN WITH A ROBBERY REPORT IN THE LOBBY OF THE P.D. THE VICTIM, CRUZ-LOPEZ, WAS BROUGHT INTO THE CONFERENCE ROOM OF THE P.D. RECORDS CLERK CASILDO TRANSLATED FOR THE VICTIM. WHILE THE VICTIM WAS DETAILING THE INCIDENT HE GAVE A DESCRIPTION OF ONE OF THE OFFENDERS. R/I KNEW FROM THE DESCRIPTION THAT THE SUSPECT MAY BE A 13 YOA FEMALE THAT THIS DEPARTMENT HAS HAD PREVIOUS CONTACTS WITH.

THIS R/I AND OFC. BANKS THEN WENT TO THE JUVENILE'S RESIDENCE LOCATED AT [REDACTED]. THE R/I MET WITH THE JUVENILE AND HER GRANDMOTHER, ROSEMARY CHRISTENSEN. R/I EXPLAINED TO CHRISTENSEN ABOUT THE INCIDENT AND THAT WE NEEDED TO SPEAK WITH THE JUVENILE REGARDING THE INCIDENT. CHRISTENSEN, WHO IS THE GUARDIAN OF THE JUVENILE, GAVE THIS R/I PERMISSION TO TAKE THE JUVENILE TO THE P.D. TO INTERVIEW HER. AT THIS TIME THE JUVENILE WAS TRANSPORTED TO THE P.D. BY OFC. LAPORTE.

THIS R/I AND MET WITH THE JUVENILE AT THE P.D. R/I TOOK A PICTURE OF THE JUVENILE AND COMPILED A PHOTO LINEUP WHICH CONSISTED OF THE FOLLOWING JUVENILES:

THIS R/I THEN MET WITH THE VICTIM IN THE CONFERENCE ROOM. R/I EXPLAINED AND SHOWED THE VICTIM THE PHOTO LINEUP ADVISORY FORM. THE VICTIM STATED THAT HE UNDERSTOOD AND SIGNED THE FORM. THIS R/I THEN SHOWED THE VICTIM THE LINEUP. THE VICTIM PICKED OUT #5, THE JUVENILE SUSPECT, STATING THIS WAS THE GIRL THAT ROBBED HIM.

AT 1300 HOURS THIS R/I AND OFC. BANKS INTERVIEWED THE JUVENILE IN THE INVESTIGATIONS OFFICE OF THE P.D. R/I READ THE JUVENILE HER CONSTITUTIONAL RIGHTS OF A PERSON BEING INTERVIEWED FROM A PRE-PRINTED FORM. THE JUVENILE STATED AND SIGNED THAT SHE UNDERSTOOD HER RIGHTS. THE JUVENILE AGREED TO SPEAK WITH THIS R/I WITHOUT THE PRESENCE OF AN ATTORNEY.

THIS R/I ASKED THE JUVENILE ABOUT BEING AT [REDACTED] ON THE NIGHT OF THE INCIDENT. THE JUVENILE STATED THAT SHE WAS ON THE BACKSTEPS OF THE BUILDING WITH PETER CAPOTE AND THEY WERE TALKING. THE JUVENILE STATED THAT A MALE HISPANIC WALKED UP AND WAS STARING AT HER. THE JUVENILE STATED THAT SHE DID NOT LIKE WHEN PEOPLE STARED AT HER. THE JUVENILE STATED THAT THE MALE KEPT STARING AND THAT SHE WALKED UP TO HIM AND PUNCHED HIM IN THE FACE. THE JUVENILE STATED THAT THE PUNCH KNOCKED THE VICTIM TO THE GROUND. THE JUVENILE STATED THAT SHE CONTINUED TO PUNCH THE VICTIM WHILE HE WAS ON THE GROUND. THE JUVENILE ALSO STATED THAT CAPOTE KICKED THE VICTIM WHILE HE WAS ON THE GROUND.

THIS R/I INQUIRED ABOUT THE \$150.00 THAT WAS STOLEN FROM THE VICTIM. THE JUVENILE STATED THAT SHE DID NOT TAKE HIS MONEY AND THAT MAYBE CAPOTE HAD. THE JUVENILE STATED THAT CAPOTE DID TAKE THE VICTIM'S BACKPACK. THE JUVENILE STATED THAT THE VICTIM WAS ABLE TO GET UP AND THAT HE RAN AWAY.

THIS R/I THEN CONCLUDED THE INTERVIEW AND TRANSPORTED TO THE JUVENILE BACK TO HER RESIDENCE WITH CHARGES PENDING.

AT APPROX 1610 HOURS., THIS R/I WAS NOTIFIED BY OFC. LAPORTE THAT HE HAD CAPOTE STOPPED NEAR THE LIBRARY. THIS R/I ASKED OFC. LAPORTE TO TRANSPORT CAPOTE TO THE P.D. TO BE INTERVIEWED. AT 1620 HOURS THIS R/I AND SGT. DOOLEY MET WITH CAPOTE IN THE INTERVIEW ROOM OF THE P.D. THIS R/I READ CAPOTE HIS CONSTITUTIONAL RIGHTS OF A PERSON BEING INTERVIEWED FROM A PRE-PRINTED FORM. CAPOTE STATED AND SIGNED THAT HE UNDERSTOOD HIS RIGHTS AND AGREED TO SPEAK WITH THIS R/I WITHOUT THE PRESENCE OF AN ATTORNEY.

CAPOTE STATED THAT HE AND THE JUVENILE WERE ON THE BACK STEPS OF [REDACTED] TALKING. CAPOTE STATED THAT A HISPANIC MALE WALKED UP TO THEM AND THAT HE WAS STARING AT THE JUVENILE. CAPOTE STATED THAT THE MALES IN THE BUILDING ARE ALWAYS TOUCHING AND TALKING TO THE JUVENILE IN A SEXUAL MANNER. CAPOTE STATED THAT THE JUVENILE GOT UPSET BECAUSE THE MALE WAS STARING AT HER. CAPOTE STATED THAT THE JUVENILE THEN WALKED UP AND BEGAN PUNCHING THE VICTIM. CAPOTE STATED THAT THE JUVENILE KNOCKED HIM TO THE GROUND AND THAT SHE CONTINUED TO HIT HIM.

R/I THEN INQUIRED ABOUT THE \$150.00 THAT WAS STOLEN FROM THE VICTIM. CAPOTE STATED THAT HE DID NOT TAKE ANY MONEY FROM THE VICTIM, BUT DID SAY THAT HE DID THINK ABOUT IT.
