Dear Mr. Mance:

I am pleased to help you with your March 2, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on March 2, 2016. You requested copies of the items indicated below:

"15-3811."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV15003811.1. (2 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

At 0057 hours on 04/15/15, R/O and Ofc Herrera were dispatched to [REDACTED] to a call for domestic trouble. R/O and Ofc Herrera arrived on scene at 0059 hours. Upon arrival R/O met with Donecka D Ford who was in the hallway on the fourth floor of the apartment building. Donecka told R/O that she had a verbal argument with [REDACTED], over a cigarette in the bathroom. R/O then spoke with [REDACTED], who stated that he had a verbal argument with Donecka over the cigarette in the bathroom.

R/O requested dispatch to run Donecka through LEADS, which returned that she had a warrant out for her arrest for failure to appear-Unlicensed, LEADS # [REDACTED]. Dispatch informed R/O that the warrant is valid, Case # 11TR15533 bond set at \$2,000 cash bond 10% +\$75 warrant fee.

At 0140 hours, R/O placed Donecka D Ford under arrest for the failure to appear warrant. Donecka was searched incident to arrest before being placed in the squad car by Ofc Guest. Donecka was transported to the station by R/O and Ofc Herrera in squad #311.

At 0148 hours, Donecka was booked and processed by R/O. R/O took custody of Donecka's white Samsung smartphone and placed it in the storage cabinet for prisoner's property. At 0226 hours, Donecka was placed in cell #4, to await for bail to be brought to the station.

At 0403 hours [REDACTED] and Kevin D Green arrived at the station and posted bond in the amount of \$275, \$210 cash and \$65 with a credit card transaction reference # [REDACTED]. At 0446 hours Donecka was informed of her court date, 05/12/15 at 0900 hours in Room 100 at the Dekalb County Courthouse 133 W State St, Sycamore IL 60178. R/O returned to Donecka her white Samsung smartphone and was released to Kevin D Green and [REDACTED].
