These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

ON 14JULY2015 AT APPROXIMATELY 0607 HOURS, THE R/O WAS DISPATCHED TO [REDACTED] ST FOR A REPORT OF DISORDERLY CONDUCT. DISPATCH NOTIFIED THE R/O A SUBJECT, TO LATER BE IDENTIFIED AS MIGUEL SALAZAR M/H [REDACTED], POINTED WHAT APPEARED TO HAVE BEEN A GUN AT [REDACTED] M/[REDACTED] AND FLED ON GROVE. DISPATCH STATED MIGUEL WAS DRIVING A BLACK BMW. A SEARCH OF THE AREA TURNED UP NEGATIVE RESULTS FOR MIGUEL'S VEHICLE.

UPON ARRIVAL TO [REDACTED], THE R/O SPOKE WITH [REDACTED], WHO STATED THE FOLLOWING TO THE R/O: AT APPROXIMATELY 0559 HOURS, MIGUEL CAME FROM THE NW ALLEY BEHIND [REDACTED] AND STOPPED OUTSIDE OF [REDACTED] BACKYARD. MIGUEL GOT OUT OF HIS VEHICLE AND POINTED A BLACK GUN AT [REDACTED]. MIGUEL WAS UPSET ABOUT AN INCIDENT BETWEEN [REDACTED] AND MIGUEL'S WIFE, CLAUDIA SALAZAR F/H [REDACTED], IN WHICH [REDACTED] WAS ARRESTED FOR BATTERY AND DISORDERLY CONDUCT (DUPAGE SHERIFF CASE #15-20955). [REDACTED] STATED MIGUEL WAS JEALOUS AND WANTED TO "TAKE MATTERS INTO HIS OWN HANDS." [REDACTED] TOLD MIGUEL HE WAS "WORKING TO FIX THE PROBLEM" AND "PAYING FOR HIS MISTAKES." MIGUEL THEN STATED HE WAS GOING TO "FIX IT ON HIS OWN," AND [REDACTED] WAS "GOING TO PAY FOR IT." [REDACTED] WIFE, PRISCILLA DIAZ-ZEPEDA F/H [REDACTED], WAS ALSO IN THE BACKYARD AT THE TIME OF THE INCIDENT TOOK OUT HER CELL PHONE AND BEGAN TO TAKE PHOTOS OF MIGUEL. MIGUEL SAID, "I DON'T CARE IF YOU TAKE PICTURES OF ME." GOT INTO HIS VEHICLE AND LEFT THE PREMISES. [REDACTED] STATED HE AND DIAZ-ZEPEDA WERE BOTH ALARMED AND DISTURBED BY MIGUEL'S ACTIONS AND CONTACTED BPD FOR FURTHER ASSISTANCE.

DIAZ-ZEPEDA PROVIDED THE R/O A PHOTO OF MIGUEL'S VEHICLE BACKING OUT OF THE ALLEY BEHIND [REDACTED], WHICH HAS BEEN PLACED INTO EVIDENCE.

THE R/O LEARNED FROM COURT DOCUMENTS PROVIDED BY [REDACTED] THAT SALAZAR RESIDES AT [REDACTED] IN BENSENVILLE, AND NOTIFIED DISPATCH OF THIS INFORMATION. DISPATCH CORRECTED THIS INFORMATION AND ADVISED SALAZAR'S RESIDENCE CAME BACK TO AN ADDISON ADDRESS. OFC. REYNOLDS #534, OFC. CHA #531, OFC. MIRANDOLA #557, AND OFC. MARKS #560 RESPONDED TO SALAZAR'S RESIDENCE. UPON ARRIVAL, OFC. REYNOLDS SPOKE WITH CLAUDIA, WHO GAVE PERMISSION TO SEARCH THE PREMISES FOR A FIREARM, WHICH TURNED UP NEGATIVE RESULTS. OFC. REYNOLDS FOUND A SAFE, WHICH BELONGED TO MIGUEL. CLAUDIA GAVE PERMISSION TO CONFISCATE THE SAFE AND TAKE IT BACK TO BPD TO BE SEARCHED. CLAUDIA ALSO STATED MIGUEL WORKS AT O'HARE AIRPORT AND SHOULD BE FOUND THERE. OFC. MARKS TOLD CLAUDIA TO CONTACT HER HUSBAND AND ADVISE HIM TO COME INTO BPD FOR QUESTIONING. OFC. REYNOLDS TRANSPORTED THE SAFE BACK TO BPD.

AT APPROXIMATELY 0700 HOURS THE R/O WAS NOTIFIED MIGUEL WAS WAITING IN THE BPD LOBBY. THE R/O AND OFC. REYNOLDS MET WITH MIGUEL IN THE BPD LOBBY. MIGUEL STATED THE FOLLOWING TO THE R/O: AT APPROXIMATELY 0559 HOURS MIGUEL WAS DRIVING TO WORK AT O'HARE AIRPORT AND WAS PASSING [REDACTED] WHERE HE KNOWS [REDACTED] RESIDES. MIGUEL SAW [REDACTED] IN THE ALLEY BEHIND [REDACTED] AND DECIDED TO CONFRONT HIM. MIGUEL STATED HE WAS UPSET THAT NOT ENOUGH HAS HAPPENED TO [REDACTED] FOR THE INCIDENT WITH CLAUDIA, AND WANTED TO DO SOMETHING ABOUT IT. MIGUEL DROVE TOWARD [REDACTED], WHO RAN INTO HIS BACKYARD TO GET AWAY FROM HIM. MIGUEL STOPPED OUTSIDE OF [REDACTED] BACKYARD. MIGUEL THEN EXITED THE VEHICLE HOLDING A 16" SOCKET WRENCH IN HIS HAND AND BEGAN YELLING AT [REDACTED]. MIGUEL STATED [REDACTED] NEEDED TO PAY FOR "DESTROYING HIS WIFE." THROUGHOUT THE INCIDENT MIGUEL WAS APPROXIMATELY 20 TO 25 FEET AWAY FROM [REDACTED]

AND DID NOT MOVE TOWARD HIM OR DIAZ-ZEPEDA. MIGUEL STATED HE REMAINED BY HIS VEHICLE AND HELD THE SOCKET WRENCH BY HIS HEAD. MIGUEL OBSERVED DIAZ-ZEPEDA HOLDING HER PHONE AND TAKING PHOTOS AND SAID HE "DIDN'T CARE IF SHE TOOK PICTURES OF ME." MIGUEL WAS ABLE TO TELL BOTH [REDACTED] AND DIAZ-ZEPEDA WERE SCARED OF HIM AND SAID IT MADE HIM "FEEL BETTER." MIGUEL GOT BACK IN HIS VEHICLE AND CONTINUED TOWARDS WORK. AT HIS WORK, MIGUEL RECEIVED A PHONE CALL FROM HIS WIFE AND WAS ADVISED TO COME INTO BPD FOR QUESTIONS ABOUT THE INCIDENT AT [REDACTED].

MIGUEL ALSO STATED HE OWNED A FIREARM IN THE 80'S, BUT SOLD IT AND WAS NO LONGER IN POSSESSION OF ONE, NOR WAS HE IN POSSESSION OF A VALID FOID CARD.

OFC. REYNOLDS ASKED MIGUEL FOR PERMISSION TO SEARCH HIS VEHICLE AND WORK STATION, WHICH MIGUEL PROVIDED. MIGUEL ADVISED OFC. REYNOLDS HIS VEHICLE WAS PARKED AT IRVING PARK RD AND SOUTH ACCESS RD AND HE WORKED IN A YELLOW CATERPILLAR BACKHOE MACHINE. MIGUEL ALSO MENTIONED HE HAD A BLACK LUNCHBOX AT HIS WORK AND OFC. REYNOLDS HAD PERMISSION TO SEARCH EACH OF THESE AREAS. A SEARCH BY OFC. REYNOLDS TURNED UP NEGATIVE RESULTS FOR A FIREARM. OFC. REYNOLDS DID FIND A SOCKET WRENCH IN MIGUEL'S VEHICLE, LIKE THE ONE HE DESCRIBED USING TO SCARE [REDACTED] AND DIAZ-ZEPEDA. OFC. REYNOLDS LATER PLACED THE SOCKET WRENCH INTO EVIDENCE.

AT BPD, OFC. REYNOLDS ASKED MIGUEL IF HE COULD RETRIEVE THE KEY TO THE SAFE FROM MIGUEL'S RESIDENCE. MIGUEL STATED THEY WERE AT HIS HOUSE, BUT DID NOT WANT BPD TO DISTURB CLAUDIA WHILE SHE WAS WATCHING CHILDREN. MIGUEL SAID HE WAS WILLING TO BREAK OPEN THE SAFE, AND DID SO. THE R/O SEARCHED THE CONTENTS OF THE SAFE FOR A FIREARM OR PAPERWORK RELATING TO OWNERSHIP OF A FIREARM, WHICH TURNED UP NEGATIVE RESULTS FOR BOTH.

THE R/O ADVISED MIGUEL HE WAS UNDER ARREST FOR DISORDERLY CONDUCT, AND PLACED MIGUEL INTO CUSTODY. THE R/O PUT HANDCUFFS ON MIGUEL, CHECKED FOR PROPER FIT AND DOUBLE LOCKED THEM. THE R/O THEN TOOK MIGUEL TO THE BOOKING AREA WHERE HE WAS PROCESSED AND GIVEN A TICKET FOR DISORDERLY CONDUCT. MIGUEL PROVIDED \$120 USC FOR BOND ON TICKET # [REDACTED]. MIGUEL WAS PROVIDED HIS PAPERWORK AND ADVISED TO NOT HAVE FURTHER CONTACT WITH [REDACTED], DIAZ-ZEPEDA OR THEIR TWO CHILDREN, TO WHICH MIGUEL STATED HE UNDERSTOOD.
