Re: March 10, 2016 FOIA Request

Dear Mr. Murphy:

I am pleased to help you with your March 10, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on March 14, 2016. You requested copies of the items indicated below:

"Report #16-2249."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Non Crime/Other Report No. BV16002249.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 3/10/16 AT APPROXIMATELY 1240 HOURS, THE R/O OFFICER MELONE #521 WAS FLAGGED DOWN BY A SUBJECT REQUESTING TO MAKE A THEFT REPORT.**

THE R/O SPOKE WITH GERALD F. MURPHY, M/W, [REDACTED] WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: MURPHY SHUT DOWN A RESTAURANT/BAR AND NEEDED A PLACE TO STORE MISCELLANEOUS PROPERTY. JAMIE E. ENGER, M/W, [REDACTED] PUT MURPHY IN CONTACT WITH THE OWNER OF THE PROPERTY AT 320 MEYER DRIVE, ROBERT PALMER, AND ADVISED THAT PALMER MAY BE WILLING TO STORE MURPHY'S PROPERTY IN HIS WAREHOUSE. APPROXIMATELY A YEAR AND HALF AGO, MURPHY PUT HIS PROPERTY INTO THE WAREHOUSE. MURPHY AND PALMER NEVER MADE ANY ARRANGEMENT IN REGARDS TO PAYMENTS OR HOW LONG THE ITEMS WOULD BE STORED. MURPHY DID NOT PROVIDE ENGER WITH HIS ADDRESS OR PHONE NUMBER AND THE ONLY MEANS OF COMMUNICATION WERE THROUGH ENGER. MURPHY HAD BEEN TO THE WAREHOUSE APPROXIMATELY 6 TIMES TOTAL WHILE THE PROPERTY WAS AT THE WAREHOUSE TO EITHER CHECK ON HIS PROPERTY OR TO REMOVE ITEMS HE WAS SELLING. THE LAST TIME MURPHY SAW HIS PROPERTY WAS APPROXIMATELY 2-3 MONTHS AGO. MURPHY WAS AT THE ADDRESS AND WAS NOT ABLE TO VIEW ALL OF HIS PROPERTY DUE TO A TRUCK OBSTRUCTING HIS VIEW, HOWEVER HE DID OBSERVE HIS PROPERTY PRESENT. APPROXIMATELY 3 WEEKS AGO MURPHY OBSERVED THAT ALL OF HIS PROPERTY HAD BEEN REMOVED. MURPHY ASSERTS THAT AT NO TIME WAS HE TOLD BY EITHER PALMER OR ENGER TO REMOVE HIS PROPERTY FROM THE WAREHOUSE AND FURTHER STATED THAT HE DOES NOT BELIEVE PALMER TO HAVE HIS PHONE NUMBER OR ADDRESS. MURPHY ADVISED THAT ENGER WOULD TELL THE R/O THE SAME THING. MURPHY ESTIMATES THE TOTAL VALUE AT \$35,773.

THE R/O RESPONDED TO 320 MEYER AND SPOKE WITH PALMER REGARDING THE ABOVE INFORMATION. PALMER GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: MURPHY'S PROPERTY WAS AT HIS WAREHOUSE FOR APPROXIMATELY 2 YEARS. PALMER HAS ADVISED MURPHY TO REMOVE HIS PROPERTY FOR AT LEAST ONE YEAR. PALMER ADVISED THAT HE ALSO SPOKE WITH ENGER ASKING TO HAVE MURPHY'S PROPERTY REMOVED. MURPHY WOULD OCCASIONALLY COME AND REMOVE A FEW ITEMS BUT THE LARGE MAJORITY OF THE PROPERTY JUST SAT AT THE WAREHOUSE TAKING UP A SIGNIFICANT AMOUNT OF SPACE. IN MID JANUARY ANY REMAINING PROPERTY WAS PLACED OUTSIDE OF THE WAREHOUSE AND WAS SUBSEQUENTLY REMOVED BY A SCRAP COLLECTOR. PALMER ADVISED THAT HE MADE EVERY EFFORT TO GIVE MURPHY THE OPPORTUNITY TO REMOVE HIS ITEMS BUT HE NEVER DID. PALMER ADVISED THAT HE HAD SPOKE WITH MURPHY IN PERSON AND OVER THE PHONE REQUESTING MURPHY TO REMOVE THE PROPERTY. PALMER CONFIRMED THAT MURPHY WAS NOT ASKED TO PAY IN FOR THE STORAGE SPACE.

THE R/O SPOKE WITH ENGER OVER THE PHONE WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: ENGER AND PALMER HAVE BOTH TOLD MURPHY THAT PALMER WANTED THE PROPERTY REMOVED AND THEY HAVE BEEN TELLING MURPHY THAT FOR APPROXIMATELY A YEAR. ENGER ADVISED THAT MURPHY WAS WELL AWARE THAT HE NEEDED TO MAKE NEW ARRANGEMENTS TO STORE THE PROPERTY ELSEWHERE. ENGER ADVISED THAT ONCE PALMER AND MURPHY BEGAN COMMUNICATING DIRECTLY HE STOPPED BEING THE MIDDLE MAN.

THE R/O SPOKE WITH MURPHY AGAIN AND ADVISED HIM THAT HIS CASE WOULD NOT BE CONSIDERED CRIMINAL IN NATURE AND THAT MURPHY WOULD HAVE TO PURSUE THE ISSUE IN CIVIL COURT IF HE WISHED TO DO SO.
