Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 10-28-15 AT APPROXIMATELY 1900 HOURS, THE R/O WAS DISPATCHED TO THE BENSENVILLE POLICE DEPARTMENT, 345 W. GREEN STREET, FOR THE HARASSMENT BY TELEPHONE REPORT. THE R/O ARRIVED AND SPOKE WITH GEORGE SARRIS, M/W [REDACTED], WHO STATED THAT HIS WIFE, WHO HE IS CURRENTLY SEPARATED FROM, IS CALLING AND SENDING HIM TEXT MESSAGES, AND HE WOULD LIKE IT TO STOP.**

**GEORGE STATED IN SUMMARY THAT, ON 10-19-15 HE CAME INTO THE BENSENVILLE POLICE DEPARTMENT AND SPOKE WITH OFC. MELNYK #533 AND OFC. NAVARRO #539 ABOUT HIS WIFE, LETICIA I. SARRIS, FW, [REDACTED], WHO CURRENTLY LIVES IN FLORIDA, AND SHE HAS BEEN SENDING HIM TEXT MESSAGES AND PHOTOGRAPHS TO HIS CELL PHONE, CELL PHONE NUMBER [REDACTED] AND GEORGE WOULD LIKE IT TO STOP, SEE REPORT 15-11157 FOR FURTHER. GEORGE STATED THAT, THE POLICE MADE CONTACT WITH LETICIA AND ADVISED HER TO ONLY CONTACT GEORGE WHEN IT RELATES TO THEIR SON THAT GEORGE AND LETICIA HAVE TOGETHER. GEORGE STATED THAT, HE HAS NOT TEXTED LETICIA SINCE 10-19-15. GEORGE STATED THAT, ON 10-28-15 HE RECEIVED APPROXIMATELY TWENTY TEXT MESSAGES FROM LETICIA, ALONG WITH NUDE PHOTOS. GEORGE THINKS THAT LETICIA IS DOING THIS TO MAKE HIS CURRENT FIANCE JEALOUS. GEORGE STATED THAT, HE WOULD LIKE THE R/O TO CALL LETICIA AND ADVISE HER TO STOP SENDING HIM TEXT MESSAGES, AND CALLING HIM. GEORGE ALSO STATED THAT, A FAKE FACEBOOK ACCOUNT WAS STARTED, POSSIBLY BY LETICIA. GEORGE ALSO STATED THAT, HE IS GOING TO BE DIVORCING LETICIA AND SHE IS UPSET WITH THAT.**

**ON 10-28-15 AT 1918 HOURS, THE R/O CALLED LETICIA, [REDACTED], AND SPOKE WITH HER ON THE PHONE. LETICIA STATED THAT, ON 10-28-15 HER AND GEORGE WERE TALKING ON THE PHONE ABOUT THEIR SON. LETICIA LATER STATED THAT, IT WAS ONLY TEXT MESSAGES THAT THEY WERE SENDING BACK AND FORTH ABOUT THEIR SON, AND SHE DOES NOT KNOW WHY GEORGE WOULD BE IN THE LOBBY OF THE POLICE DEPARTMENT, WITH THE POLICE CALLING HER. THE R/O ADVISED LETICIA THAT SHE IS SENDING HARASSING TEXT MESSAGES AND PHOTO'S TO GEORGE VIA THE CELL PHONE AND THE IT NEEDS TO STOP. LETICIA STATED THAT, SHE IS UPSET WITH GEORGE BECAUSE HE IS NOT PAYING CHILD SUPPORT, AND SHE IS LIVING IN FLORIDA TAKING CARE OF THEIR SIX YEAR OLD SON THAT LETICIA AND GEORGE HAVE TOGETHER. LETICIA STATED THAT, SHE FORWARDED MESSAGES TO GEORGE, AFTER GEORGES MOTHER CALLED LETICIA SWEARING AT HER ON HER CELL PHONE VOICE MAIL. THE R/O ASKED LETICIA ABOUT THE FAKE FACEBOOK ACCOUNT, AND DENIED ANY KNOWLEDGE, BUT STATED THAT GEORGE HAD THREE FACEBOOK ACCOUNTS. THE R/O ADVISED LETICIA TO NO LONGER HAVE ANY CONTACT WITH GEORGE VIA CELL PHONE CALLS OR TEXT MESSAGES. LETICIA STATED THAT, SHE UNDERSTOOD. THE R/O ADVISED LETICIA OF GEORGES INTENTION OF DIVORCE, AND FOR HER TO HIRE A LAWYER TO PROCEED WITH DIVORCE PROCEEDINGS.**

**THE R/O THEN WENT BACK INTO THE LOBBY OF THE POLICE DEPARTMENT TO SPEAK WITH GEORGE, AND HE STATED THAT LETICIA HAD ALREADY CALLED HIM, AFTER THE R/O ADVISED HER TO STOP. GEORGE'S FIANCE, STATED THAT THE FACEBOOK PAGE HAS SINCE BEEN DELETED, WHEN SHE WAS GOING TO TAKE A SCREEN SHOT TO SAVE FOR COURT PROCEEDINGS. THE R/O ADVISED GEORGE OF THE SAME THINGS HE TOLD LETICIA, TO NO LONGER CALL OR SEND EACH OTHER TEXT MESSAGES. GEORGE WAS INFORMED TO HAVE NO FAMILY MEMBERS CALL LETICIA EITHER. GEORGE STATED THAT, HE UNDERSTOOD AND HE WOULD BE TAKING THE NECESSARY STEPS TO PROCEED WITH A DIVORCE FROM LETICIA. THE R/O ADVISED WHEN HE HIRES A LAWYER, TO HAVE THE LAWYERS COMMUNICATE WITH EACH OTHER UNTIL ARRANGEMENTS ARE MADE ABOUT COMMUNICATIONS WITH EACH OTHER AND ABOUT THE CHILD. GEORGE STATED THAT, HE UNDERSTOOD.**

Report Narrative: On 12/05/15 at approximately 1900 hrs, I, Officer Driscoll #518, was dispatched to the lobby of the Bensenville Police Station for a harassment by telephone report.

I spoke with George Sarris m/w [REDACTED], who stated that his wife, who currently lives in Florida and are separated from one another, Leticia Sarris f/w [REDACTED] was advised to stop contacting George by other Bensenville Officers (See reports BV15011495 and BV15011157 for further). Since she was asked to stop contacting George by other Officers, she has continued to send texts on multiple occasions to George. Leticia has also sent nude photographs of herself and other males to the cell phone of George.

George's girlfriend, [REDACTED] f/w, stated that she has been victim of Leticia by receiving Facebook messages from Leticia, harassing phone calls to the place of [REDACTED] business and believes that Leticia's new boyfriend, who is a Police Officer in the State of Florida, has used the state records to locate her home address.

I made contact with Leticia and requested that she ceases all contact with George and [REDACTED]. I confronted her about the nude photos, the harassment of [REDACTED] and the constant text messages. She denies all accusations but advises that she only contacts him when trying to get money from George for their child they share in common.

George advises that Pascoe County Sheriff's, Deputy Rodriguez (727-844-7764) is standing by for the reports so the matter can be addressed with Leticia by the Pascoe County Sheriff's Department.

On 02/05/16 at approximately 1815 hrs, I completed a follow-up with [REDACTED] who further advises that Leticia has created a fraudulent Facebook account using [REDACTED] legal name and has since texted George claiming that [REDACTED] has been stalking her. Leticia has continued to send text messages and photos containing nudity of herself and other males in the photos.

[REDACTED] further advises (via telephone) that she has printed the harassing texts. [REDACTED] was asked to maintain possession of the prints until Pascoe County advise her how to provide them the documentation.
