Dear Mr. Heaps:

I am pleased to help you with your March 23, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on March 24, 2016. You requested copies of the items indicated below:

"Any booking photos, police report and contact cards regarding any arrests of me by your agency."

After a search of Village files, the following documents are enclosed to fulfill your request:

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **ON 03/01/11 AROUND 2130 HOURS R/O (OFC HOLMAN #533) WAS DISPATCHED TO THE BENSENVILLE POLICE DEPARTMENT FOR THE REPORT OF TELEPHONE HARASSMENT. AROUND 2131 HOURS R/O MET WITH STOKLOSA, LYNDISAY, N FW [REDACTED] AT THE BENSENVILLE POLICE DEPARTMENT.**

STOKLOSA STATED IN SUMMARY THAT SHE RECENTLY BROKE OFF A RELATIONSHIP WITH THE FATHER OF THEIR TWO CHILDREN [REDACTED]. [REDACTED] HAS SINCE STARTED A NEW RELATIONSHIP WITH GARY, MICHELLE, L FW [REDACTED], WHO [REDACTED] HAS A CHILD WITH AS WELL. STOKLOSA HAS RECEIVED SEVERAL PHONE CALLS OVER THE PAST COUPLE OF WEEKS FROM A RESTRICTED PHONE NUMBER, STOKLOSA ANSWERED THESE PHONE CALLS BUT THERE WAS NO ANSWER ON THE OTHER END OF THE LINE. STOKLOSA BELIEVES THAT GARY AND [REDACTED] ARE BEHIND THE PHONE CALLS BECAUSE ONE OF THE CALLS WAS NOT RESTRICTED AND THE PHONE NUMBER OF [REDACTED] SHOWED ON HER CALLER ID. STOKLOSA STATED THAT THIS TELEPHONE NUMBER BELONGS TO THE HOME OF GARY. STOKLOSA ALSO INFORMED R/O THAT SHE HAS BEEN IN CONTACT WITH [REDACTED] VIA FACEBOOK BECAUSE SHE WAS TRYING TO SET UP A TIME FOR [REDACTED] TO SEE HIS CHILDREN. STOKLOSA HAD BEEN MAKING HER CONTACT WITH [REDACTED] BY POSTING MESSAGES ON [REDACTED] FACEBOOK PAGE. WHENEVER STOKLOSA MAKES A POST ON [REDACTED] FACEBOOK PAGE GARY MAKES A POST ON STOKLOSA'S POST CALLER HER OBSCENE NAMES AND TELLING HER TO QUIT CONTACTING [REDACTED] STOKLOSA INFORMED R/O THAT THESE POSTS IN QUESTION WERE MADE ON 02/28/11 AND 03/01/11. STOKLOSA THEN WENT ON TO INFORM R/O THAT ON 03/01/11 AROUND 1600 HOURS SHE CHANGED HER PHONE NUMBER SO THAT SHE WOULD NOT RECEIVE ANY MORE PHONE CALLS FROM [REDACTED] OR GARY. ON 03/01/11 AROUND 1900 HOURS A WHITE COTTAGE PIZZA DELIVERY PERSON SHOWED UP AT STOKLOSA'S HOME AT [REDACTED] WITH SEVEN PIZZAS, STATING THAT SHE HAD ORDERED THE PIZZAS. THE PIZZA DELIVERY PERSON THEN INFORMED STOKLOSA THAT THEY HAD A CONTACT PHONE NUMBER OF [REDACTED] FOR THE PERSON THAT HAD ORDERED THE PIZZAS. STOKLOSA THEN INFORMED THE DELIVERY PERSON THAT THE PHONE NUMBER THEY HAD WAS HER OLD PHONE NUMBER WHICH SHE HAD JUST RECENTLY CHANGED. STOKLOSA THEN SPOKE WITH AN OWNER OF WHITE COTTAGE PIZZA VIA TELEPHONE AND INFORMED HIM THAT SHE BELIEVED THAT GARY MAY HAVE BEEN THE PERSON TO ORDER THE PIZZAS BECAUSE SHE IS AN EMPLOYEE OF WHITE COTTAGE PIZZA AND KNOWS STOKLOSA'S OLD PHONE NUMBER. STOKLOSA ALSO INFORMED THE OWNER THAT GARY HAS A PERSONAL ISSUE WITH STOKLOSA AND BELIEVES THAT IS THE REASON THE PIZZAS WERE ORDERED. THE OWNER OF WHITE COTTAGE PIZZA THEN INFORMED STOKLOSA THAT HE WOULD BE FILING A POLICE REPORT WITH THE WOOD DALE POLICE DEPARTMENT ON 03/02/11 FOR THE SEVEN UNPAID PIZZAS.

STOKLOSA WISHED TO HAVE THE INCIDENTS DOCUMENTED BECAUSE IF FURTHER INCIDENTS OCCUR, COMPLAINTS WILL BE SIGNED.

STOKLOSA INFORMED R/O THAT SHE MADE A FACEBOOK POST ON THE MORNING OF 03/01/11 TELLING GARY AND [REDACTED] NOT TO CONTACT HER ANYMORE.

ON 03/01/11 AROUND 2145 HOURS R/O ATTEMPTED TO CONTACT GARY VIA TELEPHONE BUT R/O'S ATTEMPTS WENT UNANSWERED.

R/O INFORMED STOKLOSA THE NEXT TIME STOKLOSA IS CONTACTED BY [REDACTED] OR GARY TO INFORM THEM VERBALLY THAT SHE NO LONGER WANTS THEM TO CONTACT HER IN ANY WAY OR THEY ARE GOING TO HAVE CRIMINAL COMPLAINTS FILED AGAINST THEM. R/O ALSO RECOMMENDED THAT STOKLOSA CONTACT DUPAGE COUNTY TO APPLY FOR AN ORDER OF PROTECTION.

R/O THEN BEGAN HEADING SOUTH ON CHURCH TOWARD JEFFERSON WITH THE EMERGENCY LIGHTS OF SQUAD #310 ACTIVATED. AS R/O APPROACHED THE INTERSECTION OF CHURCH AND JEFFERSON DISPATCH INFORMED OFFICERS THAT [REDACTED] WAS LEAVING THE RESIDENCE OF [REDACTED], AND TRAVELING W/B ON JEFFERSON IN A WHITE CAR. PASSENGER FRONT SEAT. AN EMPTY TECATE BEER BOTTLE WAS ALSO LOCATED UNDER THE PASSENGER FRONT SEAT. R/O COLLECTED THE BEER CANS, BOTTLE, AND BAG. R/O TRANSPORTED THESE ITEMS BACK TO THE BENSENVILLE POLICE DEPARTMENT WHERE THEY WERE PHOTOGRAPHED BY OFC DRISCOLL. A MEMORY CARD CONTAINING THE PHOTOGRAPHS WAS LATER PACKAGED AND PLACED IN THE EVIDENCE DEPOSITORY IN THE BENSENVILLE POLICE DEPARTMENT BY OFC DRISCOLL. THE ITEMS DISCARDED AFTER PHOTOGRAPHS WERE TAKEN.
