These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

RO ARRIVED ON SCENE AND MET WITH [REDACTED] M/B [REDACTED] WHO RELATED THAT AT APPROXIMATELY 1515 HOURS ON 8/21/15 HE WAS WALKING AROUND THE FAIRWAY GREEN APARTMENT COMPLEX 646 S YORK RD WITH HIS FIANCE [REDACTED] F/W [REDACTED]. [REDACTED] RELATED THAT AFTER THE SECOND TIME AROUND THE COMPLEX HE WAS HIT ON THE BACK OF HIS HEAD WITH A GOLF BALL. [REDACTED] RELATED THAT THE GOLF BALL CAME FLYING FROM THE GOLF COURSE LOCATED NEXT TO THE APARTMENT COMPLEX. [REDACTED] RELATED THAT [REDACTED] CALLED THE PARAMEDICS AND BENSENVILLE FIRE PROTECTION PARAMEDICS TRANSPORTED HIM TO ALEXIAN BROTHERS MEDICAL CENTER. RO OBSERVED A BUMP ON THE BACK OF [REDACTED] HEAD.

ON 9/10/15 OFC EICKELMANN INFORMED RO THAT [REDACTED] CAME INTO THE STATION ON 09/09/15 IN REFERENCE CASE 15-8929 WHEN HE WAS HIT ON THE BACK OF THE HEAD WITH A GOLF BALL. EICKELMANN RELATED THAT [REDACTED] TOLD HIM THAT ON 08/23/15 [REDACTED] WAS IN THE KITCHEN AND HE EXPERIENCED NAUSEA, DIZZINESS, BUZZING IN EARS AND PASSED OUT. [REDACTED] RELATED THAT [REDACTED] TOOK HIM TO ALEXIAN BROTHERS MEDICAL CENTER EMERGENCY ROOM. [REDACTED] PROVIDED OFC EICKELMANN WITH COPIES OF HIS DISCHARGE PAPERWORK FROM BOTH 8/21/15 AND 8/23/15.

THE DISCHARGE PAPERWORK FROM 08/21/15 INDICATE THAT [REDACTED] WAS DIAGNOSED WITH A CONTUSION. [REDACTED] WAS GIVEN ZOFRAN ORAL 4MG AND IBU 600MG AT THE EMERGENCY ROOM OF ALEXIAN BROTHERS MEDICAL CENTER AND DISCHARGED ON 08/21/15 WITH INSTRUCTIONS TO FOLLOW UP WITH HAMEEDUDDIN, AFSHAN IN 1-2 DAYS.

THE DISCHARGE PAPERWORK FROM 08/23/15 INDICATE THAT [REDACTED] WAS DIAGNOSED WITH SYNCOPE (ED) AND CONCUSSION (ED). [REDACTED] WAS GIVEN 1000ML NS BOLUS, ZOFRAN 4MG IV, FENTANYL 50MCG IV AND ZOFRAN 4MG IV AT THE EMERGENCY ROOM OF ALEXIAN BROTHERS MEDICAL CENTER. BLACKWELL WAS PRESCRIBED NORCO 5/325 MG, ANTIVERT 25 MG AND ZOFRAN ODT 4MG AND DISCHARGED ON 08/23/15 WITH INSTRUCTIONS TO FOLLOW UP WITH KIEFER, PETER IN 1-2 DAYS.

OFC EICKELMANN INFORMED RO THAT [REDACTED] RELATED THAT A F/W APPROXIMATELY 50-60 YEARS OLD WITH GLASSES AND BROWNISH HAIR RODE OVER TO THE FENCE IN A GOLF CART AND SAID "MY BALLS OVER THERE". [REDACTED] RELATED THAT THE F/W WAS IN THE GOLF CART WITH ANOTHER LADY AND THE F/W LEFT IN THE GOLF CART.
