Dear Mr. Kais:

I am pleased to help you with your April 18, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on April 18, 2016. You requested copies of the items indicated below:

"Dog bite on 3/29/16 at 201 W. Belmont Ave., Bensenville, IL. Please provide: 1) any & all animal control records & reports (including any supplemental); 2) Any & all Bensenville Fire Department records and report (including and supplemental)."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Non Crime/Other Report No. BV16002982.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Please be aware, the Bensenville Fire District and Village of Bensenville are their own Taxing Bodies. Therefore, a separate FOIA request will need to be filed with the Bensenville Fire District to obtain any records they may have.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

UPON ARRIVAL R/O WAS MET BY THE VICTIM ([REDACTED]) AND BENDYK, EWELINA WHO WAS ACTING AS TRANSLATOR FOR [REDACTED] WHO STATED THE FOLLOWING IN SUMMARY: ON 03-29-16 AT APPROXIMATELY 1145 HRS, [REDACTED] WAS WORKING ON HER GARDEN & WAS ATTACKED BY A DOG THAT HAD BEEN LET OUT OF THE RESIDENCE LOCATED AT [REDACTED]. THE DOG BITE [REDACTED] ON THE RIGHT ARM IN TWO LOCATIONS (FOREARM, REAR UPPER BICEPS). THE DOG WAS THEN RETRIEVED BY JUVENILE #1 (HENCEFORE KNOWN AS JP) AND PLACED BACK INTO THE RESIDENCE. BFD ARRIVED ON SCENE & PROVIDED MEDICAL CARE TO [REDACTED] WHO ADVISED R/O SHE WOULD GO TO A HOSPITAL ON HER OWN TIME.

R/O APPROACHED THE RESIDENCE AT [REDACTED] AND MADE CONTACT WITH JP WHO STATED THE FOLLOWING IN SUMMARY: ON 03-29-16 JP WAS WALKING HIS FAMILY'S DOGS (8 IN TOTAL) AND ONE OF THE DOGS GOT LOOSE & ATTACKED [REDACTED]. JP THEN TOOK THE DOG BACK TO HIS HOME. R/O HAD JP CONTACT HIS MOTHER AS SHE HAD THE INFORMATION THAT PERTAINED TO THE DOG.

ON 03-29-16 AT APPROXIMATELY 1230 HRS, THE MOTHER (CIFUENTES, JENNIFER) RETURNED HOME & PROVIDED R/O WITH THE INFORMATION NEEDED IN REGARDS TO THE DOG.

R/O ADVISED CIFUENTES THAT SHE NEEDED TO REDUCE THE NUMBER OF PETS SHE HAD IN THE RESIDENCE & TO ENSURE ALL PAPERWORK THAT WAS NEEDED FOR THE REMAIN PETS. R/O THEN ISSUED CITATIONS TO CIFUENTES.

ON 03-30-16 R/O FAXED A COPY OF THE REPORT TO DUPAGE ANIMAL CONTROL.
