Re: April 29, 2016 FOIA Request

Dear Mr. Baltazar:

I am pleased to help you with your April 29, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on April 29, 2016 and extended May 6, 2016. You requested copies of the items indicated below:

"Report #16-3729."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV16003729.1. (2 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative On April 20th, 2016 at approximately 1000 hours the victim in this report, identified as [REDACTED], came into the Bensenville Police Department file a report regarding Unlawful Visitation Interference.

[REDACTED] stated the following in summary and not verbatim [REDACTED] state according to court order, he was to have visitation with his juvenile child for the first half of spring break. [REDACTED] brought in court documents proving his statement. [REDACTED] stated his ex-wife, identified as the offender in this report, Silvia E. CAMPOS did not allow him to visit with his juvenile child during the first half of the break. [REDACTED] stated he went to court and got a remedy allowing him to see his juvenile child for the second half of the break. [REDACTED] stated CAMPOS still refuses to allow him visitation and took their child out of state to St. Luis, Missouri. [REDACTED] stated CAMPOS is not allowed to take their child out of state without his permission. [REDACTED] stated he learned CAMPOS took their juvenile child out of state from another family member.

I, Officer (Ofc.) Sanborn initially referred [REDACTED] to the Markham, Illinois Police Department to file his report. I advised [REDACTED] that the MARKHAM Police could attempt to make contact with Campos at her residence. The Markham Police would be better able to document if CAMPOS was out of town, or home and still refusing to give visitation to [REDACTED]. I advised [REDACTED] to return to this PD where we can document the incident for him should Markham be unable to help him.

At approximately 1420 hours BALTIZAR returned to this PD and spoke with me again. [REDACTED] stated the Markham Police were both unwilling and unable to help him and referred him back to the Bensenville Police Department.

I advised [REDACTED] I would document the incident for him and provided him with this report number.

See attached court documents regarding visitation arrangements.

[REDACTED] stated he would sign complaints for the Unlawful Visitation Interference.
