Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: ON 10-25-10 AT APPROXIMATELY 0905 HOURS, THE R/O WAS DISPATCHED TO 758 INDUSTRIAL DR TO STAND BY WHILE A FORMER EMPLOYEE OF AUTO FORUM PICKED UP HIS PERSONAL TOOLS. THE R/O ARRIVED ON SCENE AND MET WITH PIOTROWSKI, JAN M/W [REDACTED] WHO STATED THAT HE WORKED AT AUTO FORUM AT THE END OF AUGUST AND THE BEGINNING OF SEPTEMBER, HOWEVER WAS FIRED AND NEVER RECEIVED HIS PERSONAL TOOLS.

THE R/O SPOKE WITH THE BUSINESS OWNER, BARANOWSKI, MIKE M/W [REDACTED], WHO STATED THAT PIOTROWSKI DID WORK FOR HIM FOR ABOUT 2 WEEKS AND DID STILL HAVE SOME OF HIS TOOLS AT 758 INDUSTRIAL DR, HOWEVER BARANOWSKI STATED THAT PIOTROWSKI TOOK TOOLS FROM THE BUSINESS WITHOUT PERMISSION AND HAS NOT RETURNED THEM. BARANOWSKI STATED THAT PIOTROWSKI UNLAWFULLY TOOK THE FOLLOWING ITEMS PRIOR TO BEING FIRED IN SEPTEMBER:

"SNAP-ON"-COIL SPRING COMPRESSOR  
"SNAP-ON"-SPRAY GUN  
"SNAP-ON"-AIR FILTER AND AIR HOSES

PIOTROWSKI WENT OUT TO HIS VEHICLE AND RETRIEVED THE SPRAY GUN, AIR FILTER AND AIR HOSES. BARANOWSKI STATED THAT THE TOOLS WERE DAMAGED AND HE WAS STILL MISSING THE "SNAP-ON" COIL SPRING COMPRESSOR, WHICH WAS VALUED AT \$600.00. PIOTROWSKI STATED THAT HE TOOK THE COIL SPRING COMPRESSOR, BUT HE NO LONGER HAD IT. PIOTROWSKI OFFERED TO PAY FOR THE COIL SPRING COMPRESSOR, BUT BARANOWSKI REFUSED STATING THAT PIOTROWSKI WAS NOT GOOD FOR THE MONEY.

THE R/O SPOKE WITH GASIOR, WALDEMAR M/W [REDACTED], WHO IS AN EMPLOYEE AT AUTO FORUM. GASIOR STATED THAT ON 09-03-10 HE SAW PIOTROWSKI TAKE ALL THE TOOLS IN QUESTION. GASIOR STATED THAT HE TOLD PIOTROWSKI THAT HE COULD NOT TAKE THE TOOLS HOWEVER PIOTROWSKI TOOK THEM ANYWAY FOR USE IN HIS GARAGE.

THE R/O ADVISED PIOTROWSKI THAT HE WAS UNDER ARREST FOR THEFT. THE R/O TRANSPORTED PIOTROWSKI BACK TO THE BPD FOR PROCESSING.

ON 10-25-10 AT APPROXIMATELY 1100 HOURS, PIOTROWSKI WAS PROCESSED FOR THEFT [REDACTED] AND PLACED INTO CELL 1 TO AWAIT COMPLAINTS AND BOND.

ON 10-25-10 AT APPROXIMATELY 1120 HOURS, BARANOWSKI ENTERED THE BPD AND COMPLETED A VOLUNTARY STATEMENT, WHICH WAS SUBMITTED INTO EVIDENCE.

ON 10-25-10 AT APPROXIMATELY 1230 HOURS, PIOTROWSKI WAS SERVED WITH A (1) COUNT COMPLAINT FOR THEFT AND POSTED \$100.00 CASH BOND ON BAIL BOND BB168082. OFC EICKELMANN 556 RELEASED PIOTROWSKI FROM POLICE CUSTODY.

ON 11-24-2014 AT 1105 HRS. R/O WAS DISPATCHED TO THE LOBBY OF THE PD FOR A THEFT INVESTIGATION. R/O MET WITH COMPANY OWNER BARANOWSKI, IWONA F/W/ [REDACTED] OF "ON AUTO TRANSPORT" 758 INDUSTRIAL DR. [REDACTED] WHO WANTED TO REPORT THAT EX-EMPLOYEE ARMAN, SHADE, B. M/W/ [REDACTED] DID NOT RETURN \$1950 IN CASH, \$1200 IN CHECKS, INVOICES, RECEIPTS, KEYS & MISC. PAPERWORK FROM A TRANSPORT TRIP TO TEXAS AS WELL AS DAMAGED THE WIRING (GPS) OF A COMPANY PICKUP TRUCK. BARANOWSKI STATES ARMAN QUIT BECAUSE HE SAID THE WORK WAS TOO TOUGH AND COMPLAINED ABOUT HER HUSBAND (WHO ALSO WORKS AT THE COMPANY). BARANOWSKI STATES ARMAN IS KEEPING THE ABOVE ITEMS BECAUSE HE WANTS HIS LAST PAYCHECK RIGHT A WAY BUT WAS ADVISED HE'D HAVE TO WAIT UNTIL PAYDAY.
