These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative	<p>ON 10.08.11 AT APPROXIMATELY 0100 HRS RO AND OFC LINKOWSKI 520 RESPONDED TO [REDACTED] FOR THE UNKNOWN DISTURBANCE, TRANSFERRED FROM THE LANGUAGE LINE. RO OBSERVED A LARGE GROUP OF APPROXIMATELY 8-10 MALE SUBJECTS STANDING BOTH BEHIND AND IN FRONT OF A DUMPSTER AT THE NORTHWEST CORNER OF THE PARKING LOT- RO OBSERVED THAT SEVERAL OF THE MALE SUBJECTS' FACES AND CLOTHES WERE STAINED WITH BLOOD. RO OBSERVED THE MALE SUBJECTS HUDDLED AT THE DUMPSTER WERE HUNCHED OVER AND VISIBLY WINDED.</p> <p>RO AND OFC LINKOWSKI 520 IDENTIFIED THE CALLER/ WITNESS #1 [REDACTED] MH [REDACTED]; [REDACTED] STATED MALE WITH NO SHIRT, LATER IDENTIFIED AS PEDRO LLAMAS MH [REDACTED], HAD A GUN, AT WHICH TIME ALL SUBJECTS WERE COMMANDED BY OFFICERS TO KNEEL WITH THEIR HANDS ON THEIR HEADS(OFC NAVARRO 539 AND RUIZ 511 AND SGT HERMES 502 ARRIVED SECONDS LATER). EVERY SUBJECT WAS PATTED DOWN AND THEN RO, OFC LINKOWSKI 520, AND OFC NAVARRO 539 BEGAN INTERVIEWING THE MALES SUBJECTS INDEPENDENTLY. NO FIREARM WAS LOCATED AT THIS TIME. IN THE MEANTIME, SGT HERMES 502 AND OFC RUIZ 511 SEARCHED THE AREA.</p> <p>[REDACTED] STATED HE AND HIS FAMILY AND FRIENDS WERE DRINKING AND TALKING IN THE PARKING LOT OUTSIDE [REDACTED] WHEN 2 MALE SUBJECTS, LLAMAS AND ESTEBAN ARIAS-PEREZ MH [REDACTED], APPROACHED THE GROUP. SGT HERMES 502 SEARCHED THE WEST SIDE OF THE PARKING AREA TO THE REAR OF 1094 W IRVING PARK RD. IN THE GRASSY AREA IMMEDIATELY PARALLEL TO THE PARKING LOT AND DIRECTLY IN FRONT OF A PARKED BLUE DODGE VAN(ILLINOIS REGISTRATION [REDACTED]), SGT HERMES LOCATED A SILVER .380 BERSA THUNDER HANDGUN, SERIAL [REDACTED]. THERE WAS ONE ROUND IN THE CHAMBER WITH NO MAGAZINE IN THE PISTOL; THE PISTOL WAS SHOWN TO THE VICTIMS AT WHICH TIME THEY AFFIRMED IT WAS THE GUN USED BY LLAMAS. OFC LINKOWSKI 520 DISCOVERED A MAGAZINE LOADED WITH TWO ROUNDS(.380 ACP HOLLOW POINT) AND A CELL PHONE BELONGING TO LLAMAS, SIDE BY SIDE ON THE GROUND WITHIN APPROX. TWO FEET OF THE SAME GRASSY LOCATION- LLAMAS IDENTIFIED THE CELL PHONE AS HIS OWN. BOTH THE PISTOL AND ITS MAGAZINE WERE HELD WITH SGT HERMES 502.

ARIAS-PEREZ ADMITTED TO OFC NAVARRO 539 THAT LLAMAS DID PULL OUT AND POINT THE PISTOL AT THE GROUP IN THE PARKING LOT. BOTH LLAMAS AND ARIAS-PEREZ WERE PLACED UNDER ARREST AND TRANSPORTED TO THIS PD FOR PROCESSING BY RO. AT APPROXIMATELY 0230 HRS LLAMAS AND ARIAS-PEREZ WERE PLACED INTO CELLS 3 AND 1 RESPECTIVELY.

BENSENVILLE MEDICS WERE SUMMONED- THE INJURED SUBJECTS WERE EXAMINED AND RELEASED.

AT APPROXIMATELY 0300 HRS LLAMAS WAS MIRANDIZED AND THEN QUESTIONED UNDER AUDIO AND VIDEO RECORDING AFTER BEING ADVISED OF SUCH. LLAMAS ADMITTED TO HAVING THE PISTOL TUCKED INTO THE REAR OF HIS WAISTBAND AND THEN PULLING IT OUT TO POINT AT THE GROUP OF MALES IN THE PARKING LOT. LLAMAS CONTINUED BY SAYING HE BOUGHT THE PISTOL "ABOUT A MONTH AGO FOR \$500" IN THE CITY.

AT APPROXIMATELY 0430 HRS ARIAS-PEREZ WAS MIRANDIZED AND THEN QUESTIONED UNDER AUDIO AND VIDEO RECORDING AFTER BEING ADVISED OF SUCH. ARIAS-PEREZ ONCE AGAIN STATED HE SAW LLAMAS TAKE OUT THE PISTOL AND POINT IT AT THE GROUP.
