These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

ON 5MAY2016 AT APPROXIMATELY 0125 HOURS, R/O RESPONDED TO A VEHICLE ON FIRE BEHIND 605 COUNTRY CLUB DR.

UPON ARRIVAL, R/O LOCATED THE VEHICLE ON FIRE. BENSENVILLE FIRE PROTECTION DISTRICT FIRE FIGHTERS ARRIVED ON SCENE SHORTLY AFTER AND EXTINGUISHED THE VEHICLE.

ASSISTING OFFICER LABUZ AND NAVARRO LOCATED THE VEHICLES BURNT LICENSE PLATE. REGISTRATION PLATE [REDACTED] REGISTERED TO A 2008 WHITE CADILLAC WITH AN OWNER OF ARMANDO J. RODRIGUEZ OF [REDACTED] IN BENSENVILLE IL.

R/O'S MADE CONTACT WITH ARMANDO AT THE AFOREMENTIONED RESIDENCE. R/O'S INQUIRED ABOUT HIS VEHICLES WHEREABOUTS AND ARMANDO STATED THAT HE PARKED HIS VEHICLE IN HIS DRIVEWAY AROUND 2100 HOURS ON 04MAY2016 AND THAT HE WENT INTO HIS RESIDENCE AND WENT TO SLEEP. ARMANDO STATED THAT HE DOES NOT KNOW WHERE THE VEHICLE IS NOW AS IT IS MISSING FROM THE DRIVEWAY. ARMANDO STATED THAT HE IS THE SOLE POSSESSOR OF THE VEHICLES KEYS AND NO ONE ELSE HAS KEYS TO THE VEHICLE. ARMANDO SHOWED R/O'S THE VEHICLE KEY. ARMANDO DID NOT APPEAR CONCERNED ABOUT HIS VEHICLE NOR ITS WHEREABOUTS AND STATED THAT HE DID NOT KNOW WHERE HIS VEHICLE WAS. ARMANDO DID NOT WISH TO REPORT THE VEHICLE STOLEN AND OFFICERS LEFT THE RESIDENCE.

AT APPROXIMATELY 0530 HOURS, ARMANDO ARRIVED TO THE BENSENVILLE POLICE DEPARTMENT LOBBY AND ASKED TO MEET WITH OFC. MIRANDOLA. UPON ARRIVAL, ARMANDO STATED THAT HE DID NOT WANT TO GIVE DETAILS ABOUT HIS VEHICLE BECAUSE HE DID NOT FEEL COMFORTABLE EXPLAINING IT IN FRONT OF HIS WIFE WHO WAS PRESENT IN THE LIVING ROOM OF THE HOUSE WHEN OFFICERS ARRIVED.

ARMANDO WENT ON TO EXPLAIN TO R/O THAT HE HAS A "MISTRESS" BY THE NAME OF SILVIA GALLINDO F/H FROM THE DALLAS, TEXAS AREA WHO OCCASIONALLY VISITS HIM EVERY THREE MONTHS OR SO. ARMANDO THEN EXPLAINED THAT SILVIA IS OFTEN UNSTABLE AND "PSYCHOTIC". ON 04MAY16 ARMANDO HAD MET UP WITH SILVIA AT APPROXIMATELY 1800 HOURS AND WENT TO THE WOODFIELD MALL WITH HER. ON THE WAY BACK, ARMANDO STATED THAT SILVIA DEMANDED HE GIVE HER 3,000 U.S.C. OR SHE WOULD TELL HIS WIFE ABOUT THEIR RELATIONSHIP OR CALL THE COPS AND SAY THAT HE HAD BEATEN HER. ARMANDO REFUSED TO GIVE SILVIA THE MONEY AND AN ARGUMENT ENSUED. ARMANDO PULLED INTO THE McDONALDS PARKING LOT AT 630 RT. 83 IN BENSENVILLE AND EXITED THE VEHICLE AT APPROXIMATELY 2000 HOURS. ARMANDO STATED SILVIA LEFT THE SCENE IN HIS VEHICLE AND ARMANDO WAS PICKED UP BY A FRIEND AND DRIVEN HOME.

ARMANDO ADMITTED TO R/O THAT SILVIA DOES HAVE A SET OF KEYS TO THE VEHICLE AND HE OFTEN LETS HER TAKE THE VEHICLE WHEN SHE IS IN TOWN. IT WAS ALSO STATED THAT SILVIA HAS IN THE PAST GOTTEN UPSET WITH ARMANDO AND LEFT THE VEHICLE ON THE SOUTH SIDE OF CHICAGO FOR ARMANDO TO PICK UP.

SILVIA AND ARMANDO HAVE BEEN HAVING RELATIONS FOR THE PAST FOUR YEARS AND ARMANDO SAID WHEN SILVIA COMES INTO ILLINOIS HE EITHER BUYS HER A HOTEL ROOM OFF OF THORNDALE IN WOOD DALE OR SHE STAYS WITH POSSIBLE FAMILY ON THE SOUTH SIDE OF CHICAGO. ARMANDO STATED THAT HE MET SILVIA WHILE PERFORMING WITH HIS BAND IN DALLAS.

ARMANDO STATED HE WILL SIGN COMPLAINTS IF SILVIA IS LOCATED.

NOTHING FURTHER AT THIS TIME.
