I am pleased to help you with your May 19, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on May 19, 2016. You requested copies of the items indicated below:

"1. Please provide documents showing the end of year total payroll summary, including total covered wages and number of employees. Please provide this information from January 1, 2006 – December 31, 2015. Please provide this separated out by year.

2. Please provide documents showing the annual total costs of workers compensation to your government. This should include the following, but is not limited to:

- *Any settlement payments*
- *Indemnity payments*
- *Administrative costs*
- *Medical payments*
- *Legal fees*
- *Insurance premiums*

3. Please provide documents showing how many workers compensation claims were filed each year against your unit of government from January 1, 2006 – December 31, 2015.

4. Is the unit of government self-insured? If the unit of government has an insurer, please provide documents showing the total amount of premium payments made to the insurance company from January 1, 2006 – December 31, 2015 and separated by year as responsive to the document request made in item #2. Also, does the unit of government have excess insurance? If so, please provide documents showing those payments as well."

After a search of Village files, the following documents are enclosed to fulfill your request:


- 1) Village of Bensenville Total Pay Roll Summary from May 2009 – December 2015. (1 pg.)
