These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **ON 052116 AT APPROXIMATELY 1512 HOURS, R/O RESPONDED TO 501 INDUSTRIAL DRIVE, TRANSPRAPHIC INC, FOR A DELAYED DELIVERY CONTAINER THEFT. UPON ARRIVAL, R/O MET WITH TOMASZ LAPIAK MW [REDACTED] WHO STATED THE FOLLOWING IN SUMMARY:**

**TOMASZ STATED LAST NIGHT, 052116 AT APPROXIMATELY 0255 HOURS, A TRAILER WAS STOLEN FROM THEIR SHARED TRAILER YARD. TOMASZ STATED THAT HIS COMPANY, TRANSPRAPHIC, PARKS THEIR TRAILERS AT A YARD AT THE DEAD END OF INDUSTRIAL, JUST NORTH OF THE BUSINESS. THE YARD IS SHARED WITH TURBO EXPRESS, HYPER FOX INC, AND EVERMORE LIFTING GEAR. A DRIVER OF TOMASZ WAS IN THE YARD AT APPROXIMATELY 0255 WHEN HE STATED TO TOMASZ THAT A TRUCK WITHOUT A TRAILER AND A BLACK SUV WITH A FEMALE DRIVER ENTERED THE YARD. THE DRIVER THOUGHT NOTHING OF IT, BECAUSE ITS COMMON FOR A DRIVER TO HAVE THEIR WIVES PICK THEM UP AFTER A SHIFT. THE SUV AND TRUCK LEFT THE YARD AND SOON AFTER, THE DRIVER LEFT AND CLOSED THE GATE. THE DRIVER SECURED THE GATE WITH A COMBINATION PADLOCK THAT IS SHARED BY ALL 4 COMPANIES.**

**TOMASZ THEN SHOWED R/O A VIDEO THAT SHOWED THE BLACK SUV RETURNING TO THE CLOSED GATE. YOU CAN SEE THE FEMALE SUBJECT EXIT THE VEHICLE AND OPEN THE GATE. THE FEMALE RE-ENTERS THE VEHICLE AND DRIVES AWAY FROM THE LOT. A SHORT TIME LATER, A TRACTOR, DESCRIBED BY TOMASZ AS A 2008/2009 WHITE VOLVO 630 "BOBTAIL". THE TRACTOR HAD NO LETTERS OR MARKINGS. THE TRACTOR ENTERS THE LOT AT 0256 HOURS. AT APPROXIMATELY 0300 HOURS, THE TRACTOR LEAVES WITH THE TRAILER HOOKED ON TO THE BACK.**

**R/O NOTES THAT THE VIDEO IS VERY GRAINY AND HARD TO SEE SPECIFIC MARKINGS/PLATES.**

**TOMASZ DESCRIBES THE TRAILER AS A 2013 UTILITY D400, IL TRAILER PLATE OF [REDACTED]. THE TRAILER HAS THE NUMBER "[REDACTED]" ON THE DRIVERS SIDE BEHIND THE CAB AND VERTICALLY ON THE BACK RIGHT DOOR. THE TRAILER IS WORTH APPROXIMATELY \$20,000.00. TOMASZ STATED THAT THE TRAILER WAS ALSO FULL WITH THE FOLLOWING ITEMS:**

- KURIG COFFEE MAKERS, UNKNOWN AMOUNT**
- JUICES**
- CRATE WITH CONSTRUCTION ITEMS**

**TOMASZ STATED THAT HE WOULD PROVIDE R/O WITH A COMPLETE LIST AND AMOUNT OF ITEMS IN THE TRAILER AS WELL AS A COPY OF THE VIDEO SURVEILLANCE AT A LATER DATE.**

**TOMASZ IS WILLING TO SIGN COMPLAINTS IF AN OFFENDER IS LOCATED.**

**THE TRAILER WAS ENTERED INTO LEADS ON 052116 WITH LEADS NUMBER V16D4738.**
