Re: May 27, 2016 FOIA Request

Dear Mr. McElroy:

I am pleased to help you with your May 27, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on May 27, 2016. You requested copies of the items indicated below:

"Please email a copy of Police Report 16-5019 completed by Officer Valois #562."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16005019.1. (4 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 05/25/2016 at approximately 1815 hours, R/O was dispatched to 1117 N Ellis Street for the report of a delayed theft.

Upon arrival, R/O met with BTX Global Logistics Vice President [REDACTED] and Rhode, Rich MW [REDACTED] who related the following information: On 05/16/2016, a joint partnership with RMCC, LLC was terminated. The three employees had been working at the location for approximately 8-9 years. Executives of BTX Global arrived at the location and the employees had no idea what for. The Executives requested that RMCC, LLC owner/employee Coyne, Richard M/W [REDACTED] come with them to meet off site to handle the termination privately. The two others RMCC, LLC employees were not aware of what was taking place at that time. After the meeting took place, it is believed that Richard then calls his brother and sister who are the two other RMCC, LLC employees and tells them he has been terminated. The two other employees are identified as Coyne, Linda F/W [REDACTED] and Coyne, William M/W (Unknown DOB) [REDACTED]. Linda and William are observed via surveillance cameras packing up various items into boxes. They also gain entry to Richard's office and take several items from inside. [REDACTED] is unable to tell what items were removed that day but it appears to be paperwork that is in binders. [REDACTED] is concerned that customers files and/or financial information were taken. Linda and William had not yet been terminated when they were observed removing the boxes and briefcases. Linda and William also did not return after this incident. [REDACTED] and Rhode advised that they do not believe that this was done maliciously but they are concerned company information could be compromised.

R/O reviewed the video footage and Linda and William are seen loading the boxes and various items into a silver BMW sedan.

[REDACTED] related that he is unsure at this time if complaints will be signed.

The surveillance information was placed onto a CD and placed into evidence.

Nothing further at this time.
