I am pleased to help you with your May 31, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on May 31, 2016. You requested copies of the items indicated below:

"Report # BV16-4595."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16004595.1. (10 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: ON 5/14/16 AT APPROXIMATELY 0530 HOURS, THE R/O OFFICER MELONE #521 RESPONDED TO THE AREA OF BROOKWOOD AND MARSHALL IN REGARDS TO THE REPORT OF A RECKLESS DRIVING VEHICLE DESCRIBED AS AN OLDER MODEL RED CADILLAC WHICH MAY HAVE KNOCKED DOWN MAILBOXES ON BROOKWOOD STREET.

THE R/O LOCATED THREE MAILBOXES THAT HAD BEEN STRUCK. THE GRASS WAS WET DUE TO RECENT RAIN. THE MUDDY TIREMARKS AND THE LAY OF THE MAILBOXES LOCATED INDICATE THAT THE VEHICLE CROSSED ONTO THE GRASS ON THE SOUTH SIDE OF THE STREET EASTBOUND ON BROOKWOOD STREET COMING FROM MARSHALL ROAD. THE FIRST MAILBOX WAS STRUCK WAS ON THE NORTH SIDE OF THE STREET IN FRONT OF [REDACTED]. THE R/O RECEIVED NO ANSWER AT THE DOOR BUT LATER SPOKE WITH THE OWNER JOHN F. KURTZWEIL, M/W, [REDACTED] OVER THE PHONE WHO WAS NOT AWARE OF THE DAMAGE PRIOR TO BEING CONTACTED BY THE R/O. THE NEXT MAILBOX STRUCK WAS AT THE NEIGHBORING HOUSE TO THE EAST AT [REDACTED]. THE R/O SPOKE WITH THE OWNER, PENNY M. MANDZIARA, F/W, [REDACTED] AT THE SCENE WHO HAD POSSIBLY HEARD THE CRASH BUT COULD NOT PROVIDE ANY FURTHER INFORMATION REGARDING IT. THE THIRD DOWNED MAILBOX WAS LOCATED AT [REDACTED]. THE R/O LEFT A MESSAGE WITH OWNER [REDACTED], F/W, [REDACTED] AND LATER SPOKE WITH [REDACTED] WHO ADVISED THAT SHE WAS UNAWARE OF THE DAMAGE UNTIL AFTER BEING CONTACTED BY THE R/O.

AT APPROXIMATELY 0619 HOURS THE R/O WAS DISPATCHED TO 302 W. IRVING PARK ROAD IN REGARDS TO THE REPORT OF A SUBJECT WHO CAME INTO MCDONALDS REQUESTING PARAMEDICS FOR A CUT HAND, BV16004598. THE R/O WAS SOON MET AT THE SCENE BY ASSISTING OFFICER STEPHENS #527. THE R/O ARRIVED TO FIND CARLOS GUZMAN, M/W, [REDACTED] AND GABRIEL OLIVAS, M/W, [REDACTED] HAVING AN ALTERCATION WITH OTHER CUSTOMERS, HUBBERTO GUERRERO, M/W, 3/6/62, AND GABINO IRRRA, M/W, [REDACTED] INSIDE THE RESTAURANT. HUBBERTO AND GABINO WERE SEATED AND CARLOS WAS SHOUTING AT HUBBERTO. ONCE GABRIEL OBSERVED THE R/O HE USHERED CARLOS AWAY FROM HUBBERTO AND GABINO AND ADVISED THAT CARLOS NEEDED PARAMEDICS FOR HIS CUT HAND. CARLOS AND GABRIEL WERE WALKED OUT OF THE RESTAURANT TO AWAIT THE ARRIVAL OF BENSENVILLE MEDICS WHO WERE ALREADY ENROUTE. CARLOS HAD A SEVERE CUT ON HIS LEFT HAND WHICH WAS DRIPPING BLOOD CONTINUOUSLY AND WAS COVERING BOTH HANDS. ASSISTING OFFICER STEPHENS #527 POURED A SALINE SOLUTION OVER CARLOS' HAND AND WRAPPED IT IN A GAUZE WRAPPING PENDING THE ARRIVAL OF BENSENVILLE MEDICS.

THE R/O SPOKE WITH GABRIEL WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: GABRIEL WAS INITIALLY EVASIVE IN ADVISING HOW CARLOS OBTAINED THE CUT. GABRIEL DEFERRED THE QUESTION AWAY TO CARLOS SEVERAL TIMES BUT THEN ADVISED THAT GABRIEL ADVISED THAT HE AND CARLOS ARRIVED AT MCDONALDS TO GET FOOD. WHILE INSIDE MCDONALDS GABRIEL AND CARLOS GOT INTO AN ALTERCATION WITH ANOTHER CUSTOMER, LATER IDENTIFIED AS HUBBERTO GUERRERO, M/W, [REDACTED]. HUBBERTO ATTEMPTED TO TELL CARLOS TO LEAVE AT WHICH TIME OLIVAS "STUCK UP FOR HIS BOY AND BOXED THE GUY" STATING "I'M NOT GONNA LET HIM TALK TO MY BOY LIKE THAT". THOSE STATEMENTS ARE NOT DIRECT QUOTES MADE BY OLIVAS BUT ARE GENERALIZED STATEMENTS CONVEYING WHAT WAS RELAYED TO THE R/O. OLIVAS INITIALLY ADVISED THAT CARLOS HAD OBTAINED THE CUT ON HIS HAND WHILE AT MCDONALDS AND WHILE HAVING THIS ALTERCATION BUT WHEN ASKED WHO HAD A KNIFE, OLIVAS ADVISED THAT THERE WAS NO KNIFE. OLIVAS LATER ADVISED CARLOS TO BE "STRAIGHT WITH OFFICER STEPHENS" AND TO TELL HIM WHAT HAPPENED.

CARLOS GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: GUZMAN HAD INITIALLY ADVISED THAT HE OBTAINED THE CUT IN THE ALTERCATION INSIDE MCDONALDS. WHEN ASKED WHICH SUBJECT INSIDE HAD A KNIFE CARLOS ADVISED THAT THERE WAS NO KNIFE. GUZMAN SOON LATER ADVISED THAT HE HAD OBTAINED THE CUT PRIOR TO ARRIVING AT MCDONALDS IN AN ALTERCATION "OVER THERE" GESTURING TO THE NORTHWEST. THIS IS ALSO THE SAME DIRECTION OF THE MAILBOX INCIDENT REPORTED PRIOR. CARLOS WOULD NOT ELABORATE ON WHERE OR WHAT HAPPENED EARLIER ON CAUSING THE CUT ON HIS HAND. BENSENVILLE MEDICS ARRIVED ON SCENE AND BEGAN TREATING CARLOS AND TRANSPORTED HIM TO ALEXIAN BROTHERS MEDICAL CENTER. A PAT DOWN FOR

WEAPONS WAS PERFORMED ON CARLOS JUST PRIOR TO MEDICS ARRIVING. NO WEAPONS FOUND.

IT WAS APPARENT AN OBVIOUS TO THE R/O AND ASSISTING OFFICER STEPHENS THAT OLIVAS AND GUZMAN WERE HIGHLY INTOXICATED. THERE SPEECH WAS IMPARED AND THE STONG AND OBVIOUS ODOR OF AN ALCOHOLIC BEVERAGE EMINATED FROM THEIR BREATH AS THEY SPOKE. BOTH SUBJECTS EYES WERE RED AND GLASSY.

THE R/O ENTERED INTO MCDONALDS AND SPOKE WITH MANAGER ENRIQUE RAMIREZ, M/W, [REDACTED]. ENRIQUE GESTURED TOWARD A BROWN CADILLAC PARKED ON MASON STREET SOUTH OF THE MCDONALDS ENTRANCE. ENRIQUE ADVISED THAT GABRIEL AND CARLOS ARRIVED IN THE DRIVE THRU LANE AND REQUESTED PARAMEDICS FOR A CUT HAND. ENRIQUE ADVISED THAT HE WOULD DO THIS AND ASKED THEM TO MOVE THE VEHICLE OUT OF THE DRIVE THRU LANE. GABRIEL AND CARLOS REACTED UNHAPPILY AND YELLED AT RAMIREZ. IT IS NOT KNOW WHAT GABRIEL AND OR CARLOS STATED TO ENRIQUE. ENRIQUE ADVISED THAT HE WAS UNAWARE OF THE ALTERCATION BETWEEN CUSTOMERS WITHIN THE STORE. ENRIQUE ADVISED THAT THERE IS CAMERA FOOTAGE BUT A DIFFERENT MANAGER, DENNIS Y CHA, M/U, [REDACTED] WOULD HAVE TO ASSIST THE R/O WITH OBTAINING IT. THE R/O LATER CONTACTED ENRIQUE AGAIN AND ASKED WHICH OF THE TWO SUBJECTS WAS DRIVING THE VEHICLE. ENRIQUE ADVISED THAT GABRIEL WAS DRIVING AND REFERRED TO HIM AS "EL MAS GORDO" BEING THE HEAVIER ONE.

HUBBERTO AND GABINO WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: CARLOS AND GABRIEL INITIALLY HAD AN ALTERCATION WITH ENRIQUE. CARLOS AND GABRIEL HAD COME INTO AND LEFT MCDONALDS COMING FROM AND TO THE CADILLAC DESCRIBED ABOVE AND CLEARLY INTOXICATED AND CAUSING A DISTURBANCE TO HUBBERTO AND GABINO AND OTHER CUSTOMERS. HUBBERTO WAS CONFRONTED BY CARLOS AND GABRIEL. HUBBERTO DID NOT INITIATE ANY CONVERSATION UNTIL AFTER CARLOS AND GABRIEL ASKED "WHAT ARE YOU LOOKING AT" OR SOMETHING SIMILAR. HUBBERTO ADVISED THAT HE ONLY MENTIONED THAT THEY SHOULD MAKE A POLICE REPORT OR SOMETHING REGARDING THE ACCIDENT THEY WERE IN AND THE CONVERSATION ESCALATED QUICKLY FOR NO REASON AND GABRIEL PUSHED HUBBERTO TOWARD THE SOUTHEAST CORNER OF THE RESTAURANT AND BEGAN STRIKING HUBBERTO. CARLOS HAD ALREADY HAD THE CUT ON HIS HAND PRIOR TO ENTERING THE MCDONALDS. THE R/O TOOK A PHOTO OF A RED ABRASION UNDER THE LEFT EYE OF HUBBERTO WHICH WAS LATER PLACED INTO EVIDENCE. HUBBERTO ADVISED THAT HE DID NOT NEED TO SPEAK WITH MEDICS.

THE R/O AGAIN ATTEMPTED TO ASK GABRIEL FOR AN ACCOUNT OF WHAT HAPPENED AND GABRIEL ADVISED THAT HE HAS NOTHING FURTHER TO SAY.

THE R/O INSPECTED THE CADILLAC AND FOUND THE FOLLOWING IN SUMMARY:

- PARKED BETWEEN 2-3 FEET OFF THE CURB WITH DRIVER WINDOW DOWN.
- BLOOD ON THE FRONT PASSENGER SEAT, ON THE INTERIOR PASSENGER DOOR, ON THE FLOOR OUTSIDE THE PASSENGER DOOR, ON THE DOOR HANDLE ON THE OUTSIDE OF THE PASSENGER DOOR, ON THE FLOOR OUTSIDE OF THE DRIVERS DOOR,
- 375 ML BOTTLE OF HENNESSY ALCOHOL, LESS THAN HALF FULL LOCATED ON THE PASSENGER SEAT.
- UNOPENED CAN OF BUDWEISER UNDER THE PASSENGER SEAT.
- DAMAGE TO THE FRONT BUMPER CONSISTENT WITH HAVING STRUCK MORE THAN ONE MAIL BOX.
- DAMAGE TO THE TOP OF THE HOOD CONSISTENT WITH WHAT COULD HAVE BEEN CAUSED WHEN THE MAILBOX WAS STRUCK AND BROKE OVER THE HOOD.
- DAMAGED FRONT PASSENGER HEADLIGHT
- BROKEN WINDSHIELD CONSISTENT WITH WHAT COULD HAVE BEEN CAUSED WHEN THE MAILBOX WAS STRUCK AND BROKE OVER THE HOOD.
- A LARGE AMOUNT OF FRESH GRASS/MUD BEHIND THE FRONT WHEEL WELLS OF THE VEHICLE AND SOME ON THE REAR.
- A MISSING CADILLAC EMBLEM AT THE FRONT OF THE VEHICLE ABOVE THE FRONT GRILL

THE R/O WAS ENROUTE TO THE POLICE DEPARTMENT TO CONTACT THE COMPLAINANT FROM THE ORIGINAL MAILBOX DAMAGE CALL. WHILE ENROUTE THE R/O WAS ADVISED THAT SHE WAS IN THE LOBBY TO SPEAK WITH THE R/O. THE R/O SPOKE WITH VIANEY SALGADO, F/W, [REDACTED], WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: VIANEY CAME TO A STOP ON HILLSIDE DRIVE JUST WEST OF MARSHALL ROAD. VIANEY ADVISED THAT SHE WAS WAITING FOR CO-WORKERS TO ARRIVE WHO WERE GOING TO FOLLOW HER TO WORK. VIANEY ADVISED THAT SHE OBSERVED A BURGUNDY CADILLAC AND SHOWED THE R/O A PHOTO OF THE VEHICLE BEARING ILLINOIS REGISTRATION [REDACTED]. VIANEY ADVISED THIS CADILLAC TRAVELED NORTH ON MARSHALL ROAD BLOWING THROUGH THE STOP SIGN AT HILLSIDE DRIVE AT APPROXIMATELY 70 MPH. THE VEHICLE CONTINUED PAST TWIN OAKS AND HAD TO SLAM ON THE BREAKS DUE TO A VEHICLE BACKING OUT OF A DRIVEWAY SOMEWHERE NEAR GREEN VALLEY STREET. VIANEY WAS WATCHING AND CONCERNED AS SHE BELIEVED THIS VEHICLE COULD ACTUALLY BE ONE OF THE VEHICLES THAT SHE WAS WAITING FOR. THIS SECOND VEHICLE WAS DESCRIBED AS A SILVER OR LIGHT BLUE PASSENGER CAR AND BEGAN TRAVELING SOUTH ON MARSHALL ROAD. THE BURGUNDY CADILLAC TURNED AROUND AND BEGAN TO ACCELERATE AFTER THIS SILVER/BLUE VEHICLE. IT APPEARED THAT THE INCIDENT WAS NOW A ROAD RAGE INCIDENT. THE BURGUNDY CADILLAC BLEW THREW THE STOP SIGN AGAIN AT A HIGH RATE OF SPEED AND CUT OFF AND STOPPED IN FRONT OF THE SILVER/BLUE VEHICLE ON MARSHALL ROAD AT BROOKWOOD STREET. THE BLUE/SILVER VEHICLE BACKED INTO A DRIVEWAY AT [REDACTED]. THE DRIVER OF THE VEHICLE HAD HIS DRIVER WINDOW ROLLED DOWN A SMALL DEGREE AND WAS APPROACHED BY 2 MALE HISPANIC SUBJECTS DETERMINED TO BE GABRIEL AND CARLOS. VIANEY ADVISED THAT GABRIEL WAS DRIVING REFERRING TO HIM AS THE HEAVIER TALLER SUBJECT. VIANEY PROVIDED THE R/O WITH A WRITTEN STATEMENT REGARDING THE ABOVE WHICH WAS LATER PLACED INTO EVIDENCE. VIANEY ALSO PROVIDED THE R/O WITH THE PHOTO TAKEN NEAR BROOKWOOD

AND MARSHALL OF THE OFFENDING VEHICLE WHICH WAS LATER PLACED INTO EVIDENCE.

THE R/O RESPONDED BACK TO THE 1000 BLOCK OF BROOKWOOD. IN THE ROADWAY EAST OF 1015 BROOKWOOD THE R/O LOCATED A CADILLAC EMBLEM AND A FEW SHARDS OF GLASS CONSISTENT WITH THAT OF THE OFFENDING VEHICLE. THESE ITEMS WERE LATER PLACED INTO EVIDENCE.
