Dear Mr. Lagos:

I am pleased to help you with your June 14, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on June 15, 2016. You requested copies of the items indicated below:

"Report #16-5716."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16005716.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 06/13/2016 at approximately 1700 hours, R/O was dispatched to Lako Engineering located at 1024 Fairway Drive for the report of a theft.

Upon arrival, R/O spoke with owner of Lako Engineering, [REDACTED] M/W [REDACTED] who related that on 06/06/2016 he was working and cut his finger badly so an employee of a neighboring business took him to the hospital. He left the front and rear doors open. He returned from the hospital around 2230 hours and locked the doors to the business. On 06/13/2016, he was looking for some blueprints for one of the pieces of machinery he produces and realized that all of his blueprints were taken out of a filing cabinet near the front door. The blueprints are described as assembly drawings and technical sheets. He also noticed that some social security paperwork and an old passport were missing from the same filing cabinet. [REDACTED] related that it is common for him to leave the rear door open. [REDACTED] is unsure who would want to steal from him. [REDACTED] related that the pieces of machinery he builds cost about \$2,200 each. [REDACTED] is concerned that someone stole the blueprints and will begin to build the same pieces and put him out of business.

R/O recognized the address from a call for service on 06/06/2016, reference case number 16-5430. [REDACTED] son in law Walenczewski, Lukasz M/W [REDACTED] had arrived at 1024 Fairway Dr because no one had heard from [REDACTED] for hours which is unlike him. At that time, the business was locked and Walenczewski had a key and opened the door for officers to check the inside. Nothing appeared out of order at the time.

[REDACTED] related there are no surveillance cameras on the premises. [REDACTED] will sign complaints if the offender(s) is located and would like the items returned.

Nothing further at this time.
