Dear Ms. Tellez:

I am pleased to help you with your June 15, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on June 15, 2016. You requested copies of the items indicated below:

*"Police report #16-5445."*

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16005445.1. (8 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

## Report Narrative

On Thursday 06/02/16 I was included in an email that was sent to Lisa Kulze who is one of the counselors at Blackhawk Middle School in reference to an instagram account that was created the previous night making fun of juvenile B.T. in the user name.

The assistant principal Jeff Kersten completed an investigation and learned who were the juveniles involved. According to Kersten juvenile A.W., juvenile A.M. and juvenile K.R. went to the movies on 06/01/16. While at the movies A.W. used A.W.'s phone to create an instagram account [REDACTED]. Juvenile K.R. was the one who had the password to the account. School consequences were issued to A.M. and A.W. due to their involvement in the account. K.R. was not issued consequences because it was determined by Kersten that K.R. was only there but was not directly involved.

On Friday 06/03/16 I was asked to join Perry Finch who is the principal and Kersten in a meeting with the parents of B.T. [REDACTED] and Luis at Blackhawk. During the meeting [REDACTED] and Luis expressed their frustrations about the instagram account that was created and other mean behavior inside and outside of school where B.T. was being targeted. [REDACTED] also mentioned that she met with A.W. and her mother Kelly the night before which resulted in an apology from A.W. and Kelly which the family was appreciative of. [REDACTED] and Luis then requested for me to set up a meeting with B.T. parents since they know each other and [REDACTED] even has B.T.'s mother's phone number. After meeting with the Tellez family I went to A.M.'s residence and met with the father Luis Mendoza. Mendoza was aware of the instagram account that was created and agreed to meet with the [REDACTED] family on Tuesday 06/07/16 at 1000.

On Tuesday 06/07/16 at approximately 1000 hours Luis, [REDACTED], and B.T. arrived at the Bensenville Police Department. I spoke with B.T. first alone. During our conversation I asked B.T. about how she felt about everything. B.T. said B.T. was strong and did not let things like that get to B.T. I asked B.T. to rate Blackhawk from 1-10 with 1 being the worst school ever to 10 being the best. B.T. rated the school an 8. I then asked B.T. was B.T. comfortable with me bringing A.M. into the room to talk which B.T. agreed. During that conversation I learned that the two juveniles were best friends last school year and use to have sleepovers from time to time. The two juveniles began hanging out with other friends and their friendship drifted apart. In September A.M. had a party at A.M. house and invited B.T. and others. During the party some of the party attendees were mean to B.T. even excluding B.T. for certain things they were doing. A.M. said A.M. did not create the account and was not aware the account was being created until A.M. looked over at A.W. and noticed A.W. creating the account from A.W.'s phone. A.M. only created the password for the account which A.M. was unable to remember the exact password at that time. A.M. only remembered the password was related to the user name that was created. A.M. was asked why was B.T. singled out. A.M. said it was not A.M.'s idea and the only thing A.M. could think of was A.W. was on instagram and A.W. may have seen a B.T. picture posted which could have influenced A.W. A.M. apologized to B.T. for the account and B.T. accepted A.M.'s apology. Prior to meeting with both families together I asked the juveniles what would be helpful for me to know or do to prevent something like this from happening to other juveniles. I then suggested speaking with the juveniles by grade level the first day of school next school year about the dangers of social media and consequences if used inappropriately which they both agreed.

At approximately 1115 hours we all met together. During the meeting both parenting styles were challenged by both parents. Prior to the meeting getting very heated I learned from A.M. that the movie theater that the account was created in was AMC in Cicero. Due to the yelling back and forth between the two families and B.T. crying while the parents were arguing I decided to stop the meeting. Mendoza and A.M. left the police department. I then example to Luis and [REDACTED] that since the account was created in Cicero if they wanted to pursue this any further they must contact the Cicero Police Department to further investigate. Luis then asked if I would be able to set a meeting up with A.W. mother since they spoke with the mother already and that meeting won't be like this other meeting was. I told them I would reach out to them but if they deny the meeting I can't force them. Prior to Luis and [REDACTED] leaving the police department they also wanted to document that B.T. clothes selection has been questioned by B.T.'s peers. [REDACTED] also told me that B.T. was called out in the locker room during physical education by A.W. for stuffing B.T.'s bra with tissue. [REDACTED] also added even during softball season the juveniles tell other juveniles they suck and they are not going to win during the game which results in the other juveniles' confidence being very low. 06/08/16 I searched instagram for the account in question and could not locate it.

On 06/08/16 at approximately 0835 hours I spoke with a subject who identified himself as Owen Wallace, A.W. father over the phone. Wallace said he was told by his wife Kelly that A.W. claimed it was A.M. idea to create the instagram account not A.W. The only thing A.W. did was provide A.M. with A.W.'s phone to create the account. Wallace said there were approximately 10 juveniles that went to the movies together and the movie ended between 2200 and 2230 that night. The reason the movies in Cicero was selection was due to A.M.'s mother possibly working there or some type of ties there. Owen also mentioned that the day after the instagram account was created A.W. and Kelly went to the Tellez's residence to apologize to B.T.

At approximately 0945 hours I meet with A.W. and Wallace at their residence. A.W. said the following in summary: A.W. and 7 other juveniles went to the movies. While inside the theater both A.W. and A.M. were talking about creating the instagram account. Both juveniles were attempting to come up with the user name but A.W. was the one that decided the name. A.W. then gave A.M. A.W.'s phone and A.M. created the password assless101. The account had one post on it which was a picture of another juvenile N.B. that A.W. took earlier that day. A.W. also admitted to posting with the caption you want what you can't have. A.W. said A.W. posted that caption due to A.W. knowing B.T. liked N.B. sometime during the school year but did not know if B.T. currently did. A.W. also said besides A.M. only K.R. know the account was being create but K.R. said K.R. did not get involved. After speaking with Wallace and A.W. it was decided another meeting with the Tellez's family would not occur at this time.

Included in the otherwise involved section of this report are the other juveniles that were present at the movie theater.
