Dear Mr. Saltanavicius:

I am pleased to help you with your June 17, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on June 17, 2016. You requested copies of the items indicated below:

"16-5850 & 16-5851."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV16005850.1. (3 pgs.)
- 2) Village of Bensenville Crime Report No. BV16005851.1. (2 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

ON 17JUNE2016, AT APPROXIMATELY 0533 HOURS, R/O WAS DISPATCHED TO 101 SPRUCE (TOMATOW TOW YARD) IN REFERENCE TO A DISTURBANCE.

UPON ARRIVAL, R/O SPOKE WITH TOMATOW TOW TRUCK DRIVERS JAMES A. BAKUTIS, AND JEFFREY S. JOHNSON. THEY BOTH STATED THAT THEY HAVE A CONTRACT WITH A COMPANY FROM PALATINE TO TOW REPOSESSIONS. THEY REPOSESSED A NUMBER OF TRUCK AND TRAILERS FROM A LOCATION IN PALATINE. AS THEY WERE IN THE TOW YARD THEY OBSERVED A VEHICLE BEARING DEALER REGISTRATION [REDACTED] DRIVE INTO THE FENCED IN TOW YARD WITH SIGNS POSTED AND CLEAR STATING "RESTRICTED AREA", AND DO NOT ENTER. THE DRIVER OF THE VEHICLE, [REDACTED] M/W (ALSO OWNER OF THE REPOSESSED TRUCK/TRAILERS) APPEARED IRATE AND BEGAN TO SCREAM AT THE DRIVERS. THEY STATED [REDACTED] LAID ON THE GROUND HINDERING THEM TO LEAVE THE YARD DEMANDING THAT THEY RELEASE THE VEHICLES. JAMES AND JEFFREY STATED THEY WERE IN FEAR THAT THINGS WOULD GET PHYSICAL AND POLICE WERE CALLED.

R/O THEN SPOKE TO [REDACTED] STATED THAT HE WAS UPSET AND WENT TO THE TOW YARD. HE THEN STATED THAT ONCE INSIDE THE AREA MARKED "NO TRESPASSING" THE TOW TRUCK DRIVERS MET HIM AND HE BEGAN TO VERBALLY ARGUE WITH THEM OVER THE TRAILERS. HE CLAIMS THAT HE WAS THEN PHYSICALLY TAKEN OUT OF HIS VEHICLE BY THE TWO AFOREMENTIONED DRIVERS. THE DRIVERS INITIALLY REFUSED TO GIVE [REDACTED] HIS VEHICLE BACK AND AND LOCKED HIM OUT OF THE YARD. IT WAS THEN THAT [REDACTED] LAID ON THE GROUND REFUSING TO LEAVE.

R/O PLACED [REDACTED] INTO CUSTODY FOR TRESPASSING AND DISORDERLY CONDUCT. [REDACTED] ADMITTED TO R/O ON SCENE THAT WHAT HE DID MAY HAVE BEEN WRONG AND AGREED THAT HE SHOULD HAVE TAKEN HIS ISSUES TO THE OUTSTANDING FINANCIAL INSTITUTION HE WAS INDEBTED TOO AND NOT THE TOW TRUCK DRIVERS.

THE VEHICLE WAS DRIVEN BY A TOW TRUCK DRIVER OUT OF THE YARD AND PARKED IN GINA'S HOT DOG STAND PARKING LOT FOR [REDACTED] PICK UP AFTER BEING RELEASED FROM THE BENSENVILLE POLICE DEPARTMENT. THE VEHICLE WAS LOCKED AND [REDACTED] WAS GIVEN THE CAR KEYS.

[REDACTED] WAS THEN TRANSPORTED TO THE BENSENVILLE POLICE DEPARTMENT FOR FURTHER PROCESSING.

AT THE BENSENVILLE POLICE DEPARTMENT, [REDACTED] WAS ISSUED TWO VILLAGE ORDINANCE CITATIONS; TRESPASSING TO PROPERTY, AND DISORDERLY CONDUCT (BE 125041/BE125042). [REDACTED] WAS RELEASED AT APPROXIMATELY 0620 HOURS.

Report Narrative **AT APPROXIMATELY 0730 HOURS, 6/17/16, RO WAS NOTIFIED OF A BURGLARY TO MOTOR VEHICLE REPORT AT 101 N SPRUCE. RO ARRIVED AND MET WITH THE CALLER, [REDACTED] M/W [REDACTED]**

[REDACTED] STATED THAT HE WAS ARRESTED EARLIER IN THE MORNING BY BENSENVILLE POLICE (SEE OFC. MIRANDOLA'S ARREST REPORT 16-5850). [REDACTED] STATED THAT WHEN HE WAS TRESPASSING ON TOMATOW PROPERTY LOOKING FOR HIS REPOSSESSED TRUCK, ONE OF THE TOW TRUCK DRIVERS PULLED HIM OUT OF HIS CAR (A BROWN IN COLOR 2006 NISSAN ALTIMA WITH IL DEALER PLATE [REDACTED]) WHILE AWAITING FOR POLICE TO ARRIVE. THE SAME TOW TRUCK DRIVER THEN MOVED [REDACTED] VEHICLE OUT OF THE LOT AND PARKED THE VEHICLE ON A PUBLIC STREET. [REDACTED] VEHICLE WAS MOVED ONCE AGAIN BY POLICE TO THE SOUTHERN PART OF GINA'S PARKING LOT AT 101 N SPRUCE. THE VEHICLE WAS THEN LOCKED BY POLICE AND THE KEYS WERE GIVEN TO [REDACTED]. [REDACTED] RETURNED TO HIS VEHICLE AFTER BEING PROCESSED AND FOUND HIS VEHICLE STILL LOCKED WITH NO SIGNS OF FORCED ENTRY. ONCE [REDACTED] OPENED THE CENTER CONSOLE OF HIS VEHICLE UNDERNEATH THE RADIO HE CLAIMED THAT \$6500 WAS MISSING. [REDACTED] BELIEVES THAT A TOW TRUCK DRIVER TOOK THE MONEY FROM THE VEHICLE WHEN IT WAS INITIALLY MOVED OFF THE PROPERTY.

[REDACTED] DIDN'T SEEM UPSET THAT MONEY WAS MISSING OUT OF HIS VEHICLE BUT SEEMED MORE UPSET WITH THE ATTITUDE OF THE TOW TRUCK DRIVER. [REDACTED] DESCRIBED THE TOW TRUCK DRIVER AS A OLDER M/W OR M/H WITH VERY SHORT WHITE HAIR.
