These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **On 11/01/15 at approximately 1527 hrs, I, Officer Driscoll #518, was dispatched to [REDACTED] in reference to domestic trouble. Upon arrival, I found complainant, [REDACTED] f/w [REDACTED], outside on the back porch on the phone and yelling at a subject inside the house to get out. As I approached I was met by Alberto T Torres m/w [REDACTED] who was later learned to be the father of two children who reside in the house, and boyfriend/ex-boyfriend of [REDACTED]. Torres immediately approached me and presented an eviction notice that he was given by the landlord on 0831/2015 and advised that he has not moved out since then and has been living there. I advised Torres that he should gather his personal belongings and leave the house as it has been two months since he was served with the eviction notice. Torres advised that he had all of his items packed up already and was going to leave tomorrow. The whole conversation was performed by Torres in a very vulgar, demeaning and disrespectful manner to all those involved, while his two children were both present in the next room over. Torres continued to be belligerent after being asked to refrain from using vulgar language in front of the children and advised that it doesn't matter because their mother cusses in front of them all around and then goes out "hoing" around. After Torres gather three of his baskets/tubs full of clothing I advised Torres to take his belonging downstairs and that he was no longer allowed to remain in the residence. I spoke with [REDACTED] and requested she find Torres' social security card and other personal paperwork. [REDACTED] made an attempt and was not able to locate those belongings. I exited the residence and Torres was walking back up the back of the stairs smoking a cigarette. I advised Torres she was unable to locate those items and again Torres became belligerent. I advised Torres to go downstairs and take his belongings off of the property as he was no longer welcome onto the property. Torres took a laundry basket full of clothes toward the alley when I asked him if he understood that he was not welcome back. He turned around, looked at me, grabbed his cigarette and flung it directly at me. The cigarette bounced short of me and struck my pants leg and boot.**

Torres was subsequently arrested and transported to the Bensenville Police Station where he was processed for Disorderly Conduct and was given an I-Bond on Citation #BE130743 and released at approximately 1604 hrs.

Nothing further at this time.
