I am pleased to help you with your June 16, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on June 16, 2016 and extended on June 23, 2016. You requested copies of the items indicated below:

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Police Reports Responsive to Your Request. (50 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **ON 08-24-09 AT APPROXIMATELY 1622 HOURS, THE R/O WAS DISPATCHED TO [REDACTED] FOR THE NEIGHBORHOOD DISTURBANCE. THE R/O SPOKE WITH ISRAEL ARENAS, M/W [REDACTED], WHO IS THE RESIDENT AT [REDACTED], STATED THAT HE HAS HAD AN ONGOING PROBLEM WITH HIS NEIGHBOR THAT LIVES DIRECTLY BELOW HIM IN APARTMENT #1N.**

ARENAS STATED THAT, ON 08-24-09 AT APPROXIMATELY 1615 HOURS, ARENAS WAS INSIDE HIS APARTMENT AT [REDACTED]. ARENAS WAS WALKING AROUND INSIDE HIS APARTMENT, AND THEN HEARD THE NEIGHBOR THAT LIVES DIRECTLY BELOW HIM IN APARTMENT [REDACTED] START BANGING ON HER CEILING AND CAUSING A DISTURBANCE IN ARENAS APARTMENT. ARENAS STATED THAT, THE FEMALE THAT LIVES IN THAT APARTMENT IN [REDACTED] WAS THEN YELLING AND SWEARING INSIDE HER APARTMENT, WHICH ARENAS COULD HEAR FROM HIS. ARENAS STATED THAT, THIS IS A CONSTANT PROBLEM WITH THE NEIGHBOR AND WOULD LIKE TO SIGN A COMPLAINT AGAINST HER.

THE R/O WENT TO [REDACTED], AND KNEW THE RESIDENT, JENNIFER S. HANSEN, F/W [REDACTED], FROM PREVIOUS CONTACTS IN THE PAST AND CAUSING DISTURBANCES WITH HER NEIGHBORS IN THE APARTMENT BUILDING AT [REDACTED]. THE R/O ALSO KNEW HANSEN TO HAVE AN ACTIVE FAILURE TO APPEAR WARRANT FOR POSSESSION OF CANNABIS, WARRANT NUMBER W09D7341. THE R/O KNOCKED ON THE DOOR TO HANSEN APARTMENT AND ADVISED HANSEN THAT IT WAS THE BENSenville POLICE DEPARTMENT, AND THE R/O NEEDED TO TALK WITH HANSEN ABOUT A DISTURBANCE THAT SHE WAS CAUSING INSIDE THE APARTMENT BUILDING. HANSEN STATED TO THE R/O TO GO AWAY, THAT SHE DID NOTHING WRONG, AND SHE BEGAN SWEARING AT THE R/O. HANSEN THEN CALLED 911 TO REPORT THAT THE POLICE WERE AT HER DOOR TO HER APARTMENT, AND WANTED A SARGENT TO RESPOND TO THE SCENE. OFC. HERRERA #525 AND SGT. ZODROW #508 RESPONDED TO THE SCENE. AFTER ABOUT TWENTY-FIVE MINUTES OF TALKING WITH HANSEN THROUGH HER FRONT DOOR TO HER APARTMENT, AND ADVISING HER TO OPEN THE DOOR TO THE APARTMENT, HANSEN DID COMPLY. HANSEN OPENED THE DOOR TO HER APARTMENT, AND SGT. ZODROW AND OFC. HERRERA ENTERED THE APARTMENT OF [REDACTED]. HANSEN WAS VERY UNCOOPERATIVE AND STATED THAT, SHE DID NOTHING WRONG, AND JUST WANTED TO BE LEFT ALONE. SGT. ZODROW ADVISED HANSEN THAT SHE HAS AN ACTIVE WARRANT AND WAS UNDER ARREST. SGT. ZODROW AND OFC. HERRERA LOCATED ON THE GLASS TABLE INSIDE THE LIVING ROOM, WHERE HANSEN WAS STANDING, A CLEAR PLASTIC SANDWICH BAG, WHICH CONTAINED A GREEN LEAFY SUBSTANCE. THE CLEAR PLASTIC SANDWICH BAG, WITH THE GREEN LEAFY SUBSTANCE WAS IN PLAIN VIEW ON THE GLASS TABLE. THE R/O ENTERED THE APARTMENT, TOOK POSSESSION OF THE GREEN LEAFY SUBSTANCE AND HANSEN WAS PLACED INTO HANDCUFFS BY SGT. ZODROW AND OFC. HERRERA.

THE R/O PLACED HANSEN INTO SQUAD #13 AND HANSEN WAS TRANSPORTED TO THE BENSenville POLICE DEPARTMENT TO BE PROCESSED. WHILE THE R/O AND OFC. HERRERA WERE ATTEMPTING TO PROCESS HANSEN, THE R/O ASKED HANSEN IF SHE WAS GOING TO COOPERATE. HANSEN BEGAN TO BECOME VERY AGGRESSIVE AND STATED SHE WAS NOT GOING TO COOPERATE WITH THE R/O. HANSEN THEN BEGAN TO CLAIM THAT SHE NEEDED HER INHALER, AND THEN FELL ON THE FLOOR, DROOLING ON THE FRONT OF HER SHIRT AND HOLDING HER BREATH. THE R/O ASKED HANSEN TO SIT UP, BUT SHE CONTINUED TO LAY ON THE FLOOR. SGT. ZODROW HAD THE BENSenville MEDICS RESPOND TO THE BENSenville POLICE DEPARTMENT. THE BENSenville MEDICS M-78 RESPONDED TO THE SCENE AND CHECKED ON THE HEALTH OF HANSEN. HANSEN STATED THAT, SHE NEEDED TO GO TO THE HOSPITAL. BENSenville MEDICS M-78 TRANSPORTED HANSEN WHO WAS STILL IN POLICE CUSTODY TO ELMHURST HOSPITAL. THE R/O FOLLOWED THE BENSenville MEDICS TO ELMHURST HOSPITAL. ONCE INSIDE ELMHURST HOSPITAL, HANSEN BEGAN YELLING AGAIN AT THE R/O THAT HE WAS GAY, HAD A SMALL DICK, AND WAS A CHILD MOLESTER AND SHE DID NOT KNOW HOW I COULD HAVE EVER GOTTEN A JOB AS A POLICE OFFICER. HANSEN WAS SCENE BY THE NURSE, AND ASKED WHY SHE WAS TRANSPORTED TO THE HOSPITAL. HANSEN STATED THAT, SHE HAD A WARRANT AND NEEDED \$300 OR SHE WAS GOING TO COUNTY JAIL. THE NURSE ASKED HANSEN IF SHE WANTED TO BE SCENE BY A DOCTOR

FOR ANY MEDICAL ISSUES THAT SHE WAS EXPERIENCING. HANSEN REFUSED MEDICAL TREATMENT BY ANYONE AT ELMHURST HOSPITAL. Report Narrative **ON 10-23-08 AT APPROXIMATELY 1648 HRS, R/O WAS SUMMONED TO THE AREA OF [REDACTED] FOR A REPORT OF A VIOLENT DOMESTIC IN PROGRESS.**

UPON ARRIVAL R/O COULD HEAR LOUD NOISES COMING FROM THE [REDACTED]. R/O KNOCKED ON THE DOOR & WAS MET BY THE OFFENDER (HANSEN, JENNIFER) WHO PARTIALLY OPENED THE DOOR & BECAME UNCOOPERATIVE WITH R/O.

R/O EXPLAINED TO HANSEN WHY THE POLICE WERE THERE & THAT R/O NEEDED TO MAKE SURE EVERYTHING WAS IN ORDER, HANSEN TRIED TO CLOSE THE DOOR ON R/O WITH NEGATIVE RESULTS. ZODROW #508, RESPONDED FOR THE UNKNOWN DISTURBANCE AT [REDACTED] THE R/O WAS UPDATED BY DISPATCH THAT, A FEMALE WHITE, WEARING A BLACK SHIRT AND BLACK PANTS, IS STANDING IN THE MIDDLE OF THE ROADWAY AT THE CORNER OF S. YORK ROAD AND E. BELMONT, AND IS BLEEDING BECAUSE SHE ATTEMPTED TO JUMP OUT THE WINDOW OF HER RESIDENCE.

THE R/O ARRIVED AND LOCATED, AND FOUND A FEMALE WHITE WEARING BLACK SHIRT AND BLACK PANTS AND NO SHOES, LATER IDENTIFIED AS JENNIFER S. HANSEN, FW, [REDACTED], WHO WAS BEING HELD DOWN BY NUMEROUS RESIDENTS IN THE AREA AT THE CORNER OF S. YORK ROAD AND E. BELMONT. THE R/O ASKED THE RESIDENTS TO LET UP HANSEN, AT WHICH TIME THE R/O OBSERVED THAT BOTH OF HANSEN FOREARMS WERE CUT AND BLEEDING AND THAT SHE HAD BLOOD ON HER HANDS. THE R/O OBSERVED HANSEN TO BE VERY UPSET AND CRYING AND TO BE UNDER THE INFLUENCE OF ALCOHOL DUE TO THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE AND POSSIBLY UNDER THE INFLUENCE OF NARCOTICS. HERRERA SUPPLEMENTAL FOR FURTHER INFORMATION.

THE R/O WATCHED HANSEN STAND UP AND THEN WITHOUT ANY REASON FALL OVER, NOT TRYING TO BRACE HERSELF FROM FALLING TO THE GROUND. THE R/O WATCHED AS HANSEN LAID ON THE GROUND WITH HER EYES OPEN, AND TRYING TO HOLD HER BREATH. THE R/O OBSERVED THAT HANSEN WAS ALERT, AND BREATHING WHILE LYING ON THE GROUND.

THE R/O HEARD THE AMBULANCE APPROACHING NORTH BOUND ON S. YORK ROAD, AND OBSERVED HANSEN STOP LYING ON THE GROUND HOLDING HER BREATH, GET TO HER KNEES, AND START SCREAMING OUT FOR THE MEDICS TO HELP HER. THE R/O OBSERVED HANSEN BEGIN TRYING TO GRAB AT THE MEDICS, AND THEY PUSHED HER AWAY DUE TO THE BLOOD ON HER FOREARMS AND HANDS. THE MEDICS GOT HANSEN TO HER FEET, AND THEN SHE BEGAN SCREAMING AT THE R/O SAYING, "I HOPE YOU DIE FOR WHAT YOU DID TO ME, I KNOW YOU KNOW WHAT YOU DID TO ME, YOU FUCKING BASTARD, YOU RAPED ME, AND YOU WILL HAVE TO LIVE WITH THAT FOR THE REST OF YOUR LIFE". THE R/O AND OFC. HERRERA AND THE MEDICS WERE ABLE TO GET HANSEN ONTO THE STRETCHER AND WERE ATTEMPTING TO RESTRAIN HER, WHEN SHE TOOK A SWING WITH A CLOSED FIST, AT THE R/O WHO WAS STANDING ON THE LEFT SIDE OF THE STRETCHER. Report Narrative **ON 9/15/15 AT APPROXIMATELY 1222 HOURS, THE R/O OFFICER MELONE #521 AND ASSISTING OFFICER GILLIGAN #529 RESPONDED TO [REDACTED] IN REGARDS TO AN ASSIST TO MEDICS FOR A PERSON THAT HAD CALLED 911 AFTER FALLING. FD DISPATCH HAD ADVISED THAT THE SUBJECT SOUNDED INTOXICATED AND MAY HAVE PSYCHOLOGICAL ISSUES.**

THE R/O KNOCKED ON THE DOOR AND HEARD A SUBJECT LATER IDENTIFIED AS JENNIFER HANSEN, FW, [REDACTED] FALL ON THE FLOOR IN FRONT OF THE DOORWAY. HANSEN OPENED THE DOOR AND ADVISED THAT SHE HAD JUST FALLEN DUE TO A WET FLOOR FROM HAVING RECENTLY MOPPED. HANSEN ADVISED THAT SHE ORIGINALLY CALLED BECAUSE SHE HAD FALLEN PRIOR TO THE R/O ARRIVAL. HANSEN ADVISED THAT SHE FREQUENTLY FALLS. HANSEN ADVISED THAT SHE WAS UNDER THE INFLUENCE OF ALCOHOL. THE R/O OBSERVED THAT HANSEN WAS HIGHLY INTOXICATED. HANSEN SHOWED THE R/O A MASON JAR CONTAINING CORN ALCOHOL WHICH SHE HAD BEEN DRINKING AND WAS ALMOST EMPTY. BENSENVILLE MEDICS FRIEBURG AND LIBERTO ARRIVED AND ADVISED THAT HANSEN WOULD HAVE TO GO TO THE HOSPITAL DUE TO THE INTOXICATION AND DUE TO HAVING FALLEN. HANSEN ADVISED THAT SHE DID NOT WISH TO GO TO THE HOSPITAL. MEDICS AND THE R/O EXPLAINED THAT IN HANSENS CURRENT STATE SHE WAS UNABLE TO REFUSE TO GO TO THE HOSPITAL.

AFTER A FEW MINUTES HANSEN AGREED TO WALK OUT TO THE COT UNDER HER OWN POWER. HANSEN BEGAN COLLECTING PRESCRIPTION PILL BOTTLES TO BRING TO THE HOSPITAL. MEDICS ADVISED HANSEN THAT THESE WERE NOT NECESSARY. HANSEN INSISTED ON TAKING THE BOTTLES. MEDIC FRIEBURG ASKED HANSEN IF SHE NEEDED A BAG TO HOLD THE 6 PRESCRIPTION PILL BOTTLES WHICH SHE APPEARED TO BE HAVING TROUBLE COLLECTING. FOR NO JUSTIFIED REASON, HANSEN TOOK OFFENSE TO THIS AND PUSHED FRIEBURG WITH ONE HAND TO FRIEBURG'S CHEST. THE R/O TOOK HANSEN BY THE LEFT ARM AND ESCORTED HER OUTSIDE TO THE MEDICS COT. HANSEN WAS PLACED INTO MEDIC AMBULANCE #18 AND SEAT BELTED, MEDICS BEGAN TRANSPORTING TO ALEXIAN BROTHERS MEDICAL CENTER IN ELK GROVE VILLAGE.

WHILE ENROUTE THE R/O WAS ADVISED THAT THE AMBULANCE WAS STOPPED AT GREEN STREET AND YORK ROAD AND THAT HANSEN HAD BITTEN A MEDIC. THE R/O RESPONDED AND MET MEDICS AND OFFICER GILLIGAN WHO ARRIVED PRIOR TO THE R/O. HANSEN WAS PLACED BACK ON HER COT AND INTO MEDICAL HAND AND FOOT RESTRAINTS. HANSEN WAS TRANSPORTED TO ALEXIAN BROTHER HOSPITAL WITH THE R/O FOLLOWING BEHIND.

THE R/O SPOKE WITH MEDIC FRIEBURG AND LIBERTO WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: WHILE ENROUTE, HANSEN REMOVED HER LAP BELT AND STOOD UP MOVING TOWARD THE DOOR OF THE AMBULANCE ATTEMPTING TO LEAVE. FRIEBURG APPROACHED HANSEN FROM BEHIND WRAPPED HIS ARMS AROUND HANSEN TO RESTRAIN HER FROM OPENING THE DOOR OF THE MOVING VEHICLE. FRIEBURG SAT HANSEN BACK DOWN ON THE COT AT WHICH TIME HANSEN BIT FRIEBURG ON THE LEFT ARM. FRIEBURG PULLED AWAY AS HANSEN WAS BITING HIM. HANSEN WAS THEN RESTRAINED BY FRIEBURG AND LIBERTO UNTIL OFFICERS ARRIVED AGAIN. UPON ARRIVAL AT ALEXIAN BROTHERS MEDICAL CENTER HANSEN WAS AGAIN UNCOOPERATIVE WITH HOSPITAL STAFF.

R/O OBSERVED SOME REDNESS AND A SMALL INDENTATION MARK ON FRIEBURG'S LEFT FOREARM.

FRIEBURG ADVISED THAT HE IS WILLING TO SIGN COMPLAINTS.

THE R/O CONTACTED AND SPOKE WITH MEGAN MCGUIRE WITH DUPAGE COUNTY STATES ATTORNEYS FELONY SCREENING AND WAS DENIED FELONY CHARGES FOR AGGRAVATED BATTERY TO A PROTECTED CLASS.

Report Narrative ON 13 JUNE 2016 AT APPROXIMATELY 1720 HOURS, R/O WAS DISPATCHED TO [REDACTED] FOR A CRIMINAL SEXUAL ABUSE (LATER DETERMINED TO BE A BATTERY). THE APARTMENT BUILDING CONSISTS OF FOUR RENTAL UNITS WITH A BASEMENT COMMON AREA THAT HOLDS BOTH LAUNDRY MACHINES AND UNIT STORAGE LOCKERS.

UPON ARRIVAL R/O SPOKE WITH VICTIM COMPLAINANT, JENNIFER S HANSEN (F/W [REDACTED]). HANSEN SHOWED SIGNS OF ALCOHOL CONSUMPTION BUT DID NOT APPEAR INEBRIATED. HANSEN CONFIRMED SHE HAD BEEN DRINKING ALCOHOL THROUGH OUT THE DAY. HANSEN WAS INTERVIEWED AND RELATED THE FOLLOWING IN SUMMARY.

ON 13 JUNE 2016 AT APPROXIMATELY 1200 HOURS, HANSEN WENT TO THE BASEMENT TO DO SOME LAUNDRY. HANSEN WAS DRESSED IN A LOOSE UNTUCKED TEE SHIRT (NO BRASSERIE), PAJAMA TYPE PANTS, AND BOTTOM UNDERGARMENT. WHILE IN THE BASEMENT, HANSEN CAME ACROSS A NEIGHBOR WHO RESIDES IN APARTMENT [REDACTED]. THE NEIGHBOR WAS LATER IDENTIFIED AS OFFENDER, ISRAEL ARENAS (M/W [REDACTED]).

AT ONE POINT ARENAS APPROACHED HANSEN AND STATED "I'M NOT MAD AT YOU". HANSEN EXPLAINED SHE HAD AN ARGUMENT WITH ARENAS THE WEEK PRIOR CONCERNING A PARKING SPACE. AFTER MAKING THE COMMENT, ARENAS ALMOST IMMEDIATELY LEANED IN AND ATTEMPTED TO KISS HANSEN. HANSEN PUSHED ARENAS BACK AND STATED "NO...NO...NO...". HANSEN TURNED THEN ATTEMPTED TO WALK UP THE STAIRWAY TO EXIT THE BASEMENT.

ARENAS FOLLOWED AND GRABBED HANSEN FROM BEHIND PREVENTING HER FROM MOVING UP THE STAIRWAY. ARENAS PROCEEDED TO GRAB AND GROPE HANSEN'S BREASTS WITH BOTH HANDS. HANSEN ATTEMPTED BUT WAS UNABLE TO BREAK AWAY FROM ARENAS. HANSEN WAS PUSHED / FELL FORWARD AND WAS NOW IN A POSITION WHERE BOTH HER HANDS AND FEET WERE ON THE STEPS. ARENAS REMAINED BEHIND HANSEN WITH HIS BODY WEIGHT RESTING ON TOP OF HER. HANSEN TOLD ARENAS TO STOP, STRUGGLED TO BREAK AWAY FROM, AND ATTEMPTED TO "CRAWL" UP THE STAIRS TO GET AWAY FROM ARENAS.

AFTER WHAT HANSEN ESTIMATED AS A MINUTE OR TWO, ARENAS MOVED HIS HAND TOWARDS HANSEN'S WAIST. ARENAS PROCEEDED TO SLIDE HIS HAND UNDERNEATH THE WAISTBAND OF HANSEN'S UNDERPANTS, THEN DOWN TOWARDS HER CROTCH. HANSEN GRABBED ARENAS' HAND / WRIST AND TOLD HIM TO STOP. ARENAS DID NOT IMMEDIATELY STOP UNTIL HANSEN ADVISED HIM THAT SHE WAS MENSTRUATING AND UTILIZING A "KOTEX". AT OR ABOUT THAT TIME, ARENAS REDIRECTED HIS HAND BACK TO HANSEN'S BREAST.

HANSEN CONTINUED STRUGGLE TO GET AWAY FROM ARENAS AND STATED "I NEED TO GET SOME NAILS". AT ABOUT THIS TIME, ARENAS RELEASED HANSEN AND SHE RETURNED TO HER APARTMENT. IT WAS LATER LEARNED HANSEN BROKE INTO HER OWN STORAGE LOCKER AFTER BEING UNABLE TO LOCATE THE KEY AND WAS GOING TO USE NAILS TO REPAIR DAMAGE CAUSED TO THE LOCKER.

R/O ASKED HANSEN IF ARENAS GROPED HER ABOVE OR BENEATH HER CLOTHING (TEE SHIRT). HANSEN BECAME EMOTIONAL AND STATED "LIKE THIS". HANSEN PHYSICALLY DEMONSTRATED ON HERSELF WHILE EXPLAINING ARENAS GRABBED AND GROPED HER BREASTS WITH BOTH HANDS OVER HER TEE-SHIRT. HANSEN EMPHASIZED SHE WAS NOT WEARING A BRASSERIE AT THE TIME.

R/O ASKED HANSEN WHICH HAND OR IF BOTH ARENAS USED TO REACH INSIDE HER PANTS. HANSEN PLACED HER RIGHT HAND BY HER WAIST, SIGNALLED WITH THE SAID HAND, AND STATED "IT WAS THIS HAND". R/O VERBALLY CLARIFIED AND CONFIRMED HANSEN WAS REFERRING TO ARENAS' RIGHT HAND. HANSEN CLARIFIED ARENAS REACHED UNDERNEATH THE WAISTBAND OF BOTH HANSEN'S PAJAMA PANTS AND UNDERWARE. HANSEN WAS ASKED SEVERAL MORE QUESTIONS AND IT WAS DETERMINED THAT ARENAS NEVER MADE CONTACT WITH THE OUTSIDE OR

PENETRATED HANSEN'S VAGINA.

R/O ASKED HANSEN WHY SHE DELAYED NOTIFYING THE POLICE. HANSEN EXPLAINED SHE WAS UPSET AND WAS TIRED OF IT HAPPENING. R/O ASKED HANSEN IF ARENAS HAD INAPPROPRIATELY TOUCHED HER IN THE PAST. HANSEN REPLIED SHE HAD BEEN TOUCHED AND / OR GROPED ARENAS SEVERAL TIMES WITHIN THE PAST TWO TO THREE YEARS TO INCLUDE ARENAS ATTEMPTING TO KISS HANSEN. R/O ASKED HANSEN TO RECALL OR ESTIMATE A NUMBER OF TIMES ARENAS TOUCHED HER INAPPROPRIATELY. HANSEN REPLIED "SEVEN" TIMES. HANSEN EXPLAINED THAT SHE SUSPECTED ARENAS TO BE A "LONELY OLD MAN" AND ALTHOUGH UPSET, JUST TOLERATED PAST ADVANCES.

HANSEN ADDED ARENAS' BEHAVIOR ON TODAY'S DATE WAS "VERY AGGRESSIVE" UNLIKE TIMES IN THE PAST. HANSEN EXPLAINED ARENAS HAD NOT PINNED HER DOWN OR ATTEMPTED TO REACH INSIDE HER PANTS BEFORE. HANSEN EXPLAINED WAS SCARED AND THAT ALTHOUGH ARENAS WAS "AN OLD MAN", HE "WENT TO FAR". HANSEN WANTED TO PURSUE CRIMINAL COMPLAINTS AGAINST ARENAS.

R/O ASKED HANSEN (IN PRIVATE) IF ON TODAY'S DATE OR ON ANY DATE IN THE PAST IF SHE INITIATED AND / OR PARTICIPATED IN ANY WILLFUL / MUTUAL PHYSICAL CONTACT WITH ARENAS. OR IF HANSEN EVER GAVE ARENAS ANY INDICATION THAT WOULD LEAD HIM TO BELIEVE IT WAS OK TO TOUCH HANSEN. HANSEN REPLIED "NO NEVER" TO BOTH.

HANSEN'S HUSBAND, JOHNNIE VAUGHN (M/W [REDACTED]), WAS PRESENT DURING THE LATTER HALF OF THE INTERVIEW. VAUGHN WAS UPSET WITH HANSEN FOR DRINKING ALCOHOL AND GOING DOWN TO THE BASEMENT WHILE ARENAS WAS PRESENT. HANSEN REPORTED A SIMILAR INCIDENT TO VAUGHN IN THE PAST WHICH ALSO OCCURRED WHILE HANSEN HAD BEEN DRINKING. VAUGHN EXPLAINED THAT BOTH HE AND HANSEN HAD KNOWLEDGE OF ALLEGATIONS MADE BY ANOTHER FEMALE NEIGHBOR WHO REPORTED SIMILAR OCCURRENCES WITH ARENAS, BUT ONLY AFTER SHE CONSUMED AND WAS IMPAIRED BY ALCOHOL. THE SAID NEIGHBOR HAS SINCE MOVED.

HANSEN CONFIRMED VAUGHN'S STATEMENT CONCERNING THE NEIGHBOR, BUT IMMEDIATELY ENGAGED VAUGHN IN A HEATED ARGUMENT. HANSEN FELT VAUGHN WAS BLAMING HER FOR WHAT HAPPENED. AS THE COUPLE BEGAN TO YELL, VAUGHN STATED "WHY DIDN'T YOU JUST WALK AWAY?". HANSEN REPLIED "BECAUSE HE WAS HOLDING ME...I COULDN'T". R/O NOTED HANSEN WAS HOLDING HER BREASTS WHILE SHE MADE THE STATEMENT. A FEW MORE WORDS WERE EXCHANGED AND HANSEN EXITED THE APARTMENT.

R/O MADE CONTACT WITH ARENAS AT HIS APARTMENT. R/O AND ARENAS RELOCATED TO THE OUTSIDE PARKING LOT WHERE THE INTERVIEWED COULD BE CONDUCTED AWAY FROM FAMILY. R/O FIRST ASKED IF ARENAS WAS PRESENT IN THE BASEMENT EARLIER IN THE DAY. ARENAS RELATED HE WAS AND ESTIMATED A TIME OF AROUND 1000 HOURS.

BEFORE R/O COULD ASK ANOTHER QUESTION, ARENAS PROCEEDED TO EXPRESS HIS PERSONAL FEELINGS / OPINIONS OF HANSEN. ARENAS RELATED HANSEN DRINKS HEAVILY, COULD NOT BE TRUSTED, AND "LIES". R/O HAD NOT YET MENTIONED HANSEN'S NAME AND INQUIRED WHY ARENAS SUSPECTED THE INTERVIEW HAD ANYTHING TO DO WITH HANSEN. ARENAS EXPLAINED HANSEN WAS IN THE BASEMENT AT THE SAME TIME AS HIM AND ASSUMED IT HAD SOMETHING TO DO WITH HER. ARENAS ADVISED HE WITNESSED HANSEN FORCING HER WAY INTO HER OWN STORAGE LOCKER.

UNSOLICITED, ARENAS WENT ON FOR SEVERAL MORE MINUTES EXPLAINING HOW HANSEN HAS PROBLEMS WITH OTHER TENANTS AND WAS CONSTANTLY CAUSING "TROUBLE" IN THE BUILDING. R/O ATTEMPTED TO REDIRECT THE CONVERSATION BACK TO WHAT OCCURRED THE BASEMENT EARLIER IN THE MORNING. ARENAS CONTINUED OFF TOPIC. ARENAS EXPLAINED A PREVIOUS INCIDENT IN WHICH HE THOUGHT HE SAVED HANSEN FROM A SUICIDE ATTEMPT BY HANGING, BUT CLAIMED TO HAVE FOUND OUT LATER THAT HANSEN PURPOSELY ASPHYXIATED HERSELF FOR SEXUAL GRATIFICATION.

R/O HAD NOT YET EXPLAINED THE NATURE OF THE CALL / CONTACT WITH ARENAS. R/O INTERRUPTED ARENAS AND ASKED WHY HE BELIEVED HE WAS BEING ACCUSED OF A CRIME AND NOT SIMPLY BEING INTERVIEWED AS A WITNESS TO A CRIME. FOR EXAMPLE HANSEN FORCING HER WAY INTO AND CAUSING DAMAGE TO THE STORAGE LOCKER. ARENAS RELATED HE ASSUMED HE WAS BEING ACCUSED OF SOMETHING BEING THAT R/O WAS SPEAKING WITH HIM.

R/O ASKED ARENAS IF HE FELT HE WAS BEING ACCUSED OF WRONG DOING, WHY UP TO THIS POINT HAD HE NOT INQUIRED WHAT ALLEGATIONS WERE BEING MADE AGAINST HIM. ARENAS GAVE R/O A STUNNED LOOK AND FOR THE FIRST TIME INQUIRED WHAT THE ALLEGATIONS WERE. R/O SUGGESTED THE REMAINDER OF THE INTERVIEW TAKE PLACE AT THE POLICE STATION. ARENAS WAS HESITANT BUT ULTIMATELY AGREED. ARENAS WAS TRANSPORTED TO THE BENSENVILLE POLICE STATION AND ESCORTED TO AN INTERVIEW ROOM LOCATED IN BOOKING.

ON 13 JUNE 2016 AT APPROXIMATELY 1840 HOURS, R/O FINISHED READING ARENAS HIS RIGHTS PURSUANT TO THE MIRANDA DECISION. ARENAS ADVISED HE DID NOT WANT TO SIGN THE FORM THE NOTICE WAS READ FROM AND INQUIRED ABOUT A LAWYER. R/O ADVISED ARENAS HE WAS NOT OBLIGATED TO SIGN THE FORM NOR DID HE HAVE TO PROVIDE A STATEMENT. ARENAS STATED HE DID NOT WANT TO SIGN THE FORM OR SPEAK WITH R/O.

ARENAS INQUIRED IF HE COULD GO HOME. R/O EXPLAINED THAT WITHOUT A COUNTER OR REFUTING STATEMENT OF THE CRIMINAL ALLEGATIONS PRESENTED AGAINST HIM, HE WAS NOT FREE TO LEAVE AND UNDER ARREST FOR BATTERY. ARENAS CHANGED HIS MIND AND ADVISED HE WAS NOW WILLING TO ANSWER QUESTIONS.

R/O RE-READ ARENAS HIS RIGHTS PURSUANT TO THE MIRANDA DECISION. ARENAS RELATED HE UNDERSTOOD THE RIGHTS READ TO HIM AND INITIALED / SIGNED THE FORM FROM WHICH THE RIGHTS WERE READ FROM. THE SAID FORM WAS LATER ATTACHED TO THE ORIGINAL ARREST REPORT.

ARENAS IMMEDIATELY REVERTED BACK TO GIVING HIS PERSONAL OPINION OF HANSEN. ARENAS WAS INTERRUPTED AND ASKED WHAT IF ANY INTERACTION HE HAD WITH HANSEN EARLIER IN THE MORNING. ARENAS WAS EXTREMELY BRIEF, UNDETAILED, AND PROVIDED THE FOLLOWING UNCLEAR ACCOUNT IN SUMMARY.

ARENAS RELATED HE CAME ACROSS HANSEN IN THE BASEMENT OF THE BUILDING EARLIER IN THE MORNING BETWEEN 0700 AND 0800 HOURS. ARENAS ALLUDED TO PLACING SOME LAUNDRY IN A MACHINE AND RETURNED TO HIS APARTMENT BECAUSE HE WANTED TO AVOID HANSEN. ARENAS RETURNED TO THE BASEMENT AND CAME ACROSS HANSEN A SECOND TIME. ARENAS RETURNED TO HIS APARTMENT. ARENAS RECALLED HEARING SOME BANGING NOISES COMING FROM THE BASEMENT WHICH HE ASSUMED WAS HANSEN. ALTHOUGH HE WAS ATTEMPTING TO AVOID HANSEN EARLIER, ARENAS WENT TO THE BASEMENT TO INVESTIGATE. ARENAS CAME ACROSS HANSEN A THIRD TIME. HANSEN LEFT THE BASEMENT AFTER ADVISING ARENAS SHE NEEDED TO RETRIEVE SOME NAILS.
