These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

ON 07-01-06 AT APPROXIMATELY 2225 HRS, R/O RESPONDED TO THE AREA OF [REDACTED] FOR A CALL OF ASSISTANCE BY A FELLOW OFFICER. THE INITIAL CALL WAS DOMESTIC TROUBLE INVOLVING A NAKED MALE SUBJECT.

UPON ARRIVAL R/O OBSERVED OFC. MIRANDA #558 & OFC.MANDZIARA #512 STRUGGLING WITH THE ARRESTEE: CRUZ, RUTILO. R/O RECOGNIZED CRUZ FROM A PREVIOUS CALL OF THE SAME NATURE (SEE 06-6285) & KNEW CRUZ HAD A PRIOR HISTORY OF FIGHTING WITH POLICE OFFICERS. R/O TOOK CUSTODY OF THE HANDCUFFED CRUZ & R/O THEN PLACED HIM INTO SQUAD #10.

AT THIS PD R/O PROCESSED CRUZ WHILE OFC. MIRANDA TOOK A STATEMENT FROM THE VICTIM [REDACTED] WHO STATED THE FOLLOWING IN SUMMARY: ON 07-01-06 AT APPROXIMATELY 2242 HRS, [REDACTED] WAS WATCHING TELEVISION WHEN THERE WAS A KNOCK ON THE DOOR OF HER RESIDENCE.

WHEN [REDACTED] OPENED THE DOOR SHE WAS MET BY CRUZ WHO WAS WEARING BLACK SHORTS AROUND HIS KNEES & BEGAN TO MASTURBATE IN FRONT OF HER [REDACTED]. [REDACTED] STATED THAT AT THIS TIME SHE BECAME TERRIFIED AND STATED THAT SHE WAS GOING TO CONTACT THIS PD & THEN CLOSED THE DOOR.

AFTER CRUZ WAS APPREHENDED [REDACTED] APPROACHED OFC. MIRANDA & INFORMED HIM WHAT OCCURED. [REDACTED] AGREED TO COME TO THIS PD WHERE SHE ISSUED A VERBAL STATEMENT & HAD OFC. MIRANDA TRANSLATE & THEN PRINT INTO ENGLISH.

[REDACTED] ALSO STATED THAT ON 06-03-06 AT APPROXIMATELY 2100 HRS IN THE SAME RESIDENCE, CRUZ ENTERED HER RESIDENCE WITHOUT PERMISSION & THEN LAYED DOWN ON THE BED.

[REDACTED] TOLD CRUZ TO LEAVE BECAUSE SHE WAS GOING TO GET THE BUILDING OWNER BUT CRUZ TRIED TO CLOSE THE BEDROOM DOOR BEHIND THEM. [REDACTED] EXITED THE APARTMENT WITH HER TWO CHILDREN AND THEN CONTACTED THE OWNER WHO ARRIVED ON SCENE & REMOVED CRUZ.

THE OWNER OF THE BUILDING TOLD [REDACTED] THAT HE WOULD TELL CRUZ TO STAY AWAY WHICH IS WHY THERE WAS NO REPORT FILED OF THE INCIDENT.

[REDACTED] STATED THAT WHEN SHE OPENED THE DOOR & SAW HIM(CRUZ) SHE BECAME FEARFUL OF HIM BECAUSE SHE RECOGNIZED HIM FROM THE LAST INCIDENT AND WAS FEARFUL OF WHAT HE MIGHT DO.

[REDACTED] COMPLETED THE STATEMENTS WHICH R/O THEN PLACED INTO EVIDENCE.

CRUZ WAS CHARGED WITH THE FOLLOWING:

- 1.PUBLIC INDECENCY
- 2.DISORDERLY CONDUCT
- 3.VIOLATION OF BAIL BOND(CRUZ WAS BONDED OUT ON 06-6285)
- 4.RESISTING A PEACE OFFICER.

ON 07-03-06 AT APPROXIMATELY 0630 HRS CRUZ WAS TRANSPORTED TO DUPAGE COUNTY JAIL FOR A BOND HEARING & WAS PLACED INTO THE CUSTODY OF DUPAGE COUNTY JAIL WITHOUT INCIDENT.
