These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **ON 6/30/16 AT APPROXIMATELY 1329 HOURS THE R/O OFFICER MELONE #521 RESPONDED TO [REDACTED] IN REGARDS TO THE REPORT OF A DOMESTIC BATTERY THAT HAD JUST OCCURRED. THE R/O WAS ASSISTED BY OFFICER STEPHENS #527.**

**THE R/O SPOKE WITH YESENIA FLORES-CHAVEZ, F/W [REDACTED] AND DAUGHTER JUVENILE 1 (BMF), 11YOA WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: JUVENILE 1 PROVIDED TRANSLATION FOR HER MOTHER YESENIA. YESENIA WAS HAVING A VERBAL ARGUMENT WITH HER BOYFRIEND, DEMECIO GUTIERREZ-SOTELO, M/W, [REDACTED], IN THEIR VEHICLE WHILE DRIVING HOME. WHEN DEMECIO AND YESENIA ARRIVED AT [REDACTED] THEY BEGAN TO WALK UP TO THEIR APARTMENT ON THE SECOND LEVEL. DEMECIO GRABBED YESENIA BY THE HAIR AND BEGAN TO PULL HER UP STAIRS TOWARD THEIR APARTMENT. DEMECIO WAS SWEARING AT YESENIA AND ADVISING HE WAS GOING TO BEAT HER UP. JUVENILE 1 WAS INSIDE THE APARTMENT WHEN YESENIA AND DEMECIO ARRIVED INSIDE. DEMECIO AND YESENIA WALKED INTO THE LIVING ROOM WHERE JUVENILE 1 WAS SITTING AND DEMECIO STRUCK YESENIA IN THE RIGHT ARM WITH AN OPEN HAND. YESENIA THEN INSTRUCTED JUVENILE 1 TO CALL THE POLICE. YESENIA AND DEMECIO SEPARATED THEMSELVES UNTIL POLICE ARRIVED. YESENIA WAS PROVIDED WITH A DOMESTIC VIOLENCE INFORMATION AND ASSISTANCE REFERENCE SHEET PRIOR TO THE R/O LEAVING.**

**ALSO PRESENT IN THE APARTMENT WERE JUVENILE 2 AND JUVENILE 3.**

**THE R/O SPOKE WITH DEMECIO WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: DEMECIO AND YESENIA GOT INTO A VERBAL ARGUMENT. DURING THE ARGUMENT, YESENIA CALLED DEMECIO SEVERAL BAD NAMES AND DEMECIO BECAME UPSET, LOST HIS TEMPER AND HIT YESENIA AS SHE HAD DESCRIBED ABOVE. DEMECIO ADVISED THAT HE DID NOT PULL YESENIA'S HAIR AT ANY POINT. DEMECIO ADVISED THAT HE LIVES AT THE APARTMENT ALONG WITH HIS TWO CHILDREN AND TWO CHILDREN OF YESENIA. DEMECIO ADVISED THAT JUVENILE 2 IS A MUTUAL CHILD BETWEEN HIMSELF AND YESENIA.**

**THE R/O OBSERVED NO VISIBLE INJURY ON YESENIA AND YESENIA ADVISED THAT SHE DID NOT WISH TO BE SEEN BY PARAMEDICS.**

**DEMECIO WAS PLACED UNDER ARREST, HANDCUFFED, CHECKED FOR COMFORT/PROPER FIT AND PLACED INTO THE REAR OF SQUAD #309 TO BE TRANSPORTED TO BENSENVILLE POLICE DEPARTMENT FOR PROCESSING. DEMECIO WAS PROCESSED AND ISSUED A TWO COUNT COMPLAINT FOR DOMESTIC BATTERY. DEMECIO WAS PLACED INTO CELL #1 AT 1430 HOURS PENDING TRANSPORT TO DUPAGE COUNTY JAIL. AT 2000 HOURS OFFICER LAPORTE #559 TRANSPORTED DEMECIO TO DUPAGE COUNTY JAIL.**
