These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON JUNE 15, 2016, AT APPROXIMATELY 2016 HOURS R/O WAS DISPATCHED TO BPD LOBBY IN REFERENCE TO A DOMESTIC TROUBLE INCIDENT. R/O SPOKE WITH COMPLAINANT [REDACTED] F/W [REDACTED]. IN SUMMARY [REDACTED] STATED THE FOLLOWING:**

ON JUNE 15, 2016, AT APPROXIMATELY 1930 HOURS [REDACTED] WENT TO HER EX-HUSBANDS(DANIEL W. HAMOUS M/W [REDACTED]) APARTMENT([REDACTED]) TO PICK UP A CELL PHONE SHE HAD LOANED HIM. [REDACTED] AND HER 12 YEAR OLD JUVENILE ENTERED THE APARTMENT WAITED FOR THE CELL PHONE. DANIEL ASKED [REDACTED] TO WAIT A FEW MINUTES WHILE HE DELETED SOME INFORMATION FROM THE PHONE. [REDACTED] FELT THAT DANIEL WAS INTENTIONALLY TAKING A LONG TIME TO GIVE HER THE PHONE AT WHICH TIME [REDACTED] REACHED OVER TO THE KITCHEN COUNTER AND TOOK A CELL PHONE. DANIEL REACHED OVER AT THE SAME TIME AND THEY BOTH STRUGGLED FOR THE PHONE. DURING THE STRUGGLE [REDACTED] WAS PUSHED BACKWARDS AND FELL INTO THE COUCH WHICH CAUSED HER TO FLIP OVER AND HURT HER RIGHT HAND. [REDACTED] FELT THAT DANIEL INTENTIONALLY PUSHED HER AND CAUSED HER TO FLIP OVER THE COUCH. [REDACTED] JUVENILE SON WAS PRESENT DURING THE INTERVIEW WITH [REDACTED] AND JUVENILE AGREED WITH [REDACTED] ACCOUNTS OF THE INCIDENT. MEDICS WERE CALLED TO BPD LOBBY TO CHECK OUT [REDACTED] HAND AND [REDACTED] REFUSED TO BE TRANSPORTED TO HOSPITAL. R/O THEN WENT TO [REDACTED] TO SPEAK WITH DANIEL. IN SUMMARY DANIEL STATED THE FOLLOWING:

ON JUNE 15, 2016, AT APPROXIMATELY 1930 HOURS [REDACTED] HAD CONTACTED DANIEL AND TOLD HIM SHE WANTED THE CELL PHONE SHE HAD GIVEN HIM. DANIEL TOLD [REDACTED] HE WOULD RETURN IT TO HER. WHEN MEAGAN ARRIVED FOR THE PHONE DANIEL ASKED [REDACTED] TO STAY OUTSIDE THE APARTMENT. DANIEL STATED HE ONLY WANTED THEIR JUVENILE SON TO ENTER THE APARTMENT. [REDACTED] DISREGARDED HIS REQUEST TO REMAIN OUTSIDE THE APARTMENT AND ENTERED THE APARTMENT AGAINST DANIEL'S CONSENT. ONCE IN THE APARTMENT DANIEL TOLD [REDACTED] SHE NEEDED TO WAIT A FEW MINUTES BECAUSE HE NEEDED TO DELETE SOME INFORMATION FROM THE PHONE. DANIEL FURTHER STATED THAT [REDACTED] BECAME IMPATIENT AND GRABBED A PHONE FROM THE KITCHEN COUNTER. DANIEL STATED THE PHONE THAT [REDACTED] HAD REACHED FOR WAS THE WRONG PHONE AT WHICH TIME, HE ALSO REACHED FOR IT AND WAS TRYING TO TELL [REDACTED] THAT THAT WAS NOT THE CORRECT CELL PHONE. DANIEL BELIEVED [REDACTED] KNEW SHE HAD TAKEN THE WRONG PHONE AND DID IT ON PURPOSE. DANIEL STATED THEY STRUGGLED FOR PHONE AND [REDACTED] WAS TRYING TO PUSHING HIM OFF AT WHICH TIME SHE FELL BACKWARDS CAUSING HER TO FLIP OVER THE COUCH AS THE AREA WHERE THE STRUGGLE TOOK PLACE WAS A TIGHT SMALL SPACE. DANIEL STATED THAT AT NO TIME HE INTENTIONALLY TRY HURTING [REDACTED] IN ANYWAY. DANIEL BELIEVED [REDACTED] EXAGGERATED WHEN SHE FLIPPED OVER THE COUCH AND WAS UNAWARE SHE HAD INJURED HER HAND. R/O INFORMED DANIEL THAT THEIR JUVENILE SON HAD AGREED WITH [REDACTED] VERSION OF THE INCIDENT. DANIEL STATED THAT HIS SON(THE JUVENILE) WAS INTIMIDATED BY HIS MOTHER AND WAS THE REASON WHY HE AGREED. DANIEL ASKED R/O TO HAVE THE JUVENILE PRESENT WHILE DANIEL GAVE HIS STATEMENTS OF THE INCIDENT. R/O INFORMED DANIEL THAT THE JUVENILE HAD ALREADY LEFT WITH [REDACTED].

R/O DID NOT OBSERVE ANY OTHER INJURIES ON [REDACTED] BODY. R/O ALSO ASKED [REDACTED] IF SHE HAD ANY OTHER INJURIES BESIDES HER HAND THAT WERE CAUSED BY DANIEL AND [REDACTED] STATED SHE WASN'T HURT ANYWHERE ELSE. R/O WAS UNABLE TO DETERMINE AT THIS TIME IF THE INJURY TO [REDACTED] HAND WAS ACCIDENTAL OR INTENTIONAL.

ON JUNE 16, 2016, AT APPROXIMATELY 1640 HOURS R/O CONTACTED VICTIMS ADVOCACY. R/O SPOKE WITH KATHY AND INFORMED HER OF THE INCIDENT. R/O ALSO CONTACTED [REDACTED] AFTER SPEAKING WITH DANIEL AND INFORMED HER THAT DANIEL WAS NOT GOING TO BE ARRESTED AT THIS TIME, AS R/O WAS UNABLE TO DETERMINE IF THE INCIDENT WAS ACCIDENTAL OR INTENTIONAL. NOTHING FURTHER AT THIS TIME.
