Re: June 27, 2016 FOIA Request

Dear Ms. Garcia:

I am pleased to help you with your June 27, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on June 27, 2016. A FOIA response was mailed to you on July 7, 2016 informing you, at the time, the police report was still a pending investigation and was denied. Since then, the report has been completed and is now available for release under the Freedom of Information Act ("FOIA"). You requested copies of the items indicated below:

"16-6234."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16006234.1. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

On 06/26/2016 at approximately 2228 hours, R/O and A/O Linkowski #520 were dispatched to [REDACTED] for the report of a domestic battery that had just occurred.

Upon arrival, R/O located Garcia, Maria Concepcion F/W [REDACTED] seated on the front steps to residence. R/O asked where the offender was and Garcia related that he had ran south bound on Marshall Rd. Garcia described Lara as bare foot, wearing an orange shirt and blue pants. Officer Linkowski #520 checked the surrounding area for Lara with negative results. Garcia then related that approximately 20 minutes prior to calling the Police Department her boyfriend Lara, Ivan M/W [REDACTED] and her had gotten into an argument regarding her discovery of his multiple girlfriends. The two had recently left a friends party in Melrose Park and she was waiting in the car. Garcia heard a phone ringing and located one of Lara's cell phone. Garcia saw messages from a woman named Mickey. Garcia questioned Lara about his multiple phones and who had messaged him. Lara denied the allegation and told Garcia that she was crazy. Garcia brought up the other women again when they arrived at her residence which upset Lara. Garcia had exited the car at which time Lara had pushed Garcia into the driver's side door of his car and then down onto the driveway. Garcia attempted to get up and held onto the driver's door at which time Lara was trying to get into the car. Garcia was unsure if it was intentional or not but her fingers got slammed in the door when he was trying to gain entry to his car. Garcia attempted to stand up at which time Lara ran south bound on Marshall Rd. Lara had left his 2012 Mazda bearing IL Reg [REDACTED] in the driveway. The vehicle is registered to Valdez-Ortiz, Jorge [REDACTED]. Garcia also related that Lara does not have a valid driver's license.

R/O observed a small spot of blood on Garcia's forehead, left elbow and left foot.

Garcia did not want to sign complaints.

At 2350 hours, R/O called Victim's Advocacy, spoke with Sharon and related the above information.

Nothing further at this time.
