These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

ON 27MAY16 AT APPROXIMATELY 0220 HOURS, R/O RECEIVED A COMPLAINT VIA DISPATCH OF A SPEEDING/LOUD MOTORCYCLE RACING UP AND DOWN THE STREETS IN THE AREA OF GROVE AND SOUTH MASON ST.

R/O WAS TRAVELING NORTHBOUND ON MASON ST APPROACHING GROVE AND HEARD A LOUD MUFFLER. R/O TURNED WESTBOUND ONTO GROVE AND OBSERVED A MOTORCYCLE TRAVELING EASTBOUND ON GROVE APPROACHING R/O'S SQUAD CAR. A MOUNTED RADAR UNIT IN SQUAD #302 READ 53MPH AND THE SPEED LIMIT ON GROVE IS 25MPH.

AS THE MOTORCYCLE APPROACHED THE SQUAD CAR, R/O OBSERVED TWO MALE SUBJECTS ON AN ORANGE IN COLOR MOTORCYCLE, THE DRIVER WEARING A WHITE T-SHIRT, HELMET WITH FACE EXPOSED, AND HAD SEMI-CURLY LIGHTER COLORED HAIR STICKING OUT OF THE HELMET ON THE SIDES AND BACK. AT THIS TIME, R/O ENGAGED HIS OVERHEAD EMERGENCY LIGHTS AND MADE A U-TURN ON GROVE AND ATTEMPTED TO FOLLOW THE MOTORCYCLE. THE MOTORCYCLE ATTEMPTED A RIGHT TURN ONTO MASON ST. (NOT MAKING AN ATTEMPT TO SLOW OR STOP AT THE STOP SIGN OF THAT INTERSECTION). THE DRIVER WAS UNABLE TO CONTROL THE MOTORCYCLE NOR MANEUVER IT AT THAT HIGH RATE OF SPEED AND THE DRIVER LOST CONTROL OF THE MOTORCYCLE AND LAYED THE BIKE DOWN. BOTH SUBJECTS FLED THE SCENE ON FOOT LEAVING THE BIKE ON THE GROUND WITH THE ENGINE RUNNING. BOTH SUBJECTS FLED SOUTHBOUND ON MASON. R/O EXITED SQUAD #302 AND CHASED AFTER THE TWO SUBJECTS ON FOOT. BOTH SUBJECTS ENTERED THE SOUTHBOUND SIDE OF [REDACTED] HEADING TO THE REAR OF THE RESIDENCE, R/O FOLLOWED. BOTH SUBJECTS TURNED TO THE WEST SIDE OF THE RESIDENCE ENTERING THE REAR OF THE RESIDENCE. AS R/O ENTERED THE AREA R/O HEARD THE REAR DOOR OF [REDACTED] SLAM SHUT.

OTHER ASSISTING OFFICERS ARRIVED ON SCENE SHORTLY AFTER AND THE RESIDENCE WAS SECURED.

R/O AND OTHER OFFICERS KNOCKED MULTIPLE TIMES ON THE FRONT AND REAR DOORS OF THE RESIDENCE ANNOUNCING "POLICE", NO OCCUPANTS CAME TO THE DOOR. THE RESIDENCE DRIVEWAY HAD TWO VEHICLES PARKED IN THE DRIVEWAY AND TWO VEHICLES PARKED ON THE STREET (ONE DIRECTLY IN FRONT OF THE RESIDENCE AND ONE TO THE NORTH OF THE RESIDENCE). A BLACK AUDI PARKED IN THE DRIVEWAY REGISTERED TO FISCHER OUT OF [REDACTED].

R/O OBSERVED THE MOTORCYCLE TO HAVE NO REGISTRATION PLATE AND IN TURN RAN THE VEHICLES VIN NUMBER (VBKEXP407EM490052) THROUGH DISPATCH. DISPATCH RESPONDED THAT THE BIKE IS ENTERED INTO L.E.A.D.S AS A STOLEN VEHICLE (V15D3052) AND CONFIRMED.

R/O AND ASSISTING OFFICERS; MELONE, HERRERA, JONES AND KOTLEWSKI SECURED THE RESIDENCE AND CONTINUED ATTEMPTS TO MAKE CONTACT WITH OCCUPANTS OF THE RESIDENCE WITH NEGATIVE RESULTS.

THROUGH A CHECK OF THE DEPARTMENT COMPUTER DATABASE OFC. HERRERA FOUND CONTACT INFORMATION FROM RECENT CALLS FOR SERVICE AT THE RESIDENCE. R/O'S ATTEMPTED TO CALL THE GIVEN PHONE NUMBERS OF JUSTIN "JT" TYLER BANARD AND JOSHUA DAVID LUNDE-WENTZ WHO ARE THE KNOWN OCCUPANTS OF THE RESIDENCE WITH NEGATIVE RESULTS. A SUBJECT BY THE NAME OF TIMOTHY WEBSTER WAS PHONED AS WELL. WEBSTER IS KNOWN TO FREQUENT THE RESIDENCE AND A VEHICLE PARKED IN FRONT OF THE RESIDENCE REGISTERED TO DENISE AND KENNETH WEBSTER. OFC. HERRERA WAS ABLE TO PHONE TIMOTHY WEBSTERS MOTHER DENISE WHO STATED THAT HER SON TIMOTHY WAS WITH RESIDENT BANARD EARLIER THAT NIGHT. DENISE AND

KENNETH SHOWED UP ON SCENE SHORTLY AFTER AND ATTEMPTED TO CALL HER SON SEVERAL TIMES WITH NO ANSWER. WHILE DENISE AND KENNETH (FATHER) WERE ON SCENE TIMOTHY WEBSTER EXITED THE CLOSED GARAGE DOOR OF [REDACTED] AT APPROXIMATELY 0445 HOURS WITH HANDS UP AND WEARING ONLY GRAY UNDERWEAR. R/O QUESTIONED TIMOTHY AS TO WHY HE WAS IN THE GARAGE, WHY WAS HE WITHOUT CLOTHING OTHER THEN BOXER STYLE UNDERWEAR AND WHY DID HE NOT COME OUT OF THE GARAGE WITHIN THE PAST FEW HOURS AS POLICE WERE VERBALLY ANNOUNCING THEIR PRESENCE AND KNOCKING ON RESIDENCE DOORS INCLUDING THE GARAGE. TIMOTHY STATED IN SUMMARY, THAT HE WAS TOLD BY JUSTIN WHILE INSIDE THE RESIDENCE TO GO OUTSIDE AND SHUT THE GARAGE OVERHEAD DOOR. TIMOTHY STATED THAT HE DID SO AND THEN FELL ASLEEP INSIDE THE GARAGE ON THE FLOOR. AT THIS TIME, R/O PLACED TIMOTHY INTO CUSTODY AND PLACED HIM INSIDE A MARKED SQUAD CAR AND READ HIM HIS MIRANDA RIGHTS. TIMOTHY AGREED TO SPEAK WITH R/O ON SCENE AND STATED THAT HE WAS NOT ON A MOTORCYCLE THAT NIGHT AND SQUAD CAR VIDEO FOOTAGE WOULD PROVE IT. R/O THEN ASKED IF THE TWO SUBJECTS WHO WERE ON THE AFOREMENTIONED MOTORCYCLE WERE IN THE RESIDENCE AND TIMOTHY NODDED AND STATED THEY PROBABLY WERE.

WEBSTER WAS TRANSPORTED TO THE BENSENVILLE POLICE DEPARTMENT AND FURTHER INTERVIEWED BY DETECTIVE PTAK (SEE SUPPLEMENTAL REPORT).

THE RESIDENCE WAS UNSECURED BY OFFICERS AT APPROXIMATELY 0600 HOURS.

AT THE BENSENVILLE POLICE DEPARTMENT, R/O SPOKE TO TIMOTHYS FATHER WHO STATED HE COULD POSSIBLY GET JOSHUA AND JUSTIN TO COME TO THE BENSENVILLE POLICE DEPARTMENT TO BE INTERVIEWED. KENNETH WEBSTER THEN PICKED UP AND DROPPED OFF JUSTIN AND JOSHUA AT THE BENSENVILLE POLICE DEPARTMENT.

JUSTIN AND JOSHUA WERE PLACED INTO SEPARATE INTERVIEW ROOMS IN THE BOOKING AREA OF THE BENSENVILLE POLICE DEPARTMENT AND WERE INFORMED THAT THE ROOMS WERE AUDIO AND VIDEO RECORDED.

R/O BEGAN FIRST BY READING JUSTIN HIS MIRANDA RIGHTS FROM A PRE-PRINTED FORM, IN WHICH JUSTIN INITIALED, SIGNED AND AGREED TO SPEAK WITH R/O. DURING QUESTIONING, JUSTIN STATED THAT HE AND JOSHUA, MIKE FISCHER, TIMOTHY AND MIKE FISCHERS FRIEND (UNKNOWN WHITE/MALE) WENT OUT DRINKING IN ELMHURST ILLINOIS. WHEN THEY ARRIVED BACK TO HIS RESIDENCE, JUSTIN REMEMBERS TELLING TIMOTHY TO CLOSE THE GARAGE DOOR AS THEY HAVE BEEN VICTIMS OF CRIMINAL DAMAGE TO MOTOR VEHICLE/ PROPERTY RECENTLY. AFTER THAT, JUSTIN STATED THAT HE RETIRED TO HIS ROOM IN THE BASEMENT OF THE RESIDENCE AND "PASSED OUT" AS HE WAS HIGHLY INTOXICATED. JUSTIN STATED THAT HE RECENTLY HAD SHOULDER SURGERY AND COMBINED ALCOHOL WITH PRESCRIPTION MEDICINE AND STATED IT WAS NOT A GOOD IDEA AND THIS IS WHY HE NEVER HEARD POLICE KNOCK OR ANNOUNCE THEIR PRESENCE. JUSTIN STATED THAT HE WAS WAKEN UP BY JOSHUA WHO STATED THAT HE SPOKE WITH TIMOTHYS FATHER AND THAT THE POLICE NEEDED TO SPEAK WITH THEM AND THEN HE WAS PICKED UP BY TIMOTHYS FATHER. ALSO DURING THE INTERVIEW, JUSTIN WAS QUESTIONED ABOUT THE MOTORCYCLE. JUSTIN STATED THAT IT WAS MIKES MOTORCYCLE AND THAT HE DID NOT KNOW WHERE HE GOT THE MOTORCYCLE FROM BUT WAS ASKED IF HE COULD STORE IT IN THEIR GARAGE AS MIKE DID NOT WANT HIS MOTHER TO KNOW ABOUT THE MOTORCYCLE. JUSTIN COULD NOT RECALL IF MIKE ASKED HIM DIRECTLY OR HE HAD A ROOMMATE APPROVE THE STORING OF THE MOTORCYCLE. R/O STEPPED OUT OF THE INTERVIEW ROOM TO QUESTION JOSHUA. JOSHUA ALSO STATED THAT THE MOTORCYCLE COULD NOT RECALL HOW LONG THE MOTORCYCLE HAS BEEN IN THE GARAGE. JOSHUA SAID, "IT COULD HAVE BEEN A MONTH IT COULD HAVE BEEN LONGER, I DON'T KNOW".

R/O READ JOSHUA HIS MIRANDA WARNINGS FROM A PRE-PRINTED FORM AND WAS ADVISED THAT THE ROOM IS VIDEO AND AUDIO RECORDED. JOSHUA INITIALED AND SIGNED THE PRE-PRINTED FORM AND STATED THAT HE UNDERSTOOD HIS RIGHTS AND AGREED TO SPEAK WITH R/O. DURING THE INTERVIEW, JOSHUA STATED THAT HE ARRIVED TO HIS RESIDENCE FROM WORK IN THE LATE EVENING HOURS POSSIBLY 2000 HOURS AND BEGAN CLEANING THE HOME AS HIS GIRLFRIEND WOULD BE VISITING THE NEXT DAY. JOSHUA THEN STATED THAT MIKE AND MIKES FRIEND "TOMMY" ARRIVED AT THE HOUSE AT APPROXIMATELY 2215 HOURS AND FISCHER ARRIVED AT APPROXIMATELY 2145 HOURS. THEY ALL THEN PROCEEDED TO FITZ'S BAR IN ELMHURST AT APPROXIMATELY 2230 HOURS. THEY STAYED AND DRANK ALCOHOLIC BEVERAGES AT FITZ'S UNTIL THE ESTABLISHMENTS "LAST CALL" AT APPROXIMATELY 0100 HOURS. ALL SUBJECTS LEFT IN THE SAME VEHICLE AND STOPPED AT A TACO BELL AND THEN PROCEEDED TO [REDACTED]. ALL SUBJECT ARRIVED TO [REDACTED] AT APPROXIMATELY 0200 HOURS. JOSHUA THEN WENT ON TO EXPLAIN THAT HE WAS HIGHLY INTOXICATED AND WENT TO HIS ROOM UP STAIRS AND FELL ASLEEP. JOSHUA STATED THAT HE DID NOT HEAR POLICE KNOCKING AT THE DOORS. WHEN QUESTIONED ABOUT THE MOTORCYCLE, JOSHUA STATED THAT HE KNEW THE BIKE TO BE MIKE'S. JOSHUA WAS ASKED HOW HE CAME ABOUT ARRIVING TO THE BENSENVILLE POLICE DEPARTMENT AND JOSHUA STATED THAT MIKE WOKE HIM UP AT AN UNKNOWN TIME WHILE POLICE HAD THE RESIDENCE SECURED AND STATED, "I TOOK A BIKE, I CRASHED IT AND THE POLICE HAVE BEEN HERE KNOCKING AND I DON'T KNOW WHAT TO DO." JOSHUA STATED HE WITNESSED MIKE MAKE A PHONE CALL TO HIS FATHER TO EXPLAIN TO HIM THE SAME EVENTS. WHEN R/O ASKED JOSHUA WHY HE DID NOT EXIT THE RESIDENCE ONCE HE HAD WOKEN UP AS POLICE WERE STILL PRESENT OUTSIDE JOSHUA STATED THAT MIKE BLACKMAILED HIM NOT TO COME OUTSIDE AND THAT MIKE WOULD SAY HE DID NOT CRASH THE MOTORCYCLE. WHEN ASKED ABOUT THE PASSENGER OF THE MOTORCYCLE JOSHUA STATED THAT IT WAS MIKES FRIEND WHOM THEY JUST MET THAT NIGHT AND ONLY KNOW HIM AS TOMMY AND THAT HE GOES TO DEPAUL UNIVERSITY IN CHICAGO.

UTILIZING JOSHUA AND JUSTIN'S ASSISTANCE, AND STATEMENTS TO IDENTIFY THE DRIVER AND PASSENGER, R/O WAS ABLE TO POSITIVELY IDENTIFY MICHAEL FISCHER AS THE OPERATOR OF THE MOTORCYCLE, AND THOMAS S. GARLAND JR. AS THE PASSENGER OF THE MOTORCYCLE THROUGH SECRETARY OF STATE IMAGES. R/O ALSO UTILIZED SOCIAL

MEDIA RESOURCES TO FIND OUT THAT THOMAS WAS EMPLOYED AT [REDACTED].

BOTH JOSHUA AND JUSTIN GAVE WRITTEN CONSENT TO SEARCH THE HOME. R/O ALONG WITH OFFICERS HERRERA, JONES AND DUPAGE METROPOLITAN ENFORCEMENT AGENCY AGENTS CLEARED THE HOUSE IN ATTEMPT TO LOCATE MIKE AND "TOMMY". THE RESIDENCE WAS VACANT UPON ARRIVAL AT APPROXIMATELY 0800 HOURS. Report Narrative: On Monday, 05-30-16, Officer Mirandola #557, after speaking with witnesses Timothy Webster, Joshua Lunde - Wentz, and Justin Banard, he was able to identify Thomas GARLAND as the passenger and Michael J. FISCHER and the operator of the stolen Motor Cycle in this incident. See Officer Mirandola's #557 narrative.

On Wednesday, at about 1000 hours, 06-1-16, R/I attempted to locate Thomas S. Garland Jr, at his place of employment [REDACTED]. R/I met with several employees of [REDACTED] all of which claimed GARLAND had no showed up for work. R/I passed on this detective's information to fellow employees to have GARLAND contact this detective.

R/I then Attempted to contact GARLAND at his residence [REDACTED] with negative results.

Attorney DeLuca wished to confer with his client and see if he had anything to offer to midigate charges.

On Thursday, at 1433 hours, 06-02-16, Attorney DeLuca contacted this detective to advise same his client GARLAND wished to speak with police but only if he could be assured lessor charges or no charges. Attorney DeLuca advised his client learned the motorcycle was either stolen by FISCHER or FISCHER knew the motorcycle was stolen on the date he fled from police. R/I advised Attorney DeLuca this detective would confer with the DuPage County States Attorney's Office and get back with him.

On Wednesday, at 1607 hours, 06-08-16, R/I briefed Assistant States Attorney B. Carlson, Felony Screening Unit, DuPage County States Attorney's Office on the status of this investigation and Attorney DeLuca's statement about his client Thomas GARLAND. A.S.A. Carlson opined there was insufficient evidence to charge either suspect, GARLAND or FISCHER wit Possession of Stolen Motor Vehicle or any other felony. A.S.A. Carlson would not be willing to grant any assurances or immunity to GARLAND for any testimony without hearing first what he had to say.

After ringing the doorbell, officers were met by FISCHER's father, also Michael Fischer and advised his son was not at home. Mr. FISCHER did not inquire or ask why the police needed to speak with his son but instead advised he thought his attorney had taken care of the matter. Mr. Fischer further advised his attorney had telephoned and spoke to the police about the matter. R/I inquired if Mr. Fischer's attorney had contacted the Bensenville Police. Mr. Fischer answered, "Yes." R/I then told Mr. Fischer, this detective was not aware of any attorney contacting the Bensenville Police Department repreenting his son.
