I am pleased to help you with your July 20, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on July 21, 2016. You requested copies of the items indicated below:

After a search of Village files, the following documents are enclosed to fulfill your request:

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative ON 06-23-16 AT APPROXIMATELY 2018 HOURS, THE R/O WAS DISPATCHED TO [REDACTED], FOR THE FEMALE SUBJECT ON THE BALCONY WITH A KNIFE. THE R/O WAS ADVISED BY DISPATCH THAT, THE FEMALE WAS JUST SERVED WITH A FIVE DAY EVICTION NOTICE BY THE LANDLORD, AND THE FEMALE SUBJECT THREATENED HIM. THE R/O ARRIVED ON SCENE WITH OFC. SCANLAN #533 AND OFC. KOTLEWSKI #561, AND THE R/O SPOKE WITH ARVYDAS M. DIKINIS, M/W, [REDACTED] AND CONSTANTINE J. THEODOS, M/W, [REDACTED], WHO STATED THAT THEY JUST SERVED A TENANT AT [REDACTED], WITH A FIVE DAY EVICTION NOTICE, AND WHEN THEY EXITED THE BUILDING, SHE WAS STANDING ON HER BALCONY HOLDING A LARGE KITCHEN KNIFE AND SWEARING AND CAUSING A DISTURBANCE.

THE R/O SPOKE WITH CONSTANTINE J. THEODOS, WHO STATED IN SUMMARY THAT, HE IS THE PROPERTY OWNER FOR [REDACTED]. CONSTANTINE HAS NOT GOTTEN HIS RENT THAT IS DUE TO HIM, AND HAS NOT HEARD FROM HIS TENANT, KRISTEN M. EURESTE, F/W, [REDACTED], IN THIRTEEN DAYS. CONSTANTINE HAS BEEN CALLING HER ALMOST EVERYDAY TO FIND OUT WHEN SHE WILL BE PAYING THE RENT THAT IS DUE FOR THE UNIT THAT SHE IS RENTING. CONSTANTINE STATED THAT, HE AND ARVYDAS M. DIKINIS, WHO IS HIS PROPERTY MANAGER, AND VIOLET L. THEODOS, F/W, [REDACTED], WHO IS CONSTANTINE WIFE, CAME TO [REDACTED], TO SERVE KRISTEN WITH A FIVE DAY EVICTION NOTICE. CONSTANTINE STATED THAT, THEY WENT UPSTAIRS TO THE THREE STORY, SIX UNIT APARTMENT BUILDING, TO SERVE THE NOTICE. CONSTANTINE STATED THAT, KNOCKED AND NO ANSWER, KNOWING SHE WAS INSIDE THE APARTMENT, DUE TO HER VEHICLE BEING PARKED IN THE APARTMENT PARKING LOT. CONSTANTINE STATED THAT, KRISTEN CELL PHONE WAS CALLED, AND THROUGH THE DOOR, CONSTANTINE, ARVYDAS, AND VIOLET COULD HEAR THE CELL PHONE RINGING BEHIND THE DOOR. CONSTANTINE STATED THAT, KRISTEN BEGAN SWEARING AND YELLING, AND CAUSING A DISTURBANCE IN THE APARTMENT BUILDING, THROUGH THE APARTMENT DOOR. AFTER A FEW MINUTES OF KRISTEN NOT OPENING THE DOOR, CONSTANTINE, ARVYDAS, AND VIOLET EXITED THE APARTMENT ON THE EAST SIDE BUILDING. CONSTANTINE STATED THAT, WHEN THEY GOT OUTSIDE, KRISTEN WAS STANDING OUTSIDE ON HER BALCONY, YELLING AND SCREAMING, SWEARING, AND HOLDING A LARGE KITCHEN KNIFE.

THE R/O SPOKE WITH ARVYDAS M. DIKINIS, WHO STATED IN SUMMARY THAT, HE IS THE PROPERTY MANAGER, AND WAS ASSISTING CONSTANTINE J. THEODOS, WHO IS THE PROPERTY OWNER FOR [REDACTED], IN SERVING A TENANT AT [REDACTED], WITH A FIVE DAY EVICTION NOTICE. ARVYDAS STATED THAT, THE TENANT, KRISTEN M. EURESTE, HAS NOT PAID HER RENT, AND THEY HAVE NOT HEARD FROM HER IN THIRTEEN DAYS. ARVYDAS STATED THAT, HE AND CONSTANTINE J. THEODOS, AND VIOLET L. THEODOS, WENT UPSTAIRS TO [REDACTED], TO SERVE KRISTEN WITH A FIVE DAY EVICTION NOTICE. ARVYDAS STATED THAT, THEY KNOCKED ON THE DOOR TO THE APARTMENT, BUT NO ANSWER FROM ANYONE INSIDE. ARVYDAS STATED THAT, KRISTEN CELL PHONE WAS CALLED, AND THEY COULD HEAR IT RINGING BEHIND THE DOOR, INSIDE THE APARTMENT. ARVYDAS STATED THAT, KRISTEN BEGAN SWEARING AND YELLING, AND CAUSING A DISTURBANCE IN THE APARTMENT BUILDING, THROUGH THE APARTMENT DOOR. AFTER A FEW MINUTES OF KRISTEN NOT OPENING THE DOOR, ARVYDAS, CONSTANTINE, AND VIOLET EXITED THE APARTMENT ON THE EAST SIDE OF THE BUILDING. ARVYDAS STATED THAT, WHEN THEY GOT OUTSIDE, KRISTEN WAS STANDING OUTSIDE ON HER BALCONY, YELLING AND SCREAMING, SWEARING, AND HOLDING A LARGE, APPROXIMATE TWELVE INCH KITCHEN KNIFE OR POSSIBLY A MACHETE. ARVYDAS STATED THAT, HE WAS IN FEAR OF HIS SAFETY AND THOUGHT KRISTEN WAS GOING TO THROW THE KNIFE DOWN AT WHERE THEY WERE STANDING, SO ALL THAT WERE OUTSIDE, WENT TO THE SIDE OF THE BUILDING ON THE NORTH SIDE, AND THEN CALLED THE POLICE.

OFC. KOTLEWSKI SPOKE WITH VIOLET L. THEODOS, WHO STATED IN SUMMARY THAT, HER AND CONSTANTINE, WHO IS THE PROPERTY OWNER, AND ARVYDAS, WHO IS THE PROPERTY MANAGER, WENT TO [REDACTED], TO SERVE THE TENANT, KRISTEN WITH A FIVE DAY EVICTION NOTICE. KRISTEN BEGAN YELLING AND SWEARING AND CAUSING A DISTURBANCE, AND THEN HER AND CONSTANTINE, ARVYDAS, EXITED THE BUILDING WITH KRISTEN, YELLING AND SWEARING, FROM HER BALCONY AND CAUSING A DISTURBANCE. KRISTEN STATED THAT, SHE NEVER

SAW KRISTEN WITH A KNIFE.

THE R/O, OFC. SCANLAN, AND OFC. KOTLEWSKI, WENT TO [REDACTED], AND THE OBSERVED A FIVE DAY NOTICE PLACED IN BETWEEN THE DOOR KNOB AND THE DOOR FRAME, OUTSIDE THE APARTMENT DOOR. THE R/O KNOCKED AND ANNOUNCED IT WAS THE POLICE AND ASKED FOR KRISTEN. KRISTEN STATED THAT, SHE WAS NOT OPENING THE DOOR, AND THEN THE R/O HEARD A LOUD LOCK, POSSIBLY THE DEAD BOLT TO THE APARTMENT DOOR, LOCK. THE R/O ADVISED KRISTEN TO PLEASE OPEN THE DOOR AND SPEAK WITH THE R/O. DUE TO PREVIOUS EXPERIENCE WITH THIS SUBJECT, KRISTEN ASKED IF IT WAS OFFICER LAPORTE. THE R/O ACKNOWLEDGED THAT IT WAS, AND ASKED KRISTEN TO PLEASE OPEN THE DOOR AND SPEAK WITH THE OFFICERS ABOUT WHAT OCCURRED, AND HER POSSIBLY HAVING A KNIFE. THE R/O ADVISED KRISTEN TO OPEN THE DOOR AND SPEAK WITH OFFICERS, OR IF SHE DID NOT COME TO THE DOOR, THE OFFICER WILL HAVE NO OTHER OPTION THAN TO GET AN ARREST WARRANT FOR HER. KRISTEN STILL WOULD NOT OPEN THE DOOR. THE R/O DUE TO THE LACK OF COOPERATION FROM KRISTEN, EXITED THE APARTMENT BUILDING. WHILE EXITING THE BUILDING ON THE EAST SIDE, THE R/O LOOKED UP TO THE THIRD FLOOR WHERE APARTMENT [REDACTED] IS LOCATED AND STANDING ON THE BALCONY, WAS KRISTEN, WHO THE R/O KNOWS FROM PREVIOUS CONTACTS.

WHILE DOWN IN THE PARKING LOT OF [REDACTED], [REDACTED], M/W, [REDACTED], ARRIVED ON SCENE AND BEGAN MAKING COMMENTS TO CONSTANTINE AND ARVYDAS, ABOUT NOT FIXING THINGS INSIDE THE APARTMENT. THE R/O ADVISED [REDACTED] OF THE INCIDENT AND HOW KRISTEN WAS NOT ONLY CAUSING A DISTURBANCE, BUT ALSO THREATENING PEOPLE WITH A KNIFE. [REDACTED] WAS ASKED TO GO UPSTAIRS, AND ASK KRISTEN TO COME DOWN AND SPEAK WITH THE OFFICERS. [REDACTED] WENT UPSTAIRS, AND AFTER A FEW MINUTES, CAME BACK DOWN AND STATED THAT, KRISTEN WOULD NOT COME DOWN TO TALK WITH THE POLICE. THE R/O ADVISED [REDACTED] TO LET KRISTEN KNOW THAT, THE R/O WOULD BE OBTAINING A WARRANT FOR HER ARREST, FOR ASSAULT, AND DISORDERLY CONDUCT.

ON THE R/O NEXT COURT DATE, THE R/O WILL BE OBTAINING A WARRANT FOR KRISTEN ARREST.
