I am pleased to help you with your August 5, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on August 8, 2016. You requested copies of the items indicated below:

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

ON 18MAY2016 AT APPROXIMATELY 0509 HOURS, R/O WAS DISPATCHED TO [REDACTED] IN REFERENCE TO A BATTERY BETWEEN A SUBJECT AND A TAXI DRIVER. DISPATCH THEN RELAYED THAT A MALE BLACK SUBJECT WAS LAYING IN FRONT OF [REDACTED]

UPON ARRIVAL, R/O LOCATED A YELLOW CAB TAXI OCCUPIED BY DRIVER DANIEL O. OLEGHE M/B HOLDING A BLOODY NAPKIN TO HIS LIP WHO APPEARED CONFUSED AND DISORIENTATED. R/O ASKED DANIEL WHAT HAPPENED AND WHY HIS LIP WAS BLEEDING. DANIEL STATED THAT HE WAS CONFUSED AND NEEDED A MOMENT. DANIEL STILL APPEARED DISORIENTED AND CONFUSED. DANIEL THEN ASKED R/O, "WHY DID HE DO THIS? I DON'T UNDERSTAND? WHY DID HE HIT ME?" R/O ATTEMPTED TO OBTAIN THE DRIVERS INFORMATION AND ASKED DANIEL SEVERAL TIMES WHAT HIS ADDRESS WAS. DANIEL WAS UNABLE TO ANSWER THE QUESTION AND STATED THAT HE WAS STILL DIZZY AND CONFUSED.

WHILE SPEAKING WITH DANIEL, A WHITE MALE SUBJECT, LATER IDENTIFIED AS BRANDON M. TIEDEL, STEPPED OUT OF THE APARTMENT COMPLEX ENTRANCE AND SPOKE WITH ASSISTING OFFICER HERRERA. WHILE BRANDON STOOD OUTSIDE SPEAKING WITH OFFICER HERRERA, R/O ASKED DANIEL AGAIN WHO STRUCK HIM AND DANIEL POINTED TO BRANDON AND SAID, "THAT MAN, I DON'T KNOW HIM." DANIEL WAS HOLDING APPROXIMATELY \$28.00 UNITED STATES CURRENCY (U.S.C.) IN HIS HAND AS R/O SPOKE WITH HIM.

OFFICER HERRERA SPOKE WITH BRANDON AND BRANDON STATED THAT HE AND HIS WIFE [REDACTED] F/W WERE PICKED UP FROM O'HARE AIRPORT VIA A YELLOW CAB TAXI AND DRIVEN BACK TO THEIR RESIDENCE AT [REDACTED] IN BENSENVILLE IL. 60106. UPON ARRIVING TO THE RESIDENCE, BRANDON READ A FARE OF 22.00 U.S.C. ON THE DASH GAUGE. DANIEL (DRIVER) STATED TO BRANDON THAT THERE WAS AN EXTRA FEE FOR DROPPING OFF OCCUPANTS IN A SUBURB FROM O'HARE AIRPORT. DANIEL REQUESTED APPROXIMATELY 50.00 U.S.C. FROM BRANDON FOR FARE. BRANDON HANDED DANIEL THE AFOREMENTIONED 28.00 U.S.C. AND AN ARGUMENT ENSUED. BRANDON REFUSED TO PAY THE EXTRA TAXI FEE. BRANDON STATES THAT DANIEL REFUSED TO LET GO OF HIS BAGGAGE WHILE OUTSIDE OF THE TAXI CAB AS HE REFUSED TO PAY THE FARE IN FULL. BRANDON FURTHER STATED, THAT DANIEL GRABBED HIM BY THE NECK AT ONE POINT, AND THAT IS WHEN BRANDON ADMITTEDLY STRUCK DANIEL IN THE FACE A SINGLE TIME LEAVING DANIEL LAYING IN THE GRASS AND LEFT THE IMMEDIATE AREA AND PHONED FOR POLICE.

OFFICER HERRERA SPOKE TO AN INDEPENDENT WITNESS ON SCENE, WHO STATED THAT SHE WITNESSED BRANDON KICK DANIEL IN THE HEAD WHILE DANIEL WAS ON THE GROUND AFTER THE STRIKE TO THE FACE WITH A CLOSED FIST (ELVIRA LEON-SANTIZO F/W) OFFICER HERRERA ALSO OBTAINED VIDEO FOOTAGE OF A PORTION OF THE EVENT RECORDED BY [REDACTED] ON HER CELLULAR PHONE (SEE OFFICER HERRERA'S SUPPLEMENTAL REPORT FOR FURTHER).

DANIEL WAS TRANSPORTED TO ALEXIAN BROTHERS MEDICAL CENTER EMERGENCY ROOM AND EVALUATED BY DOCTOR GRANT. IT WAS RELAYED TO DETECTIVE LARSEN THAT DANIEL HAD SUFFERED A CLINICAL CONCUSSION, A FRACTURED JAW, AND RECOMMENDED A FOLLOW UP VISIT TO SCHEDULE FACIAL SURGERY.

BRANDON WAS PLACED INTO CUSTODY ON SCENE AND TRANSPORTED TO THE BENSENVILLE POLICE DEPARTMENT WHERE HE WAS FURTHER PROCESSED.

ONE FELONY COUNT OF AGGRAVATED BATTERY-GREAT BODILY HARM WAS APPROVED BY STATES ATTORNEY K.

Report Narrative: Supplement report for Brandon M Tiedel (MW [REDACTED]) arrest for aggravated battery to Daniel O Oleghe (MW [REDACTED]) on 05/18/2016 at approximately 0500 hours.

Reporting Officer Herrera (R/O) interviewed witness Elvira Leon-Santizo (FW [REDACTED]) in Spanish who stated the following in summary. Mrs Leon-Santizo stated that she was awoken by yelling outside her apartment window at about 0500 hours. Mrs Leon-Santizo's window faces west toward Marshall Rd where the incident occurred. Mrs Leon-Santizo said she walked toward the window and observed a male white subject, Brandon, yelling at a male black subject, Daniel. Daniel was observed near the sidewalk holding on to Brandon's luggage. Mrs Leon-Santizo could hear Daniel asking Brandon for the fare money. Daniel was then on the grass still holding on to Brandon's luggage as Brandon attempted to pull the luggage away. Mrs Leon-Santizo then observed Brandon kick Daniel in the face causing him to go unconscious. As Brandon lay unconscious Mrs Leon-Santizo called 911.

[REDACTED] (FW [REDACTED]), Brandon's wife, told R/O that she captured the incident on her cell phone. R/O reviewed the video and then downloaded the video into a disc which was submitted into evidence.
