These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

## Report Narrative

On 08/09/2016 at approximately 1654 hours, R/O was dispatched to [REDACTED] for the report of a possible delayed battery.

Upon arrival, R/O could see a group of juveniles in front of the residence at [REDACTED]. R/O could recognize a few of the juveniles from prior contacts. Juvenile RC began to yell out "FUCK THE POLICE!" Juvenile RC was highly agitated and continued to yell at the other juveniles standing around him. R/O and A/O's Linkowski #520, Kotlewski #561, Caliendo #511, Scanlan #533, and Grieco #565 separated all juveniles at this time.

R/O first spoke with Juvenile RC. RC provided the following statement: RC related that he and his girlfriend Juvenile MT had gotten into an argument about their relationship when Juvenile MT started a physical fight and had scratched him on the throat while outside his residence at [REDACTED]. A/O spoke with Juvenile RC while R/O spoke with Juvenile MT regarding the incident.

Juvenile MT related that sometime in the afternoon hours she was on Argyle Street with her friend Juvenile DF. While standing near the street, her ex-boyfriend RC came out of his apartment at [REDACTED] and began yelling at her. Juvenile RC's friend Juvenile MV was present. Juvenile MT related that Juvenile RC was on "Xan" which is an abbreviation for Xanax. Juvenile MT related that the "Xan" makes Juvenile RC act more crazy and more angry than normal. Juvenile RC is known to have anger problems. Juvenile RC and Juvenile MT began arguing about their relationship status and Facebook when Juvenile RC pushed Juvenile MT to the ground causing her tank top to rip. Juvenile DF attempted to break up the fight by putting Juvenile RC in a choke hold and pulling him off of Juvenile MT. Juveniles MT and DF did not want the fight to continue and left the scene in Juvenile DF's vehicle and decided to go hang out at their friend Juvenile AB's residence at [REDACTED]. Juvenile's RC and MV somehow found out that MT and DF were at Juvenile AB's residence and rode their bikes there. Juvenile RC began yelling at AB for MT being at his house. All parties were out in the front yard of [REDACTED]. Juvenile MT related that no further physical altercations took place while at [REDACTED]. Juvenile MT related that while the fight took place, Juvenile MV did not try to stop Juvenile RC.

Juvenile MT had a large visible abrasion and bruise on her left shoulder and back. Juvenile MT related that the abrasion/bruising was from being pushed to the ground.

While speaking with Juvenile MT, [REDACTED] Vazquez, Nelly F/W [REDACTED] arrived on scene. Juvenile RC was advised he was under arrest for domestic battery, was handcuffed and transported By Officer Kotlewski to the Bensenville Police Department for processing. Vazquez was advised that her son was being arrested. Vazquez told R/O that she wanted her son arrested because he has been very bad and they cannot handle him anymore. Vazquez went to the Bensenville Police Department Lobby. R/O transported Juvenile MT to the Bensenville Police Department until her ride was arranged. R/O immediately made contact with Juvenile MT's mother [REDACTED] F/W [REDACTED] and was advised of the situation. [REDACTED] advised she was en route to pick up Juvenile MT.

Officer's Linkowski, Kotlewski and Grieco were present with Juvenile RC while in booking. At 1737 hours, Juvenile RC was read his miranda rights off of a preprinted form. Juvenile RC initialed and signed the form stating he understood his rights and agreed to speak with officers regarding the incident. Officer Linkowski interviewed Juvenile RC who stated the following: Juvenile RC and MT had been in a relationship for approximately 11 months. Juvenile MT had spent the night at RC's apartment on 08/08/16 and wanted to leave in the morning. Juvenile RC and Juvenile MT got into an argument because

Juvenile MT wanted to buy Xanax and he did not want her to. Juvenile MT left with Juvenile DF around 1030 hours and had left her money at Juvenile RC's residence. Juvenile MT called Juvenile RC and said she needed her money and he related that he had used some which caused a verbal argument over the phone. Juvenile DF drove Juvenile MT back to Juvenile RC's residence at [REDACTED] so Juvenile MT could get her money. Juvenile RC and Juvenile MT were yelling at one another outside when Juvenile MT scratched Juvenile RC's arms at which time Juvenile RC slammed Juvenile MT to the ground. DF attempted to break up the fight and put Juvenile RC in a choke hold. Juvenile RC related that a physical fight between himself and Juvenile MT had occurred twice.

During the course of the interview, Juvenile RC was unclear about where the battery had taken place. Juvenile RC first stated that the battery took place on Hillside Drive. Juvenile RC then stated that it occurred on Argyle Street then changed his mind a third time and stated it took place on Hillside Drive. At any given time that R/O and A/O's were speaking with Juvenile RC, it appeared that Juvenile RC was confused and was under the influence of an unknown narcotic. A/O's in booking advised that when Juvenile RC was asked for his date of birth, he provided a false date of birth.

Juvenile MT was picked up by her mother [REDACTED].

R/O photographed and fingerprinted Juvenile RC. While processing Juvenile RC, he admitted to R/O that he is a "13" gang member. Juvenile RC was charged with two counts of domestic battery and obstructing identification. Juvenile RC's mother told R/O's that she wanted her juvenile son transported to the hospital because she believed he was on drugs. While awaiting transport by the fire department, Juvenile RC told R/O that he had taken Xanax and smoked cigarettes. Juvenile RC told the paramedics he had "two bars of Xanax" that day. Juvenile RC was released from police custody and was transported to Elmhurst Hospital. Juvenile RC's mother, Vazquez followed the ambulance to the hospital.

Photographs of Juvenile MT's injuries at attached to this report and were submitted into evidence.

Nothing further at this time.
