
Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: ON 04-28-16 AT APPROXIMATELY 0530 HOURS, THE R/O WAS DISPATCHED TO [REDACTED] FOR THE REPORT OF A CONSTANT BANGING COMING FROM THE APARTMENT UPSTAIRS, WHICH HAS BEEN AN ONGOING ISSUE. REFERENCE THE FOLLOWING CFS:

THE R/O ARRIVED ON SCENE, ALONG WITH A/O HERRERA 525, AND WAS LET INTO THE BUILDING BY THE COMPLAINANT VANDEVEER, AMANDA F/W [REDACTED] WHOM THE R/O OBSERVED TO BE DISTRAUGHT AND CRYING. VANDEVEER STATED IN SUMMARY THAT, SHE WAS IN A DEEP SLEEP AND WAS WOKEN UP FROM POUNDING ON THE FLOOR FROM THE UPSTAIRS RESIDENT. VANDEVEER THEN STATED IN SUMMARY, THAT OUT OF FRUSTRATION SHE YELLED IN HER APARTMENT, "WHY ARE YOU POUNDING?". VANDEVEER THEN STATED THAT SHE HEARD THE UPSTAIRS RESIDENT, LATER IDENTIFIED AS FORD, ERIC S M/W [REDACTED], COME OUTSIDE, FROM THE BALCONY POSSIBILITY, AND YELL AT HER. VANDEVEER STATED IN SUMMARY THAT FORD STATED, "YOU PUSSY BITCH, COME OUTSIDE AND TALK TO ME. YOU BETTER WATCH YOUR BACK, BECAUSE I AM GOING TO PUT A BULLET IN YOUR HEAD". VANDEVEER WAS ALARMED AND DISTURBED BY THESE STATEMENTS AND WAS IN FEAR FOR HER SAFETY.

THE R/O AND A/O WENT UPSTAIRS TO APARTMENT [REDACTED], ANNOUNCED "BENSENVILLE POLICE" AND BEGAN KNOCKING ON THE DOOR. THE R/O AND A/O CONTINUED KNOCKING ON THE DOOR AND THE R/O HEARD MOVEMENT COMING FROM WITHIN THE APARTMENT. THE R/O CALLED OUT TO MR. FORD TO OPEN THE DOOR. THE R/O THEN HEARD FORD ON THE PHONE STATING THAT SOMEONE WAS BANGING ON HIS DOOR (HE HAD CALLED 911). THE R/O AGAIN FOR THE FOURTH TIME "BENSENVILLE POLICE" AT WHICH TIME FORD OPENED THE DOOR. FORD WAS HOLDING A 2.5 FOOT WHITE POLE IN HIS RIGHT HAND WHEN HE OPENED THE DOOR. THE R/O ORDERED HIM TO DROP THE POLE. FORD COMPLIED AND STATED, " I DID NOT KNOW WHO YOU WERE". THE R/O ASKED FORD WHY HE HAD MADE VERBAL THREATS TO VANDEVEER, BY PUTTING A BULLET IN HER HEAD. FORD STATED IN SUMMARY THAT, SHE KEEPS ELECTROCUTING ME THROUGH THE FLOOR AND YOU WON'T DO ANYTHING ABOUT IT. FORD THEN STATED THAT HE HAD TO PLACE RUBBER MATS AND 2" PLYWOOD THROUGHOUT HIS APARTMENT TO DEFLECT THE HARMFUL VOLTS.

THE R/O THEN ADVISED FORD THAT HE WAS UNDER ARREST FOR DOC-BREACH OF PEACE. THE R/O HANDCUFFED FORD, ENSURING THE DOUBLE LOCK WAS ENGAGED, AND CHECKED FOR TIGHTNESS. PRIOR TO PLACING HIM IN THE REAR SEAT OF SQUAD 305. THE R/O THEN TRANSPORTED FORD TO THE BPD FOR PROCESSING. A/O HERRERA PROVIDED VANDEVEER WITH REPORT NUMBER AND ADVISED HER THAT FORD HAD BEEN ARRESTED FOR DOC.
