These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative: **AT 1538 HOURS, 7/5/16, RO WAS NOTIFIED OF A LOST 3 YEAR OLD CHILD AT THE BP GAS STATION AT 157 S YORK ROAD. RO ALONG WITH OFC LINKOWSKI #520 AND OFC CALIENDO #511 ARRIVED ON SCENE AND LOCATED THE CHILD IN THE CANDY SECTION INSIDE THE GAS STATION.**

**RO SPOKE TO THE CLERK WHO FIRST APPROACHED THE CHILD, JIBI THOMAS F/A [REDACTED]. JIBI SAID THE CHILD WALKED N/B ON YORK AND EMERGED FROM THE FENCE. THE CHILD THEN WALKED INSIDE THE STORE AND TOLD JIBI THAT HIS MOTHER WAS OUTSIDE. JIBI NEVER SAW THE CHILD WITH ANYONE WHO COULD OF BEEN A GUARDIAN SO SHE CALLED THE POLICE. THE MOTHER OF THE CHILD CALLED THE POLICE A FEW MINUTES LATER AND WAS TOLD THAT THE CHILD WAS AT THE BP GAS STATION.**

**THE MOTHER, [REDACTED] F/W [REDACTED], ARRIVED AND SEEMED GENUENLY WORRIED ABOUT HER CHILDS SAFETY. [REDACTED] WAS VERY SHAKEN UP AND CRYING. THE FATHER, BRIAN C NICHOLS M/W [REDACTED], ARRIVED A FEW MINUTES AFTER THE MOTHER AND WAS IN THE SAME STATE AS [REDACTED]. [REDACTED] AND BRIAN WERE QUESTIONED ON HOW THEIR CHILD COULD OF LEFT THE HOUSE BY RO AND OFC LINKOWSKI.**

**[REDACTED] STATED THAT SHE BELIEVES THEIR CHILD HAS ADHD AND SAID HE KNOWS HOW TO OPEN THEIR MAIN DOORS, INCLUDING DOOR KNOBS WITH CHILD TAMPER DEVICES INSTALLED. AFTER [REDACTED] AND BRIAN LEARNED THEIR THAT THEIR CHILD COULD OPEN DOORS THEY INSTALLED A TYPE OF HOOK ON THE TOP OF THEIR DOOR WHICH WAS INACCESSABLE TO THE CHILD AND PREVENTED HIM FROM OPENING THE DOORS. RECENTLY [REDACTED] AND BRIAN HAD A FLOOD AT THEIR HOUSE AT [REDACTED] AND THE BUILDING INSPECTOR CAME TO THE HOUSE AND NOTICED THAT THEIR WERE A SERIES OF HOOKS AT THE TOP OF THE DOORWAY. THE BUILDING INSPECTOR MADE [REDACTED] AND BRIAN REMOVE THE HOOKS STATING THAT IT WAS A FIRE HAZARD SO THEY REMOVED THE HOOKS. PRIOR TO THE CHILD LEAVING THE HOUSE, [REDACTED] SAID SHE WAS AT HOME WATCHING TV AND THAT SHE LAST SAW THE CHILD LAYING IN BED ASLEEP. BRIAN STATED THAT HE WORKS CONSTRUCTION AND HIS CURRENT JOB HAS HIM WORKING A NIGHT SHIFT SO HE SLEEPS DURING THE DAY AND AFTERNOON. ONCE [REDACTED] SAW THAT HER CHILD WAS MISSING SHE WOKE BRIAN AND CALLED THE POLICE. [REDACTED] STATED THEIR HOUSE DOESN'T HAVE DEADBOLT LOCKS INSTALLED AND ONLY HAS THE DOOR HANDLE LOCK WHICH THE CHILD HAS LEARNED TO OPEN.**

**THE HOUSE THE CHILD LIVES ON THE WEST SIDE OF S. YORK ROAD NEAR THE CORNER OF WOOD/YORK. THE CHILD WAS ABLE TO CROSS YORK ROAD AND PROCEEDED TO WALK ABOUT A BLOCK NORTH TO THE CORNER OF YORK/GREEN. THE CHILD WAS WEARING CLEAN CLOTHES/DIAPER AND RO OBSERVED NO BRUISES OR MARKS WHICH RAISED ANY CONCERNS.**

**AT 1900 HOURS, RO NOTIFIED GAIL SNIDER WITH DCFS OF THE INCIDENT. DCFS INTAKE # 1323732.**
