Dear Ms. Bermudez:

I am pleased to help you with your August 24, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on August 24, 2016. You requested copies of the items indicated below:

"Records requested would be report #16-8474."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV16008474.1. (4 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 082216 AT APPROXIMATELY 1745 HRS RO AND OFCS LINKOWSKI 520, LAPORTE 559, CALIENDO 511, VALOIS 562, JONES 512, AND GRIECO 565 RESPONDED TO [REDACTED] FOR THE REPORT OF AGGRAVATED ASSAULT WITH A KNIFE. RO SPOKE WITH ALL PARTIES TO LEARN THE FOLLOWING; CALLER [REDACTED] FW [REDACTED] WAS STANDING ON THE SIDE WAY NEAR THE INTERSECTION OF MEMORIAL AT YORK:**

[REDACTED] STATED SHE CAME TO [REDACTED] TO VISIT HER ELDERLY MOTHER MARIA JIMENEZ FW [REDACTED]- HER STEP BROTHER RAUL BERMUDEZ MW [REDACTED] WAS ALSO INSIDE UNIT [REDACTED] VISITING MOTHER MARIA. RAUL BECAME ANGRY WITH [REDACTED] OVER AN OLD ARGUMENT AND GRABBED A KNIFE FROM A KITCHEN DRAWER. [REDACTED] STATED RAUL CORNERED HER WITH THE KNIFE ABOVE HIS HEAD WHILE THREATENING MURDER. MARIA GRABBED RAUL FROM BEHIND AT WHICH TIME [REDACTED], TERRIFIED, FLED UNIT [REDACTED] TO THE STREET.

RAUL WAS STANDING ON MEMORIAL CLOSER TO THE BUILDING- RAUL STATED HE WAS IN THE HALLWAY ABOUT TO ENTER UNIT [REDACTED]; HE OPENED THE DOOR TO OBSERVE [REDACTED] INSIDE AT WHICH TIME SHE BEGAN THE ARGUMENT. AT SOME POINT AFTER RAUL ENTERED UNIT [REDACTED] GRABBED A KNIFE. RAUL THEN LEFT AND EXITED THE BUILDING.

MARIA WAS SEATED ON A SOFA INSIDE UNIT [REDACTED]- MARIA STATED BOTH [REDACTED] AND RAUL WERE INSIDE UNIT [REDACTED] WITH HER. AN ARGUMENT ERUPTED BETWEEN [REDACTED] AND RAUL AT WHICH TIME RAUL GRABBED THE KNIFE FROM THE KITCHEN DRAWER AND HELD IT HIGH TOWARD [REDACTED] CAUSING HER TO FLEE UNIT 423.

OFCS LAPORTE 559 AND GRIECO 565 RECOVERED THE KNIFE MARIA POINTED TO IN THE APARTMENT AS THE ONE BRANDISHED BY RAUL- IT WAS PLACED INTO EVIDENCE BY RO.

RAUL WAS PLACED UNDER ARREST FOR AGGRAVATED ASSAULT AND TRANSPORTED TO THIS PD BY OFC LINKOWSKI 520. AT APPROXIMATELY 1830 HRS RAUL WAS PLACED INTO CELL 1.

RO PREPARED A 1 COUNT MISDEMEANOR COMPLAINT FOR AGGRAVATED ASSAULT ON FORM 13201623568004.

AT APPROXIMATELY 2145 HRS RAUL WAS REMOVED BY CELL 1, FINGERPRINTED & PHOTOGRAPHED, ISSUED AN IBOND ON BB363016, AND RELEASED FROM THIS PD BY RO.
