These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 8/25/16 AT 0151 HOURS, R/O ALONG WITH OFC HERRERA #525, OFC CHA #531, AND OFC MIRANDOLA #557 WERE DISPATCHED TO [REDACTED] FOR A SUSPICIOUS PERSON. THE CALLER ADVISED THAT SHE LIVED IN THE APARTMENT ABOVE THE HODGE PUDGE LODGE BAR AND A MALE HISPANIC WEARING A WHITE SHIRT WAS KNOCKING ON HER DOOR. THE CALLER STATED HER BOYFRIEND WAS ATTEMPTING TO GET HIM IN A CAR TO DRIVE HIM HOME.**

R/O ARRIVED AT [REDACTED] AND MET WITH [REDACTED] (M/H [REDACTED]) APPEARED TO HAVE A CUT ON HIS LEFT EAR, ALONG WITH A CUT AND LUMP ABOVE HIS LEFT EYE. [REDACTED] HAD BLOOD DRIPPING FROM HIS FACE AND ONTO HIS SHIRT AND HANDS. [REDACTED] TOLD THE R/O THAT "HE GOT HIS ASS BEAT" AND SHRUGGED HIS SHOULDERS. [REDACTED] SILVER IN COLOR FORD SEDAN WAS PARKED IN THE REAR OF THE BUILDING WITH THE DRIVER DOOR OPEN. [REDACTED] APPEARED TO BE HEAVILY INTOXICATED AS HIS EYES WERE RED BLOOD SHOT AND GLASSY, HIS SPEECH WAS SLURRED AND WAS UNEASY ON HIS FEET. [REDACTED] DIDN'T WANT TO GIVE THE RESPONDING OFFICERS ANY INFORMATION AS TO WHAT HAD OCCURRED PRIOR TO R/O'S ARRIVAL. MEDICS WERE CALL TO LOOK AT HIS INJURIES.

R/O THEN TALKED TO THE CALLERS DOUGLAS E COLLINS [REDACTED] AND REBECCA IBRAHIM (F/W [REDACTED]), WHO STATED IN SUMMARY: THAT [REDACTED] SHOWED UP AT [REDACTED] 30 MINUTES PRIOR TO THE POLICE BEING CALLED. [REDACTED] WAS BANGING ON THE APARTMENT DOOR AND WANTED TO SPEAK WITH IBRAHIM. COLLINS AND IBRAHIM DID NOT ANSWER THE DOOR AT FIRST BUT [REDACTED] BEGAN TO TWIST THE DOOR HANDLE ATTEMPTING TO GET INSIDE THE RESIDENCE. COLLINS THEN WENT OUTSIDE TO SPEAK WITH [REDACTED] AND ATTEMPTED TO GIVE HIM A RIDE HOME BECAUSE HE APPEARED INTOXICATED. [REDACTED] THEN BEGAN TELLING COLLINS ABOUT HOW HE HAD SEX WITH IBRAHIM AND COLLINS AGAIN OFFERED TO DRIVE HIM HOME. [REDACTED] THEN PUNCHED COLLINS IN THE GENITALS AND COLLINS PUNCHED [REDACTED] IN THE FACE. [REDACTED] FELL BACK, BREAKING THE WOODEN ROLLING OUTSIDE OF IBRAHIM'S APARTMENT. COLLINS AGAIN OFFERED TO DRIVE [REDACTED] HOME BUT [REDACTED] CONTINUED TO ACT COMBATIVE TOWARD COLLINS.

[REDACTED] THEN LOCKED HIS CAR AND WAS TRANSPORTED TO ELMHURST MEMORIAL HOSPITAL BY BENSENVILLE FIRE DEPARTMENT.

COLLINS AND IBRAHIM DID NOT WANT TO SIGN COMPLAINTS AGAINST [REDACTED].
