Dear Mr. Walsh:

I am pleased to help you with your September 2, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on September 8, 2016. You requested copies of the items indicated below:

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

## UNIT 1 STATED THE FOLLOWING IN SUMMARY:

UNIT 1 STATED THAT SHE WAS TRAVELING APPROXIMATELY 40-45 MPH N/B ON YORK ROAD IN THE RIGHT LANE. UNIT 1 STATED THAT THE SHOCKS ON HER VEHICLE ARE IN POOR CONDITION AND CAUSE HER VEHICLE TO BOUNCE. UNIT 1 STATED THAT AS SHE WAS TRAVELING N/B ON YORK ROAD HER VEHICLE BOUNCED (BECAUSE OF THE SHOCKS) AND CAUSED HER TO SLIGHTLY TURN THE STEERING WHEEL TO THE RIGHT. UNIT 1 STATED THEN WHEN SHE TURNED RIGHT HER VEHICLE STRUCK UNIT 2 (WHO WAS PARKED ON THE SHOULDER OF N/B YORK ROAD) APPROXIMATELY 200 FT NORTH OF SUPREME DRIVE. UNIT 1 STATED THAT SHE DID NOT APPLY THE BRAKES. UNIT 1 STATED THAT SHE WAS NOT ON HER CELL PHONE.

## UNIT 2 STATED THE FOLLOWING IN SUMMARY:

UNIT 2 STATED THAT HE WAS PARKED ON THE SHOULDER OF N/B YORK ROAD (WAS DOING WORK FOR AT&T ON THE SHOULDER). UNIT 2 STATED THAT HIS EMERGENCY STROBE LIGHTS WERE ACTIVATED AND CONES WERE POSTED. UNIT 2 STATED THAT AS HE WAS PARKED UNIT 1, WHO WAS TRAVELING N/B ON YORK ROAD, REAR ENDED HIS VEHICLE APPROXIMATELY 200 FT NORTH OF SUPREME DRIVE. UNIT 2 STATED THAT AFTER HIS VEHICLE WAS REAR ENDED HE STRUCK (WAS PUSHED INTO) UNIT 3 (UNIT 3 WAS PARKED IN FRONT OF UNIT 2 ON THE SHOULDER).

## UNIT 3 STATED THE FOLLOWING IN SUMMARY:

UNIT 3 STATED THAT HE WAS PARKED ON THE SHOULDER OF N/B YORK ROAD (WAS DOING WORK FOR AT&T ON SHOULDER). UNIT 2 STATED THAT HIS EMERGENCY STROBE LIGHTS WERE ACTIVATED AND CONES WERE POSTED. UNIT 3 STATED THAT UNIT 2, WHO WAS PARKED BEHIND HIM, WAS STRUCK BY UNIT 1 APPROXIMATELY 200 FT NORTH OF SUPREME DRIVE. AFTER BEING STRUCK BY UNIT 1 UNIT 2 WAS SUBSEQUENTLY PUSHED INTO UNIT 3.

## WITNESS 1 STATED THE FOLLOWING IN SUMMARY:

WITNESS 1 STATED THAT HE WAS TRAVELING N/B ON YORK ROAD. WITNESS 1 STATED THAT UNIT 1, WHO WAS ALSO TRAVELING N/B ON YORK ROAD, PASSED HIS VEHICLE AT A HIGHER RATE OF SPEED (WITNESS 1 STATED THAT HE WAS TRAVELING APPROXIMATELY 45 MPH - POSTED SPEED LIMIT). WITNESS 1 STATED THAT HE THEN OBSERVED UNIT 1 DRIFT INTO THE SHOULDER OF N/B YORK ROAD. WITNESS 1 STATED THAT HE THEN OBSERVED UNIT 1 REAR END UNIT 2 (UNIT 2 WAS PARKED ON THE SHOULDER OF N/B YORK ROAD) APPROXIMATELY 200 FT NORTH OF SUPREME DRIVE.

DUCART RESPONDED TO THE SCENE TO RECONSTRUCT THE ACCIDENT.

THE DRIVER OF UNIT 1 WAS TRANSPORTED TO ALEXIAN BROTHERS HOSPITAL. THE UNRESPONSIVE PASSENGER OF UNIT 1 WAS TRANSPORTED TO LUTHERAN GENERAL HOSPITAL. THE DRIVER OF UNIT 2 WAS TRANSPORTED TO ALEXIAN BROTHERS HOSPITAL. THE DRIVER OF UNIT 3 REFUSED MEDICAL SERVICES.

Report Narrative: ON 05/14/2015 AT APPROXIMATELY 0857 HRS R/O OBSERVED WHAT APPEARED TO BE A TRAFFIC ACCIDENT AT YORK ROAD NORTH OF SUPREME DRIVE. UPON ARRIVAL R/O OBSERVED A CHRYSLER PACIFICA (ILLINOIS PLATE [REDACTED] / UNIT 1) WITH MAJOR FRONT END DAMAGE. THE CHRYSLER APPEARED TO REAR END A CHEVROLET AT&T TRUCK (ILLINOIS PLATE [REDACTED] / UNIT 2). WHEN R/O EXITED THE VEHICLE THE DRIVER OF THE CHRYSLER EXITED HER VEHICLE (DRIVER WAS LIMPING). THE DRIVER, LATER IDENTIFIED AS RANA, JAMIE A. F/W [REDACTED], WAS SCREAMING, "MY BOYFRIEND, IS MY BOYFRIEND OKAY". R/O ADVISED DISPATCH TO IMMEDIATELY SEND THE MEDICS. R/O THEN ATTEMPTED TO LOCATE THE PASSENGER. THE INSIDE OF THE CHRYSLER WAS COVERED WITH CLOTHES AND OTHER MISCELLANEOUS ITEMS. R/O LOCATED THE PASSENGER, WHO WAS COVERED IN CLOTHES, IN THE FRONT OF THE CHRYSLER (PASSENGER SEAT). BECAUSE OF THE EXTENSIVE DAMAGE THE PASSENGER WAS TRAPPED IN THE VEHICLE (R/O ADVISED DISPATCH). BYSTANDERS ON SCENE ASKED R/O WHAT THEY SHOULD DO AND R/O ADVISED THEM TO START CLEANING OUT / CLEARING THE VEHICLE.

R/O THEN THREW THE CLOTHING THAT WAS COVERING THE PASSENGER OUT OF THE WAY / OUT OF THE VEHICLE SO THAT R/O COULD CHECK THE VITAL SIGNS OF THE PASSENGER. R/O WAS ABLE TO OPEN THE REAR PASSENGER DOOR OF THE CHRYSLER AND ENTER THE VEHICLE. THE PASSENGER, LATER IDENTIFIED AS PEDERSON, ZACHARY A. M/W [REDACTED], WAS GURGLING WHEN ATTEMPTING TO BREATHE AND WAS UNRESPONSIVE (UNCONSCIOUS). PEDERSON WAS WEDGED / STUCK IN THE VEHICLE AND R/O WAS UNABLE TO GET A CLEAR LOOK TO SEE WHAT INJURIES PEDERSON HAD (HIS FACE APPEARED TO BE COVERED IN BLOOD). R/O COULD SMELL WHAT APPEARED TO BE SMOKE FROM INSIDE OF THE VEHICLE (WAS LATER DETERMINED IT WAS FROM THE AIR BAGS BEING DEPLOYED). R/O THEN EXITED THE VEHICLE AND, WITH HELP FROM BYSTANDERS, BEGAN TO TRY AND OPEN THE PASSENGER DOOR. A TOW TRUCK DRIVER, WHO WAS IN THE AREA, GAVE EQUIPMENT TO R/O / BYSTANDERS TO USE (TRY AND USE TO OPEN THE DOOR). WHILE R/O AND BYSTANDERS WERE WORKING ON OPENING THE DOOR RANA WAS PICKING UP HER CLOTHES FROM OUTSIDE OF THE VEHICLE.

THE BENSENVILLE FIRE DEPARTMENT ARRIVED ON SCENE AND BEGAN TO CUT TO THE PASSENGER DOOR.

WHILE THE BENSENVILLE FIRE DEPARTMENT WAS CUTTING THE PASSENGER DOOR R/O ASKED RANA IF SHE WAS OKAY. RANA STATED, "YES" AND KEPT ASKING ABOUT HER BOYFRIEND. WHILE SPEAKING TO RANA R/O OBSERVED RANA'S EYES WERE BLOOD SHOT RED AND SHE WAS LETHARGIC. R/O ASKED RANA IF SHE WAS UNDER THE INFLUENCE OF ANY DRUGS OR ALCOHOL AND SHE STATED, "NO". R/O HAD RANA TEMPORARILY SIT IN THE BACKSEAT OF SQUAD #311 UNTIL THE FIRE DEPARTMENT WAS ABLE TO LOOK AT HER. THE BENSENVILLE FIRE DEPARTMENT WAS ABLE TO EXTRACT PEDERSON FROM THE VEHICLE AND ENDED UP TRANSPORTING HIM TO LUTHERAN GENERAL HOSPITAL. RANA WAS TRANSPORTED TO ALEXIAN BROTHERS HOSPITAL. THE DRIVER OF THE AT&T TRUCK (ROCKAR, DOUGLAS W. M/W [REDACTED]) WAS TRANSPORTED TO ALEXIAN BROTHERS HOSPITAL.

R/O WENT TO ALEXIAN BROTHERS HOSPITAL FOR FURTHER INVESTIGATION AND TO COMPLETE THE CRASH REPORT.

WHILE IN THE EMERGENCY ROOM OF ALEXIAN BROTHERS HOSPITAL R/O SPOKE TO THE FATHER OF THE DRIVER OF UNIT 1 (RANA, JAMIE A. F/W [REDACTED]), IDENTIFIED AS TURNER, MICHAEL B. M/W [REDACTED], WHO STATED THE FOLLOWING IN SUMMARY:

R/O ADVISED TURNER ABOUT THE CAR ACCIDENT. TURNER STATED, "I SAW SOMETHING LIKE THIS HAPPENING AND AM NOT SURPRISED". TURNER STATED, "RANA IS CRAZY AND HAS CAUSED PROBLEMS THROUGHOUT HER LIFE." TURNER ADVISED R/O, RANA HAS A DRUG PROBLEM AND SHE WAS TRYING TO GET HER LIFE IN ORDER. TURNER STATED, RANA TEXTED HIM AT 0130 HRS (ON 05/14/2015) AND ASKED IF SHE COULD MOVE BACK IN TO HIS HOUSE.

WHILE IN THE EMERGENCY ROOM OF ALEXIAN BROTHERS HOSPITAL, R/O OBSERVED / HEARD RANA GET ANGRY AND UPSET AT THE EMERGENCY ROOM STAFF FOR CUTTING HER CLOTHES. THE EMERGENCY ROOM STAFF ADVISED RANA THAT SHE WAS IN AND OUT OF CONSCIOUSNESS AND THEY HAD TO FOLLOW PROCEDURE TO EVALUATE HER THUS CUTTING HER CLOTHING FROM HER PERSON. RANA STATED THAT HER CLOTHES WERE ONE HUNDRED DOLLARS AND CONTINUED TO BE IRATE. R/O ADVISED RANA TO CALM DOWN AND THAT THE EMERGENCY ROOM STAFF WERE THERE TO TAKE CARE OF HER.

RANA WAS ARRESTED AND TRANSPORTED TO THE BENSENVILLE POLICE DEPARTMENT. SEE DETECTIVE LARSON ARREST / SUPPLEMENT REPORT.

WHILE AT THE BENSENVILLE POLICE STATION, RANA ASKED R/O, WHY SHE WAS STILL IN CUSTODY. RANA STATED, "IT IS JUST A PIPE" AND DIDN'T BELIEVE IT SHOULD TAKE AS LONG AS IT WAS TAKING. R/O ADVISED RANA, IT WAS MORE THEN JUST A CANNABIS PIPE AND THAT THE ACCIDENT SHE WAS INVOLVED IN WAS STILL BEING INVESTIGATED. RANA STILL DID NOT UNDERSTAND AND STATED, "NO ONE WAS HURT."
