Dear Mr. Mickelini:

I am pleased to help you with your September 15, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on September 15, 2016. You requested copies of the items indicated below:

"16-8867."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16008867.1. (2 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5 ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative ON 9/3/16 AT APPROXIMATELY 1155 HOURS, THE R/O RESPONDED TO ██████████ TO THE MAIN ENTRANCE OF THE APARTMENT BUILDING IN REGARDS TO THE REPORT OF A BATTERY.

THE R/O SPOKE WITH PETER H. OKANE, M/W, ██████████, WHO GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: PETER ADVISED THAT HE APPROACHED ██████████, M/W, ██████████ WHO WAS SEATED IN HIS CAR ASKING WHAT ██████████ PROBLEMS WAS. OKANE ADVISED THAT HE HAD THOUGHT THAT HE AND ██████████ WERE FRIENDS HOWEVER HE RECENTLY WAS ADVISED OTHERWISE. PETER LIVES IN APARTMENT ██████████ WHICH NEIGHBORS ██████████ APARTMENT OF ██████████. PETER WANTED TO KNOW WHAT HAPPENED AND WHY THERE WAS A SUDDEN CHANGE OF FEELINGS. PETER STATED THAT HE DID PUSH ██████████ DOOR CLOSED BUT ADVISED THAT ██████████ WAS SEATED IN HIS CAR WITH BOTH LEGS INSIDE AND THAT HE DID NOT BELIEVE THAT HE STRUCK ██████████ WITH THE DOOR.

THE R/O SPOKE WITH ██████████ WHO STATED THAT HE WAS SEATED WITH HIS LEGS INSIDE THE VEHICLE AND FEET ON THE FLOORBOARD WHEN PETER SLAMMED THE CAR DOOR AND IT STRUCK HIM ON THE LEFT SIDE OF HIS LEFT KNEE. ██████████ ADVISED INITIALLY THAT HE WAS NOT INJURED AND DID NOT WISH TO SEE MEDICS. THE R/O OBSERVED ██████████ KNEE AND COULD SEE NO INDICATION OF ██████████ KNEE BEING STRUCK. ██████████ ADVISED THAT AT THIS TIME HE ONLY WISHED TO HAVE PETER WARNED TO HAVE HAVE NO FURTHER CONTACT WITH ██████████

BOTH ██████████ AND PETER WERE ADVISED TO AVOID FURTHER CONTACT WITH EACH OTHER AND TO TRY TO IGNORE EACH OTHER IS THEY SEE EACH OTHER IN PASSING AT THE APARTMENT COMPLEX.

ON 9/4/16 AT 1030 HOURS, THE R/O RESPONDED TO THE BENSENVILLE POLICE DEPARTMENT AND SPOKE WITH ██████████ ██████████ ADVISED THAT HE HAD GONE TO THE HOSPITAL FOLLOWING THE INCIDENT AND ADVISED THAT THE IMPACT TO HIS KNEE HAD AGGRAVATED A PRE-EXISTING CONDITION CAUSING PAIN AND BRUISING. PETER ADVISED THAT HIS HOSPITAL RECORDS WOULD SHOW THAT THE IMPACT FROM THE DOOR CAUSED BRUISING TO HIS LEG AND ██████████ LIFTED HIS PANT LEG AND POINTED TO A SPOT ON THE FRONT SHIN OF HIS LEFT LEG WHICH IS VERY DIFFERENT FROM THE LOCATION THAT ██████████ INITIALLY SHOWED THE R/O ON SCENE. ██████████ ADVISED THAT HE ALSO IS SUFFERING FROM PAIN IN HIS LEFT SHOULDER FROM BEING STRUCK BY THE DOOR. WHEN ASKED WHY HE DID NOT BRING THIS FACT UP WHILE THE R/O WAS ORIGINALLY ON SCENE, ██████████ ADVISED THAT DUE TO PAIN MEDICATIONS HE TAKES FOR CHRONIC PAIN, HE REGULARLY DOES NOT FEEL AN INJURY UNTIL LATER ON. ██████████ ADVISED THAT HE PLANS TO PURSUE THE ISSUE IN CIVIL COURT.

THE R/O ADVISED THAT AT THIS TIME THERE WOULD BE NO CRIMINAL CHARGES PURSUED DUE TO A LACK OF EVIDENCE TO SUPPORT THAT AN IMPACT OCCURRED BETWEEN THE DOOR AND ██████████.

NOTHING FURTHER AT THIS TIME.
