Dear Ms. Irizarry:

I am pleased to help you with your undated Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on September 27, 2016. You requested copies of the items indicated below:

"Case # BV16009634."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Arrest Report No. BV16009634.1. (4 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 09/23/2016 AT APPROXIMTAELY 1300 HOURS THE R/O RESPONDED TO [REDACTED] FOR A REPORT OF A FORCED ENTRY TO A HOME AND A BATTERY IN PROGRESS. UPON ARRIVAL THE R/O LOCATED A WHITE IN COLOR JEEP SUV IL REG [REDACTED] AND A FEMALE WHITE LATER IDENTIFIED AS MCCAMBRIDGE, BRITTNEY N. F/W [REDACTED]. MCCAMBRIDGE STATED THE FOLLOWING IN SUMMARY.**

SHE GAIN ACCESS THROUGH THE REAR DOOR OF [REDACTED] WHICH ALLOWED ACCESS TO THE BED ROOM OF THE PROPERTY OWNER. UPON GAINING ENTRY MCCAMBRIDGE STATED SHE WAS ATTACKED BY IRIZARRY, HECTOR A. M/W [REDACTED] MCCAMBRIDGE STATED IRIZARRY GRABBED HER BY THE WAIST WITH HIS ARMS TO REMOVE FROM HER THE RESIDENTS. AFTER BEING GRABBED BY IRIZARRY AND FORCEFULLY REMOVED FROM THE RESIDENCE MCCAMBRIDGE WAITED IN THE DRIVEWAY OF [REDACTED] MCCAMBRIDGE STATED SHE ENTERED THE HOME WITHOUT PERMISSION TO TAKE HER MONEY OF \$250.00 USC FROM IRIZARRY WHICH MCCAMBRIDGE WILLING GAVE TO IRIZARRY AT AN EARLIER DATE.

THE R/O SPOKE WITH IRIZARRY WHO STATED THE FOLLOWING IN SUMMARY. WHILE TRAVELING TO WISCONSIN TOGETHER WITH MCCAMBRIDGE EARLIER IN THE DAY. MCCAMBRIDGE BECAME UPSET BECAUSE OF IRIZARRY CHEATING ON MCCAMBRIDGE WITH ANOTHER FEMALE. IRIZARRY CHOSE TO LEAVE THE VEHICLE AND GO HOME TO AVOID THE HIGH STRESS SITUATION.

UPON RETURNING HOME IRIZARRY DECIDED RELAX TO LET THIS EVENT BLOW OVER. AT APPROXIMATELY 1250 HOURS THE MCCAMBRIDGE ARRIVED AT [REDACTED] AND ATTEMPTED TO GAIN ACCESS TO THE RESIDENCE THROUGH THE MAIN ENTRANCE ON THE EAST SIDE OF THE HOME. IRIZARRY SHOWED THE R/O A VIDEO OF MCCAMBRIDGE ATTEMPTING TO GAIN ACCESS WITH NEGATIVE RESULTS. MCCAMBRIDGE RANG THE DOOR BELL SEVERAL TIME OVER A 30 SECOND VIDEO.

AFTER FAILING TO GAIN ENTRY THROUGH THE MAIN DOOR, MCCAMBRIDGE TEXT IRIZARRY THE FOLLOWING IN SUMMARY. "GOOD THING YOUR MOM KEEPS HER BEDROOM DOOR OPEN, I AM GETTING IN THROUGH THERE." IRIZARRY STATED MCCAMBRIDGE ENTER WITHOUT PERMISSION THROUGH THE MASTER BEDROOM DOOR THE HOME WHICH WAS UNSECURED AT THE TIME. THE DOOR IS ONLY ACCESSIBLE THROUGH A RAISED DECK THROUGH A GATED BACK YARD. MCCAMBRIDGE DID NOT HAVE PERMISSION FROM ANY RESIDENT OF [REDACTED]

UPON MCCAMBRIDGE ENTERING THE HOME SHE WAS CONFRONTED BY [REDACTED] F/W [REDACTED] WHO WAS IN THE MASTER BEDROOM AT THE TIME. AT THIS TIME [REDACTED] WAS FREIGHTED AND YELLED FOR IRIZARRY. AT THIS TIME IRIZARRY ENTERED THE ROOM TOLD MCCAMBRIDGE TO LEAVE, MCCAMBRIDGE BEGAN YELLING AND DEMANDING MONEY. AT THIS TIME MCCAMBRIDGE ATTACKED IRIZARRY AND [REDACTED] CAUSING INJURIES TO THE CHEST AND BREAST OF BOTH SUBJECTS.

THE R/O PLACED MCCAMBRIDGE INTO CUSTODY FOR DOMESTIC BATTERY, BATTERY AND CRIMINAL TRESPASS TO A RESIDENTS.

MCCAMBRIDGE WAS TRANSPORTED TO THE BVPD WHERE SHE WAS PROCESSED, FINGER PRINTED AND PHOTOGRAPHED.

MCCAMBRIDGE WAS TRANSPORTED TO THE DUPAGE COUNTY JAIL BY PFC. CASILLAS 555 ON 09/24/2016 AT 1500 HOURS.

THE R/O TOOK SEVERAL PHOTOGRAPHS OF INJURIES FROM BATTERY.
