These are all of the documents that can be discovered responsive to your request.


Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **AT APPROXIMATELY 1800 HOURS, 9/3/16, RO WAS NOTIFIED OF A HIT AND RUN COLLISION AT 219 W MAIN ST. DISPATCH INFORMED RO THAT THE CALLER OBSERVED A BLACK VEHICLE COLLIDE WITH AN WHITE VEHICLE, THE DRIVER OF THE BLACK VEHICLE THEN LEFT HIS VEHICLE AND JUMPED INTO ANOTHER VEHICLE. RO ARRIVED IN THE AREA AND OBSERVED A WHITE IN COLOR OLDSMOBILE TORONADO (ILREG: [REDACTED]) STOPPED IN THE MIDDLE OF THE ROADWAY AT 211 ROOSEVELT WITH DAMAGE TO THE REAR LEFT OF THE VEHICLE. RO ALSO OBSERVED A BLACK IN COLOR ACURA 4 DOOR (NO REGISTRATION) THAT WAS PARKED ON THE NORTHERN SECTION OF ROOSEVELT BEHIND THE WHITE OLDSMOBILE WITH DAMAGE TO THE FRONT RIGHT OF THE VEHICLE. NO ONE WAS OCCUPYING EITHER VEHICLE.**

RO OBSERVED RED PLASTIC FRAGMENTS (BRAKE LIGHTS) ON THE GROUND IN FRONT OF THE BLACK IN COLOR ACURA. THERE WAS NO RED PLASTIC LOCATED ON THE FRONT OF THE ACURA. RO THEN DETERMINED THAT THE OLDSMOBILE WAS PARKED ON THE NORTHERN SECTION OF ROOSEVELT WHERE IT WAS STRUCK FROM BEHIND BY THE BLACK ACURA. TOMATOWS TOWING WAS CALLED TO REMOVE BOTH VEHICLES FROM THE SCENE.

RO CONDUCTED AN INVENTORY OF THE ACURA. RO WAS ABLE TO RUN THE VIN WHICH WAS REGISTERED TO [REDACTED] AT [REDACTED]. RO ALSO FOUND MAIL FOR [REDACTED] THAT WAS LOCATED THROUGHOUT THE VEHICLE.

RO WENT TO [REDACTED] TO MAKE CONTACT WITH [REDACTED] WITH OFC KOTLEWSKI #561. A BROTHER OF [REDACTED] INFORMED RO THAT [REDACTED] WASN'T HOME. RO ASKED [REDACTED] BROTHERS WHAT KIND OF CAR [REDACTED] DROVE AND HE STATED IT WAS THE BLACK ACURA. THE BROTHER THEN CHECKED FOR [REDACTED] CAR BUT SAID IT WASN'T IN THE PARKING LOT. RO ATTEMPTED A SECOND TIME TO LOCATE [REDACTED] BUT HE WASN'T HOME.

RO FOUND A T-MOBILE DOCUMENT FOR [REDACTED] IN THE VEHICLE WITH THE PHONE NUMBER [REDACTED]. RO ATTEMPTED MULTIPLE TIMES TO CALL [REDACTED] AND EVENTUALLY [REDACTED] WOULD IGNORE THE PHONE CALLS FROM RO AND WOULD NEVER PICK UP.

ON 9/30/2016, RO SPOKE WITH THE HONORABLE A. MCGIMPSEY AND OBTAINED AN ARREST WARRANT FOR [REDACTED].
