Re: October 19, 2016 FOIA Request

Dear Ms. Dove:

I am pleased to help you with your October 19, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on October 19, 2016. You requested copies of the items indicated below:

"Police records referencing or involving Jennifer Cifuentes and/or Caesar Cifuentes for the previous twelve months."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV15013408. (3 pgs.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **On 12/27/15 at approximately 1545 hours, R/O responded to Bensenville PD lobby for a suspicious incident report. Upon arrival, R/O met with Monica Castellanos fw [REDACTED] who stated the following in summary:**

Monica stated that she was visiting her sister, Jennifer J Cifuentes fw [REDACTED] and her family for the holidays. Monica stated that while visiting, her niece, NP, stated that she was having a hard time with her parents and that she fights with her step-dad Cesar Cifuentes mw [REDACTED] frequently. Monica stated that Cesar had just been released from jail and that she suspected something was going on as her niece was begging to move in with her. Monica stated that she was over at the house on 122715 when NP stated that Cesar hit her across the face and left a bruise on her face. When Monica confronted Jennifer about the allegation, Jennifer stated that she slapped NP across the face. R/O asked Monica if she thought that Jennifer/Cesar were just punishing NP or if she thought NP was being abused and she stated that she did not know. Monica stated that she has asked NP openly about what was going on and Cesar has told NP not to have any conversation with Monica regarding what was going on in the house. Monica stated that she took a photo of NP's face today after NP stated that Cesar had slapped her. R/O requested to see the photo of NP, but R/O could not see any bruising in the photo.

Monica stated that she flat out asked NP if she was being sexually abused by Cesar as she was begging to move out with her. NP stated that Cesar was not sexually abusing her. Monica relayed that Cesar has been NP's step father since she was very little.

Monica's mother arrived on scene and spoke spanish to her. Monica then stated that she did not want to file a report against Cesar, and just wanted the incident documented. Monica's mother stated that everything was fine and that she just spoke to both children that resided in the house and they were ok.

R/O offered to do a well being check on the house and Monica declined stating that Jennifer and Cesar would not answer the door/be cooperative.

Monica could not provide any other evidence indicating there was any urgency to remove/speak to NP or any other members of the family.

R/O contacted DCFS on 122715 and spoke to Yolanda Gomez #13138958 to relay the information.

Nothing further.
