These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when complied without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative **ON 10/16/16 AT APPROXIMATELY 1340 HOURS THE R/O OFFICER MELONE #521 RESPONDED TO 100 LELAND CT IN REGARDS TO THE REPORT OF A STOLEN SEMI TRAILER.**

THE R/O SPOKE WITH LUCASZ M. SPADLO, M/W, [REDACTED] AND SEBASTIAN MICHALSKI, M/W, [REDACTED] WHO ARE PARTNERS IN BUSINESS FOR O.A.S.S. ENTERPRISES. SPADLO AND MICHALSKI GAVE THE R/O THE FOLLOWING INFORMATION IN SUMMARY: THE STOLEN SEMI TRAILER WAS PARKED IN THE SEMI TRACTOR/TRAILER PARKING LOT ON THE SOUTHEAST CORNER OF 100 LELAND CT FACING NORTH TOWARD AT THE SOUTH END OF THE LOT. THE SEMI TRAILER WAS ATTACHED TO A SEMI TRACTOR THAT WAS LEFT WITH THE KEYS INSIDE AND DOORS UNLOCKED. THE SEMI TRACTOR IS EQUIPPED WITH GPS TRACKING. AT 0247 HOURS ON 10/16/16 THE TRACTOR WAS OBSERVED VIA GPS TO HAVE LEFT ITS PARKING SPACE DROVE WEST PAST THE SOUTH SIDE OF 100 LELAND CT, NORTH ON MEYER DRIVE, AND EAST ON LELAND CT WHERE IT TURNED AROUND AND WAS BACKED INTO A PARKING SPACE NEAR THE LOADING DOCK AREA ON THE NORTHEAST CORNER OF 100 LELAND COURT.

LOCATED IN FRONT OF THE SEMI TRACTOR WERE PARTS FROM THE FRONT PASSENGER CORNER WHICH APPEARED TO HAVE BEEN DAMAGED BY UNKNOWN MEANS DURING THE INCIDENT. ALSO LOCATED WAS DAMAGED PLASTIC FROM AN UNKNOWN OTHER BLACK VEHICLE. THE OTHER VEHICLE HAS A GLOSSY BLACK APPEARANCE AS OPPOSED TO THE SEMI TRACTORS FLAT BLACK LOOK.

THE SEMI TRACTOR THAT WAS DAMAGED IS IL REG [REDACTED], A 2004 VOLVO TRACTOR REGISTERED TO AND LEASED BY MICHALSKI.

THE STOLEN TRAILER IS A 2008 VAN GUARD 53' BOX TRAILER WITH TRANSLINK WRITTEN IN LARGE RED WRITING ON ALL FOUR SIDE. THE TRAILER HAS TRAILER NUMBER 538290 WRITTEN ON THE FRONT AND REAR. THE TRAILER HAS REAR DOUBLE SWINGING DOORS AND RECENTLY HAD BRAND NEW TIRES PUT ON. THE TRAILER IS OWNED BY SPADLO.

ACDC DISPATCH ENTERED THE SEMI TRAILER INTO LEADS AS STOLEN. LEADS #V16H2292.

THE TRAILER WAS LOADED WITH 1008 SAMSUNG TELEVISIONS (27" OR 24") WHICH WERE PACKAGED ON 42 PALLETS WEIGHING 12,000 LBS AND VALUED AT LESS THAN \$100,000 USC.

SPADLO AND MICHALSKI ARE WILLING TO SIGN COMPLAINTS IF AN OFFENDER IS LOCATED.

THE BUSINESS OWNER OF THE 100 LELAND #C, VALDEK JAKOBCZYK, M/W, [REDACTED] HAS VIDEO FOOTAGE SHOWING THE THEFT AND WILL PROVIDE A COPY TO SPADLO WHO WILL PROVIDE IT TO THE R/O.
