You have requested the following information:



Enclosed are all the Village records responsive to your FOIA Request. Please be advised that the Village has redacted private information (e.g. home addresses, telephone numbers, unique serial number identifiers) which information is exempt under section 7(1)(b) of FOIA. 5 ILCS 140/7(1)(b). The Village has also redacted dates of birth, which information is exempt under section 7(1)(c) of FOIA because disclosure would constitute a clear unwarranted invasion of personal privacy. 5 ILCS 140/7(1)(c). Under section 7(1)(a) of FOIA, the Village has also redacted Law Enforcement Agency Data System "LEADS" information which is confidential and disclosure of this information is prohibited under the Illinois Administrative Code, Title 20, Chapter 11, Part 1240.110. 5 ILCS 140/7(1)(a). The Village has also redacted the identities of individuals who provide information to law enforcement pursuant to section 7(1)(d)(iv) of FOIA. 5 ILCS 140/7(1)(d)(iv).

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: [publicaccess@atg.state.il.us](mailto:publicaccess@atg.state.il.us). You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative On Wednesday, at about 1800 hours, 02-17-16, R/I learned ██████████ was in custody for a Violation of Order of Protection, ██████████.

R/I met with ██████████ in booking while Officer Caliendo was processing his arrest. R/I introduced myself to ██████████. R/I explained to ██████████, this detective was following up with him about his stolen gun, this reported incident. R/I mentioned to ██████████ this detective had previously stopped Carlos (NFI) and found him in possession of ██████████ firearm which had not been reported stolen yet. R/I further mentioned Carlos is a known cocaine dealer and ██████████ is a known cocaine addict. ██████████ admitted he was addict (cocaine) and to knowing Carlos. R/I attempted to further identify Carlos but only could gather Carlos resided on the southeast corner of ██████████ and Marshall in Bensenville, IL. ██████████ finally admitted he had given the stolen firearm to Carlos for a past due drug debt. ██████████ confided he was worried about the firearm being traced back to him and tried to purchase the firearm back but learned from Carlos, he sold the firearm two weeks ago to an unknown individual. ██████████ became worried the individual who now possessed his firearm would end up getting him in trouble. ██████████ then admitted to filing a false police report to cover his tracks and not be blamed for someone using his firearm in future crime. ██████████ provided no further reference this incident.

R/I concluded the interview.

R/I drove by Carlos' residence, ██████████. R/I observed a white in color Lincoln parked in front of the residence with Illinois Registration ██████████. Checking the plate through LEADS ██████████

Report Narrative On 09/05/15 at approximately 1648 hrs, I, Officer Driscoll #518, was dispatched to [REDACTED] in reference to a theft report.

Upon arrival, I met with the victim, [REDACTED] m/w [REDACTED] and his landlord, [REDACTED] f/w [REDACTED]. With the assistance from [REDACTED] with some background about the situation, the conversation in summary is as follows; [REDACTED] received a letter from the Village of Bensenville stating that she needed to have her grass cut or she would be subject to fines. [REDACTED] reached out to a family friend, [REDACTED] m/w [REDACTED], who has been coming by asking if he could help in any way. Due to the hot weather [REDACTED] requested [REDACTED] to assist. [REDACTED] came by in August (she believed) to mow the lawn. Since he mowed the lawn he has contacted her several times for payment to which she paid him \$30 even though she thought he was doing it for free and just to help out. At the time [REDACTED] mowed the lawn, [REDACTED] and [REDACTED] exchanged phone numbers and that was when [REDACTED] met [REDACTED] for the first time. On 08/22/15 [REDACTED] received a phone call from [REDACTED] and spoke on the phone for 3 minutes 11 seconds. On 08/23/15 [REDACTED] had a missed call from [REDACTED] at 0808 hrs. On either 09/03/15 or 09/04/15 [REDACTED] showed up at [REDACTED] door, unannounced. [REDACTED] was outside on the porch and was talking with [REDACTED]. [REDACTED] invited Ingold into the house. [REDACTED] begins asking [REDACTED] about his guns. He came in while it was still daylight outside (sunset was at 1923 and 1921 hours respectively). [REDACTED] remained in the residence for some time and was requesting to purchase a few guns that were for sale by [REDACTED]. [REDACTED] had pulled out 6 firearms to show [REDACTED]. At an unknown time requested that [REDACTED] show him the pool table which is located in the back room. While in the basement [REDACTED] was on the phone with who he says was his uncle. [REDACTED] continued to talk to [REDACTED] about nonsense and [REDACTED] eventually walked away to find a male subject in the front room. [REDACTED] did not ask him to leave, however, both [REDACTED] and [REDACTED] and his friend left to get some food and brought back Subway for [REDACTED] and themselves. It was not until approximately 2300 hrs that the two subjects left and is unaware if the firearms were gone after they left or not until the next day when he noticed them missing from the front room. [REDACTED] informed [REDACTED] that the guns have been taken care of and that [REDACTED] names are off of the guns by [REDACTED] uncle after [REDACTED] advised [REDACTED] they would have to go to a gun shop to exchange the registrations of the guns.

I went to the residence of [REDACTED], [REDACTED], and spoke in [REDACTED] father who stated that he was working at a Sports Dome (Odium) in Wood Dale (but pointed eastbound) and he advised that Ingold still lives at the residence. When asked for a phone number for [REDACTED] he advised that [REDACTED] does not have a phone.

I spoke with [REDACTED] over the phone at approximately 1947 hrs who stated in summary that he received a call from his father advising that I was looking for him. He advised that he has not been in Bensenville for some time as he moved from his father's residence approximately 3 months ago and moved to Huntley with his girlfriend and her child and are currently living with her parents. [REDACTED] advised that he did mow the lawn for [REDACTED] in August and observed that he had a lot of property and asked [REDACTED] if he would want him to put up some cameras for him and that it would take him about 20 hours and hopefully give [REDACTED] a peace of mind. [REDACTED] mentioned that [REDACTED] forgets a lot of thing. [REDACTED] had asked [REDACTED] one time if he could come in the house to use the bathroom but then changed his mind and urinated outside. When asked what [REDACTED] and [REDACTED] spoke about for 6 hours [REDACTED] advised that [REDACTED] has a lot to talk about and spoke about his daughter, his times when he was a Soldier and even showed Ingold an old school horseshoe game and made reference to a magic trick that he was able to defeat in 5 seconds due to his constant video game playing. When I told [REDACTED] that he was being accused of taking several firearms from [REDACTED] he became defensive but ultimately advised that his friend may have taken them. When I was asking him questions about his friend he advised that his name is Mel, who picks him up / drops him off for / from work from time to time and drives a black pickup truck. [REDACTED] describes him as a tall, thin but thick bald male and advised that he was hispanic but did not advised if he had a brown pigment to his skin.

I had ACDC enter the weapons into LEADS [REDACTED] at 2145 hrs, see notes under property for LDS #.

I spoke with [REDACTED] m/b [REDACTED] a neighbor who resides across the street, stated in summary that on Thursday 09/03/15 or Friday 09/04/15 he observed one m/w heavy set with lots of tattoos talking with another male subject in a late 90's model gray Yukon SUV. At one point he was approached by two males and asked if he wanted some Subway. [REDACTED] believes

that to be around 1530-1630 hrs.

I entered the Subway located at 1143 S York Rd to speak with a manager referencing video and was told he would be in in the morning on 09/08/15.

I spoke with [REDACTED] on 09/06/15 to confirm information stated above and he confirms that him and [REDACTED] has had conversations about the video cameras, and the magic trick with the horseshoe which [REDACTED] was able to defeat quickly. [REDACTED] confirms that the horseshoe trick was done on the day the weapons came up missing.

Nothing further at this time.
