To Whom It May Concern:

I am pleased to help you with your October 28, 2016 Freedom of Information Act ("FOIA"). Your request was received by the Village of Bensenville on October 28, 2016. You requested copies of the items indicated below:

"16-9638."

After a search of Village files, the following documents are enclosed to fulfill your request:

- 1) Village of Bensenville Crime Report No. BV16009638.1. (3 pgs.)
- 2) Village of Bensenville Follow-Up Report No. BV16009638.2. (1 pg.)

These are all of the documents that can be discovered responsive to your request.

Section 7(1)(b) of FOIA provided that "private information" is exempt from disclosure. "Private information" is defined in FOIA as, "unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Section 7(1)(c) of FOIA provides that, "[p]ersonal information contained within public records, the disclosure of which would constitute a clearly unwarranted invasion per person privacy" is exempt from disclosure. Consequently, a birthdate and other personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy, including a victim's name and identifying information, and the race of an individual, have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and in consultation with an attorney for the Village, made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.

Report Narrative

At approximately 1425 hours on 09/23/16 R/O was dispatched to the lobby of the Bensenville Police Department for a stolen semi-trailer report.

R/O arrived on scene and met with complainant Piotr Bikowski m/w [REDACTED] who related the following information in summary:

Approximately 2 months ago he parked his semi-trailer Florida Registration [REDACTED] in the front dock area of Kitchen and Bath Master 426 County Line Rd, Bensenville IL 60106. Bikowski parked the semi-trailer there because his tractor trailer is not working. The semi-trailer is a white 2004 with a refrigeration unit. The semi-trailer has M&P 103 on it and does have GPS but the battery died so he is unable to track the location. The last tracked address is 426 County Line Rd.

Arkadiusz Bakiej m/w [REDACTED] is the owner of Kitchen and Bath Master and friend of Bikowski. Last weekend he noticed that the semi-trailer was missing and notified Bikowski.
